MATERIAL FACT

AUTOMOB PARTICIPAÇÕES S.A. (the “Company” or “**AUTOMOB**”), in compliance with the provisions of CVM Resolution No. 44/21 and Article 157, paragraph 4, of Law No. 6,404/76 (“Brazilian Corporation Law”), hereby informs that at a meeting held on June 2, 2025, the Board of Directors accepted the resignation of Mr. Antônio da Silva Barreto Júnior and approved the appointment of Mr. Sebastián Dario Los as Chief Executive Officer and Investor Relations Officer, effective as of July 1, 2025. Mr. Antônio da Silva Barreto Júnior will remain as an Executive Officer of the Company during the transition period, which ends on June 30, 2025.

Mr. Sebastián Dario Los assumes the position of Chief Executive Officer of **AUTOMOB** – the largest and most diversified dealership group in Brazil – with the commitment to execute **AUTOMOB**’s strategic plan, promoting integration and maximizing synergies.

He has over 25 years of experience in the retail sector, including the past 22 years with the Cencosud Group, where he served as CFO for 5 years and the last 6 years as CEO, contributing to both organic and inorganic growth as well as the implementation of its e-commerce platform. Cencosud Brasil has 375 supermarkets operating in 9 states and 22,000 employees. Mr. Los holds a degree in Accounting from the University of Buenos Aires and has completed several executive education programs at CEMA and IAE, two leading business schools in Argentina. Since May 2025, he has also served as an independent board member at GPA Group.

Mr. Antônio da Silva Barreto Júnior joined the **SIMPAR** Group in 2019 as Executive Vice President of Strategic Planning and M&A, a role he held until April 2024, when he was appointed an Officer at **AUTOMOB**. During this time, Mr. Antônio da Silva Barreto Júnior contributed to **SIMPAR**’s growth through several acquisitions — ten of which were in the dealership segment. At **AUTOMOB**, he led the corporate restructuring process with Vamos Concessionárias, which turned **AUTOMOB** into the leading group in the light and heavy vehicle dealership segment in Brazil. This process led to the listing of its shares in the Novo Mercado segment of B3.

AUTOMOB and the **SIMPAR** Group thank Mr. Antônio da Silva Barreto Júnior for his contributions over the past years and welcome Mr. Sebastián Dario Los to his new position as Chief Executive Officer and Investor Relations Officer at **AUTOMOB**.
