## MINUTES OF THE EXTRAORDINARY GENERAL MEETING HELD ON AUGUST 1, 2025

**Date, Time, and Location:** August 1, 2025, at 2 p.m., held exclusively online, pursuant to Article 124, paragraph 2-A of Law No. 6,404 dated December 15, 1976 ("Brazilian Corporate Law") and the Resolution of the Brazilian Securities and Exchange Commission (CVM) No. 81 of March 29, 2022 ("RCVM 81"). Pursuant to Article 5, paragraph 3 of RCVM 81, this Extraordinary General Meeting ("EGM" or "Meeting") of Localiza Rent a Car S.A. ("Company") was deemed to have been held at the Company's headquarters, located in the city of Belo Horizonte, State of Minas Gerais, at Avenida Bernardo de Vasconcelos, 377, Cachoeirinha, CEP 31150-000.

**Call Notice:** Published in the printed editions of the newspaper "Diário do Comércio de Minas Gerais" on July 1, 2025, July 10, 2025, and July 22, 2025, on pages 5, 10, and 4, respectively, and in its digital editions on July 1, 2025, July 10, 2025, and July 22, 2025, on page 1, in accordance with Article 124 of the Brazilian Corporate Law. The call notice was waived due to the presence of shareholders representing the entirety of the Company's share capital, as provided for in Article 124, paragraph 4, of the Brazilian Corporate Law.

Attendance: Shareholders holding common shares representing 78.52% of the total voting rights of the Company were present at the Meeting, as verified through the records of the electronic remote participation system and the distance voting ballots received, pursuant to Article 47, items II and III of RCVM 81, and based on the information contained in the consolidated analytical and summary voting reports, in accordance with Article 46-C of RCVM 81. The following participants were also present: Mr. Guilherme Campos and Daniel Zappala, representing PricewaterhouseCoopers Auditores Independentes Ltda.; Mr. Antônio de Pádua Soares Pelicarpo, Chair of the Fiscal Council; and Mrs. Estela Maris Vieira de Souza, Coordinator of the Audit, Risk Management and Compliance Committee.

**Bureau:** Mr. Rodrigo Tavares Gonçalves de Sousa presided over the meeting and invited Mrs. Suzana Fagundes Ribeiro de Oliveira to act as secretary.

Reading of Documents and Drafting of the Minutes: After confirming the quorum to open the Meeting and waiving the reading of the Call Notice published on July 1, 2025, as well as the consolidated summary of votes cast through remote voting, disclosed on July 30, 2025 — both of which were made available for review by the attending shareholders in accordance with the sole paragraphs of Articles 46-B and 46-C of RCVM 81 — the attendees unanimously approved the drafting of these minutes as a summary of the proceedings, pursuant to Article 130, paragraph 1 of the Brazilian Corporate Law. The Meeting also approved the publication of the minutes without the shareholders' signatures, in accordance with Article 130, paragraph 2 of the same law.

**Agenda:** (a) To deliberate and discuss the matters related to the merger of **Companhia de Locação das Américas**, a publicly held corporation registered as "Category B" with the Brazilian Securities and Exchange Commission (CVM), enrolled with Corporate Taxpayer's ID (CNPJ) No. 10.215.988/0001-60, with

its articles of incorporation filed with the Board of Trade of the State of Minas Gerais ("JUCEMG") under Company Registry (NIRE) No. 31300136973, headquartered in the city of Belo Horizonte, State of Minas Gerais, at Avenida Bernardo de Vasconcelos, 377, Cachoeirinha, CEP 31150-900 ("Locamerica" or "Merged Company"), by the Company, resulting in the dissolution of Locamerica ("Merger"); (b) To approve the "Instrument of Protocol and Justification of the Merger of Companhia de Locação das Américas by Localiza Rent a Car S.A.", executed on July 1, 2025, by the management of both the Company and Locamerica ("Merger Protocol and Justification"), which establishes, among others, the rationale, terms, and conditions under which the Merger will be carried out; (c) To ratify the appointment and hiring of PricewaterhouseCoopers Auditores Independentes Ltda., a limited liability company headquartered in the capital city of the State of São Paulo, at Av. Brigadeiro Faria Lima, 3732, 16º andar, partes 1 a 6, Edifício Adalmiro Dellape Baptista B32, Itaim Bibi, CEP 04538-132, enrolled with the CNPJ under No. 61.562.112/0001-20, originally registered with the Regional Accounting Council of the State of São Paulo under No. 2SP000160/O-5, with a branch in the city of Belo Horizonte, State of Minas Gerais, located at Rua dos Inconfidentes, 911, 17º andar, conjuntos 1701 e 1702 e 18º andar, conjunto 1801, bairro Savassi, CEP 30.140-128, enrolled with the CNPJ under No. 61.562.112/0005-54, represented by its partner Mr. Guilherme Campos e Silva, registered with the Regional Accounting Council of the State of São Paulo under No. 1SP218254/O-1 ("Appraisal Firm"), responsible for preparing the appraisal report based on the book value of the assets of Locamerica to be merged into the Company, pursuant to Articles 227 et seq. of the Brazilian Corporate Law, as amended and currently in force ("Appraisal Report"); (d) To approve the Appraisal Report; (e) To approve the Merger by the Company, in accordance with the Merger Protocol and Justification; and (f) To authorize the Company's executive officers to take all necessary actions to implement the decisions made at this Extraordinary General Meeting.

**Resolutions:** After discussing the items on the Agenda, the following resolutions were adopted:

- (1) To approve by majority vote, with 830,484,336 votes in favor, 428,854 votes against, and 7,705,032 abstentions recorded: (a) the acts related to the Merger, namely: (b) to approve the Merger Protocol and Justification, which is attached to these minutes as Appendix I; (c) to ratify the appointment and hiring of the Appraisal Firm as responsible for preparing the accounting Appraisal Report of Locamerica's net assets for the purposes of the Merger, determined as of March 31, 2025 ("Base Date"); (d) to approve the Appraisal Report, attached as Appendix A to the Merger Protocol and Justification (Appendix I of these minutes), prepared by the Appraisal Firm as of the Base Date, which established the book value of Locamerica's net assets at BRL 15,093,333,429.14 (fifteen billion, ninety-three million, three hundred thirty-three thousand, four hundred twenty-nine reais and fourteen cents), to be merged into the Company as described in the Merger Protocol and Justification; (e) to approve the Merger, resulting in the dissolution of Locamerica, effective as of this date, under the terms and conditions described in the Merger Protocol and Justification, with all assets, rights, and obligations of Locamerica transferred to the Company at the value determined in the Appraisal Report; and, finally, (f) to authorize the Company's executive officers to take all necessary actions to implement the decisions made at this Extraordinary General Meeting.
  - 1.1. After the Merger becomes effective, in accordance with Article 224, item III, of the Brazilian Corporate Law, any changes in assets and results that occur in the Merged Company between the base date and the completion of the Merger will be absorbed and recorded by the Company. Without prejudice thereto, until the effective date of the Merger, changes in equity and results occurring in the Merged Company shall continue to be duly recorded by it.

- **1.2.** It is hereby recorded that, since the Company owned 100% of Locamerica's share capital, the Merger will not result in an increase in the Company's share capital, nor will it alter the number of shares issued by the Company, and therefore no exchange ratio shall apply.
- 1.3. The preparation of the appraisal report referred to in Article 264 of the Brazilian Corporate Law is not required, given that the Company directly holds 100% (one hundred percent) of Locamerica's share capital, and in accordance with the decision of the Collegiate Board of the Brazilian Securities and Exchange Commission dated February 15, 2018, under SEI Case File No. 19957.011351/2017-21.
- **1.4.** It is further noted that the Merger will not grant any right of withdrawal to the Company's shareholders, since the applicable law limits this right to the shareholders of the merged company, and the Company directly owns 100% (one hundred percent) of Locamerica's share capital. Therefore there are no dissenting shareholders to be considered.
- **1.5.** Once the legal procedures for the Merger are completed, Locamerica will be fully and legally dissolved for all purposes, without the need for liquidation or dissolution proceedings, and all of Locamerica's assets will be transferred universally to the Company, in accordance with Article 227 of the Brazilian Corporate Law and the Merger Protocol and Justification.
- 1.6. The Company shall succeed Locamerica universally and without interruption, assuming all assets, rights, claims, privileges, powers, immunities, actions, defenses, duties, obligations, liabilities, encumbrances, and responsibilities held by Locamerica, which is being merged into the Company. Until all registrations have been formalized and all authorizations required under applicable laws and regulations for the universal succession of Locamerica by the Company have been obtained, the Company shall temporarily hold all assets, rights, and obligations owned by Locamerica on its behalf.
- 1.7. Pursuant to Article 234 of the Brazilian Corporate Law, the certificate of the Merger issued by the Public Registry of Commercial Companies shall serve as sufficient documentation for the registration and annotation, in the relevant public and private registries, of the Company's universal succession of all assets, rights, claims, privileges, powers, immunities, actions, defenses, duties, obligations, liabilities, encumbrances, and responsibilities pertaining to or related to Locamerica.

Closing. There being no further matters to address, the Chair expressed gratitude to all attendees and declared the meeting adjourned, temporarily suspending proceedings to allow for the drafting of the minutes, which, upon being read, discussed, and found to be in accordance, were duly approved and signed by the Board. The final summary voting reports and the List of Shareholders present are attached hereto as **Appendices II and III**, respectively. The recording of the Meeting and the votes cast through remote voting ballots have been filed at the Company. Pursuant to Article 47, paragraphs 1 and 2 of RCVM Instruction 81, the shareholders whose remote voting ballots were deemed valid by the Company, as well as those who have registered their attendance through the electronic remote participation system, were considered present at the meeting and signatories to the minutes.
