MINUTES OF THE ANNUAL AND EXTRAORDINARY GENERAL MEETINGS
HELD ON APRIL 25th, 2023

Date, Time and Place: On April 25th, 2023, at 02:00 p.m., solely by digital means, in accordance with the provisions of article 124, §2-A of Law No. 6,404 of December 15th, 1976 (the “Corporations Act”) and the Securities and Exchange Commission Resolution No. 81 of March 29th, 2022 (“RCVM 81”). In accordance with article 5º, §3º of RCVM 81, this Annual and Extraordinary General Meetings (the “General Meetings” or “AEGM”) of Localiza Rent a Car S.A. (the “Company” or “Localiza”) were deemed held at the headquarters of the Company, located at Avenida Bernardo de Vasconcelos, nº 377, CEP: 31.150-000, in the City of Belo Horizonte, State of Minas Gerais.

Call Notice: Call Notice published in the “*Diário do Comércio de Minas Gerais*” newspaper, in its issues dated March 25th, April 06th and April 18th, 2023, on pages 3, 9 and 10, respectively, and in its digital issues, on March 25th, April 06th and April 18th, 2023, always on page 1, in all these publications, as per article 124 of the Corporations Act.

Legal Publications: The Management Report and the Financial Statements of the Company, for the fiscal year ended on December 31st, 2022, together with the Independent Auditors’ Report prepared by PricewaterhouseCoopers Auditores Independentes Ltda., of the Directors’ Declaration on the Financial Statements, the Extract from the Minutes of the Audit, Risks and Compliance Committee and the Opinion of the Fiscal Council, were released to the market on March 14th, 2023 and made available on the websites of the CVM (www.gov.br/cvm), of B3 S.A. - Bolsa, Balcão Brasil (“B3”) (www.b3.com.br) and Investor Relations of the Company (www.localiza.com/ri), as well as were published on March 21st, 2022, on pages 09 to 19, in the *Diário do Comércio de Minas Gerais* newspaper, and in its digital edition, on the same date.

Quorum: Shareholders of registered common shares without par value representing (i) 77,78% of the total votes granted by the Company's voting shares at the Annual Shareholder Meeting; and (ii) 78,24% of the total votes granted by the Company's voting shares at the Extraordinary Shareholder Meeting, as per the records in the of the remote attendance electronic system, in accordance with article 47 of RCVM 81, and the information contained in the analytical maps prepared by the bookkeeping agent and by the Company itself under article 48, items I and II of RCVM 81.

Legal Attendance: Mr. Eugênio Mattar, Chairman of the Board of Directors, Mr. Rodrigo Tavares Gonçalves de Sousa, Chief Financial and Investor Relations Officer, Guilherme Campos and Daniel Gzapalla, PricewaterhouseCoopers Auditores Independentes Ltda. representatives, and Antônio de Pádua Soares Pelicarp, Chairman of the Company’s Fiscal Council.

Presiding Board: Mr. Eugênio Mattar took the role of chairman of the proceedings and invited Mrs. Suzana Fagundes to act as secretary.

Reading of the Documents and Drawing up of the Minutes: After verifying the quorum for the installation of the Meeting and waiving the reading of the Call Notice and the Synthetic Consolidated Voting Map of the votes cast by remote voting mechanism, disclosed to the market on April 24th, 2023, which were made available for consultation by the shareholders present, pursuant to article 48, paragraph 4, of RCVM 81, the drawing up of these minutes in the form of a summary of the facts occurred was unanimously approved by those present, as provided for in article 130, paragraph 1, of the Corporate Law and its publication with the omission of the shareholders' signatures, as per article 130, paragraph 2, of the Corporate Law.

I - AT THE ANNUAL GENERAL MEETING

Agenda: (1) To acknowledge the Management's accounts and approve the Company's Financial Statements for the fiscal year ended December 31st, 2022, together with the Independent Auditors' Report; **(2)** Approve Management's proposal for the allocation of net income for the fiscal year ended December 31st, 2022 and the distribution of dividends; **(3)** To install the Fiscal Council and set its compensation; **(4)** To deliberate on the number of members that will make up the Board of Directors; **(5)** to deliberate on the characterization of the candidates nominated to the Board of Directors as independent directors; **(6)** to elect the members of the Board of Directors; and **(7)** To establish the Management's global annual compensation.

Resolutions:

- 1) Approved, by majority of votes casted, having registered 499,998,582 votes in favor, 1,232,020 votes against and 263,311,291 abstentions, including the abstentions of those legally prevented from voting, the Management accounts, the Company's Financial Statements for the fiscal year ended December 31st, 2022, together with the Independent Auditors' Report;
- 2) Approved, by unanimously of the votes casted, having registered 757,348,664 votes in favor, 0 votes against and 7,193,229 abstentions, the Management's proposal for the allocation of the net income of the fiscal year ended December 31st, 2022, of R\$1,844,307,876.39 (one billion, eight hundred and forty-four million, three hundred and seven thousand, eight hundred and seventy-six reais and thirty-nine cents), being: (i) R\$92,215,393.82 (ninety-two million, two hundred and fifteen thousand, three hundred and ninety-three reais and eighty-two cents) for the Legal Reserve; (ii) R\$946,476.210.36 (nine hundred and forty-six million, four hundred and seventy-six thousand, two hundred and ten Reais and thirty-six cents) for remuneration to shareholders, distributed in advance as interest on equity attributed to the mandatory dividend, and (iii) R\$805,616,272.21 (eight hundred and five million, six hundred and sixteen thousand, two hundred and seventy-two Reais and twenty-one cents) for the statutory reserve called Investment Reserve, according to article 26, §2, (f) of the Company's Bylaws. There will be no distribution of complementary dividends.

MG-3.499.446, issued by SSP/MG, with business address at Rua Rubim, nº 81, Apto. 800, Bairro Sion, CEP 30.310-630, Belo Horizonte, MG, registered 732,214,944 votes for, 0 votes against and 32,326,949 abstentions;

- (ii) **Antônio de Pádua Soares Pelicarp**, Brazilian, married, accountant, enrolled in the CPF/ME under no. 293.142.676-87, bearer of identity card no. MG 718860, issued by SSP/MG, with address at Rua Dr. Plínio de Moraes, nº 920, Apto. 201, Cidade Nova, Zip Code: 31. 170-170, Belo Horizonte, MG, to the position of effective member of the Company's Fiscal Council, and as alternate member **Guilherme Bottrel Pereira Tostes**, Brazilian, married, accountant, bearer of identity card CRC 082.058/O-0 and inscribed in the CPF/ME under no. 016. 446.957-58, residing and domiciled at Rua Vice Governador Rubens Berardo, 125 apto 702 Bl 2- Gávea, Rio de Janeiro-RJ, 743,856,787 votes for, 0 votes against and 20,685,106 abstentions; and
- (iii) **Marcia Fragoso Soares**, Brazilian, married, engineer, registered with the CPF under nº 863.363.477-53, bearer of identity card nº 20023365-5 CRA/RJ, with address at Rua Cláudio Manoel, 1029-1101, Employees, Cidade de Belo Horizonte, State of Minas Gerais, to the position of effective member of the Company's Fiscal Council, and as alternate member, **Roberto Frota Decourt**, Brazilian, married, administrator, registered with the CPF under nº 212.672.418-29, bearer of identity card nº 237630163, SSP/SP, with address at Rua Matias José Bins, 1532, Casa 2, Três Figueiras, City of Porto Alegre, State of Rio Grande do Sul, having registered 384,475,889 votes in favour, 236,592,882 votes against and 143,473,122 abstentions.

It was noted the presentation, by those elected to the Fiscal Council, of the documents evidencing the compliance with the eligibility preconditions set forth in art. 162 of the Corporate Law.

The Fiscal Council members elected herein will take office in their respective positions within thirty (30) days as of the present date, by signing the respective instrument of investiture to be drawn up in the Company's proper book, declaring their respective dismissal.

- 4) Approved, by a majority of votes, with 743,710,712 votes for, 176,897 votes against and 20,654,284 abstentions, the compensation of the members of the Fiscal Council, established at 10% (ten percent) of the compensation assigned, on average, to each director, not including benefits, representation fees and profit sharing, in addition to the mandatory reimbursement of travel and accommodation expenses necessary for the performance of the function, pursuant to paragraph 3 of article 162 of the Corporate Law. The alternate members of the Fiscal Council will only be remunerated when they act in substitution of the effective members.
- 5) Approved, by a majority of votes, with 755,814,203 votes in favor, 396,861 votes against, and 8,330,829 abstentions, that the Company's Board of Directors will consist of eight (8) members;
- 6) Approved, by a majority of votes, with 601,037,256 votes in favor, 155,718,981 votes against, and 7,785,656 abstentions, the characterization of **Adriana Waltrick dos Santos; Artur Noemio Crynbaum; Maria Letícia de Freitas Costa; Paulo Antunes Veras** and **Pedro de Godoy Bueno**, as candidates for independent members of the Company's Board of Directors, pursuant to article 17 of B3's Novo Mercado Regulations and Annex K of CVM Resolution No. 80, dated March 29th, 2022;
- 7) Approved, by vote, the election of the following members to compose the Board of Directors, with a unified term of office of two (2) years, which will end on the date of the ordinary general meeting in which the Company's shareholders resolve on the financial statements for the fiscal year ending December 31st, 2024:
 - (i) **Eugênio Pacelli Mattar**, Brazilian, married, businessman, enrolled in the CPF under no. 130.057.586-72, bearer of Identity Card no. MG-4.491, issued by SSP/MG, with business address at Av. Bernardo de Vasconcelos, 377, Zip Code: 31.150000, City of Belo Horizonte, State of Minas Gerais, with 683,760,624 votes in favor, 72,491,841 votes against and 8,289,428 abstentions;
 - (ii) **Luis Fernando Memoria Porto**, , Brazilian, married, businessman, bearer of the Identity Card RG nº M.5.437.158, issued by SSP/MG and enrolled in the CPF under nº 915.133.326-00, with business address at Av. Bernardo de Vasconcelos, nº 377, Zip Code: 31150-000, City of Belo

Horizonte, State of Minas Gerais, with 745,266,030 votes in favor, 11,440,038 votes against and 7,835,825 abstentions;

- (iii) **Adriana Waltrick dos Santos**, Brazilian, single, business administrator, bearer of the Identity Card RG nº 7003092058, enrolled in the CPF under nº 472.363.610-20, with commercial address at Av. Bernardo de Vasconcelos, nº 377, Zip Code: 31150-000, City of Belo Horizonte, State of Minas Gerais, with 754,358,620 votes in favor, 2,347,448 votes against and 7,835,825 abstentions;
- (iv) **Artur Noemio Crynbaum**, Brazilian, married, economist and administrator, enrolled in the CPF under No. 722.349.549-91, holder of Identity Card No. 3.422581-8, issued by the SSP/PR, with business address at Av. Bernardo de Vasconcelos, 377, Zip Code: 31150-000, Belo Horizonte City, State of Minas Gerais, with 753,409,200 votes in favor, 3,296,868 votes against and 7,835,825 abstentions;
- (v) **Maria Letícia de Freitas Costa**, Brazilian, single, engineer, enrolled in the CPF under no. 050.932.788-58, bearer of ID no. 6.057.278-4, issued by SSP/SP, with business address at Av. Bernardo de Vasconcelos, 377, Zip Code: 31.150-000, Belo Horizonte City, State of Minas Gerais, with 661,895,430 votes in favor, 94,810,638 votes against and 7,835,825 abstentions;
- (vi) **Paulo Antunes Veras**, Brazilian, single, engineer, enrolled in CPF under no. 179.984.168-58, bearer of ID no. 12856600-0, issued by SSP/SP, with business address at Av. Bernardo de Vasconcelos, nº 377, Zip Code: 31150-000, Belo Horizonte City, Minas Gerais State, with 743.446.944 votes in favor, 13.259.124 votes against and 7.835.825 abstentions;
- (vii) **Pedro de Godoy Bueno**, Brazilian, single, economist, enrolled in the CPF under no. 126.861.457-22, bearer of ID no. 22.352.879-5, issued by SSP/RJ, with business address at Av. Bernardo de Vasconcelos, 377, Zip Code: 31150-000, Belo Horizonte City, Minas Gerais State, with 746,444,227 votes in favor, 10,261,841 votes against and 7,835,825 abstentions;
- (viii) **Sergio Augusto Guerra**, Brazilian, married, businessman, bearer of the Identity Card RG nº M.6.057.461, issued by SSP/MG, enrolled in the CPF under nº 865.258.326-91, with business address at Av. Bernardo de Vasconcelos, nº 377, Zip Code: 31150-000, Belo Horizonte City, Minas Gerais State, with 743,869,366 votes in favor, 11,616,935 votes against and 9,055,592 abstentions;

The elected members of the Board of Directors will be vested in office upon signing (a) a statement that they possess the necessary qualifications and meet the requirements set forth in Article 147 and paragraphs of the Corporate Law for the exercise of their office and that they have no legal impediment that prevents their election, pursuant to CVM Resolution 80/22; and (b) an instrument of investiture, drawn up in the Board of Directors' minutes book.

- 8) Approved, by a majority of votes, with 693,473,284 votes in favor, 6,512,687 votes against, and 64,555,922 abstentions, the value of the Management's global compensation, in the total amount of R\$110,000,000.00 (one hundred and ten million reais), net of social charges, for the fiscal year 2023, being authorized the payment of the compensation to the Management for the period from January to April 2024, on the same basis that it is estimated to be made in the fiscal year 2023, limited to a maximum of 1/3 of this global compensation, for the referred period.

II - AT THE EXTRAORDINARY GENERAL MEETING:

Agenda: (1) To approve the amendments to the Company's Bylaws; and **(2)** Approve the proposed consolidation of the Company's Bylaws.

Resolutions:

- 1) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the amendment to amend article 3 of the Company's Bylaws to include as complementary and related activities to the Company's main corporate purpose the agency of spaces for publicity, except in communication vehicles, in the following terms:

"Article 3. The Company's purpose is

(a) the rental of cars;

(b) the temporary rental of chauffeured labor to complement the rental of cars;

(c) intermediation and agency activities of services and businesses in general, except real estate;

(d) the rental of machinery and equipment;

(e) management of third-party assets;

(f) management of equity interests, in Brazil and abroad; and

(g) the management of advertising space, except in communication vehicles."

- 2) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the amendment to article 5 of the Company's Bylaws to reflect the Company's capital increase approved at the Extraordinary General Meeting held on April 26th, 2022 and at the meetings of the Board of Directors held on July 1st, 2022, November 30th, 2022, and 16th December, 2022, which will be 12,331,397,546.75 (twelve billion, three hundred and thirty one million, three hundred and ninety seven thousand, five hundred and forty six reais and seventy five cents), divided into 988,435,930 (nine hundred and eighty-eight million, four hundred and thirty-five thousand, nine hundred and thirty) shares in the following terms:

"Article 5. The subscribed and paid-in capital stock is R\$ 12,331,397,546.75 (twelve billion, three hundred and thirty-one million, three hundred and ninety-seven thousand, five hundred and forty-six reais and seventy-five cents), divided into 988,435,930 (nine hundred and eighty-eight million, four hundred and thirty-five thousand, nine hundred and thirty) common shares, all nominative and without par value."

- 3) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the amendment of Article 6 of the Company's Bylaws to reflect the new limit of the Company's capital increase after the capital increase approved at the Extraordinary General Meeting of April 26th, 2022 and meetings of the Company's Board of Directors on July 1st, 2022, November 30th, 2022 and 16th December, 2022 in the following terms:

"Article 6. The Company is authorized to increase its capital stock up to the limit of 2,000,000,000 (two billion) registered common shares, regardless of statutory reform."

- 4) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the amendment of item (m) of Article 12 of the Company's Bylaws to simplify the process of resolutions on approvals and adjustments in the Company's indirect subsidiaries, in the following terms:

"(m) Approve the incorporation of a subsidiary, as well as any amendments to its bylaws, the subscription and payment of capital increases, except when the subscription and payment of capital increases are of direct or indirect wholly-owned subsidiaries of the Company incorporated in Brazil;"

- 5) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the amendment to item (h) of article 17 of the Company's Bylaws to reflect the nomenclature used by the Company regarding the compliance program;

"(h) Execute and evaluate annually the risk management policy, internal controls, as well as the integrity / compliance program (Compliance), and, when necessary, propose to the Board of Directors possible revisions of this policy."

- 6) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 19,821,195 abstentions, the amendment to paragraph 1 and paragraph 2 of article 19 of the Company's Bylaws to simplify the process for issuing simple powers of attorney with no financial content, in the following terms:

"§1º. Ad-judicia powers of attorney may be valid for an undetermined term.

§2º. The powers of attorney with financial content, or related to the transfer, release, withdrawal and regularization of vehicles, or granting any powers to external representatives (who are not Company employees), shall have a validity period limited to a maximum of thirteen (13) months. The other powers of attorney, may be valid for up to 24 (twenty-four) months."

- 7) Approved, by a majority of votes, with 746,408,045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the amendment to article 20 of the Company's Bylaws to reflect the non-existence of a controlling shareholder of the Company, in the following terms:

"Article 20. The acts of any Officer, attorney-in-fact, or employee involving the Company in obligations relating to business or transactions unrelated to the corporate purpose, such as sureties, sureties, endorsements or any guarantees in favor of third parties, except when expressly authorized by the Board in a meeting, or by these Bylaws, are expressly prohibited, being null and void with respect to the Company. The granting of loans to the managers and any controlling shareholders (if any) of the Company is prohibited, with the exception of loans granted pursuant to the Company's stock option plans."

- 8) Approved, by a majority of votes, with 746,408.045 votes in favor, 19,821,195 votes against, and 2,825,482 abstentions, the proposed consolidation of the Company's Bylaws, to reflect the changes provided for in the items above. The text of the Company's consolidated Bylaws, now approved according to the management's proposal, already contemplating the items indicated above, was authenticated by the Presiding Board, numbered and filed at the Company's headquarters, and will be filed with the Commercial and Registry Board of the State of Minas Gerais in a separate section of these minutes, as well as available on the websites of CVM, B3 and the Company.

The Presiding Board acknowledges receipt of a written statement from the shareholder CAIXA DE PREVIDÊNCIA DOS FUNCIONÁRIOS DO BANCO DO BRASIL – PREVI, which is attached to these minutes as Exhibit III. The request will be considered in due course by the Board of Directors.

Closing: There being nothing further to discuss, the Chairman thanked the presence of all attendants and ordered the closing of the Shareholder Meetings after suspending the same so that these minutes could be drawn up, which, after being read, discussed and found to be in good order, were approved and signed by the Presiding Board. In accordance with article 47, §§1 and 2 of RCM 81, shareholders whose remote voting ballots were considered valid by the Company and shareholders who registered their presence in the electronic remote participation system were considered present at the meeting and signatories of the minutes. The final summary voting maps and the List of Present Shareholders are shown in **Annexes I and II** to these minutes, respectively. The recording of the Meetings and the votes expressed through remote voting ballots were filed with the Company.
