MINUTES OF THE ANNUAL AND EXTRAORDINARY GENERAL MEETINGS HELD ON APRIL 26, 2022

Date, Time and Place: On April 26, 2022, at 11:00 a.m., solely by digital means, in accordance with the provisions of article 124, §2-A of Law No. 6,404 of December 15, 1976 (the "Corporations Act") and of article 4, §2, item I of Brazilian Securities and Exchange Commission ("CVM") Instruction No. 481 of December 17, 2009 ("ICVM 481"). In accordance with article 4, §3 of ICVM 481, this Annual and Extraordinary General Meetings (the "General Meetings" or "AEGM") of Localiza Rent a Car S.A. (the "Company" or "Localiza") was deemed held at the headquarters of the Company, located at Avenida Bernardo de Vasconcelos, nº 377, CEP: 31.150-000, in the City of Belo Horizonte, State of Minas Gerais.

Call Notice: Call Notice published in the "Diário do Comércio de Minas Gerais" newspaper, in its issues dated March 28, April 12 and April 19, 2022, on pages 24, 8 and 10, respectively, and in its digital issues, on March 26, April 12 and 19, 2022, pages 19, 3 and 5, respectively, and its digital issues, on the same dates, as per article 124 of the Corporations Act.

Legal Publications: The Management Report and the Financial Statements of the Company, for the fiscal year ended on December 31, 2021, together with the Independent Auditors' Report prepared by Deloitte Touche Tohmatsu Auditores Independentes, of the Directors' Declaration on the Financial Statements, the Extract from the Minutes of the Audit, Risks and Compliance Committee and the Opinion of the Fiscal Council, were released to the market on February 22, 2022 and made available on the websites of the CVM (www.gov.br/cvm), of B3 S.A. - Bolsa, Balcão Brasil ("B3") (www.b3.com.br) and Investor Relations of the Company (www.localiza.com/ri), as well as were published on March 4, 2022, on pages 15 to 32, in the Diário do Comércio de Minas Gerais newspaper, and in its digital edition, on the same date.

Quorum: Shareholders of registered common shares without par value representing (i) 71.92% of the total votes granted by the Company's voting shares at the Annual Shareholder Meeting; and (ii) 73.27% of the total votes granted by the Company's voting shares at the Extraordinary Shareholder Meeting, as per the records in the of the remote attendance electronic system, in accordance with article 21-V, item III of ICVM 481, and the information contained in the analytical maps prepared by the bookkeeping agent and by the Company itself under article 21-W, items I and II of ICVM 481.

Legal Attendance: Mr. Rodrigo Tavares Gonçalves de Sousa, as Chief Financial and Investor Relations Officer and Daniel de Carvalho Primo, representative of Deloitte Touche Tohmatsu Auditores Independentes and Antônio de Pádua Soares Pelicarpo, Chairman of the Company's Fiscal Council.

Presiding Board: Mr. Eugênio Mattar took the role of chairman of the proceedings and invited Mrs. Suzana Fagundes to act as secretary.

Reading documents: The reading of the documents related to the Agenda of these General Meetings was waived, as well as the consolidated synthetic map of remotely cast votes, disclosed to the market on March 25, 2022, as provided for in article 21-W, §4, of ICVM 481, since the aforementioned documents are fully known by all present Shareholders.

Summarized minutes: these minutes were authorized to be drawn up in summary form and to be published with omission of the signatures of shareholders, as permitted by article 130, §§1 and 2 of the Corporations Act.

Agenda: (1) To acknowledge the Management's accounts and approve the Company's Financial Statements for the fiscal year ended December 31, 2021, together with the Independent Auditors' Report; **(2)** Approve

Management's proposal for the allocation of net income for the fiscal year ended December 31, 2021 and the distribution of dividends; (3) To establish the Management's global annual compensation for the fiscal year of 2022; and (4) To install the Fiscal Council and establish its compensation.

The Company's net income for the year ended December 31, 2021 was BRL 2,043,676,253.93, having been approved, in accordance with the Management's proposal, the following allocation: (i) BRL 102,183,812.70 to constitute the Legal Reserve; (ii) BRL 521,593,788.00 to be allocated to shareholders in the form of dividends and interest on equity, of which BRL 315,393,876.98 was previously credited as interest on equity, and (iii) BRL 1,419,898,653.23 for the statutory reserve named ad Investment Reserve, pursuant to article 26, §2, (f) of the Company's Bylaws.

The payment date will be communicated by means of a notice to shareholders;

The shareholders who appointed members to the Fiscal Council informed the Presiding Board that the respective fiscal councilors (i) have the necessary qualifications and comply with the requirements established in articles 162 and 147 of the Corporations Act for the exercise of the position, and (ii) that they are in a position to sign a term of office containing the declarations regarding the implementation of such requirements and to assume responsibility for the position under the terms of the law.

Were defeated in the separate election, with 17,314,843 votes in favor, 65,346,752 votes against and 300,597,700 abstentions registered, Mr. Marco Antonio Mayer Foletto, candidate for the position of effective member of the Company's Fiscal Council, with Mrs. Alexandra Leonello Granado, appointed by the shareholders PREVI - Caixa de Previdência dos Empregos do Banco do Brasil and BB Ações Equidade Fundo de Investimento; BB Ações Governanca FI; BB BNC Ações Nossa Caixa Nosso Clube de Investimento; BB Cap Ações Investment Fund; BB Cap Ibovespa Indexed FIA; BB Eco Gold Equity Investment Fund; BB ETF Ibovespa Index Fund; BB Previdência Ações IBrX Investment Fund; BB Terra do Sol MM Private Credit Investment Fund; BB Top ASG Brasil FIA Shares; BB Top Shares Ibovespa Asset FI; BB Top Ibovespa Shares Indexed FI; BB Top Shares Sector Consumption FI; BB Top Multimercado ASG Long Term Investment Fund; and Brasilprev Top A Fundo de Investimento de Ações, investment vehicles managed by BB Gestão de Recursos DTVM S.A.

Approved, by majority of votes casted, having registered 488,986,219 votes in favor, 711,896 votes against and 51,248,898 abstentions, the compensation of the members of the Fiscal Council, set at 10% (ten percent) of the attributed, on average, to the Company's Officers, not including benefits, representation allowances and profit sharing, in addition to the mandatory reimbursement of travel and lodging expenses necessary for the performance of the function, pursuant to, §3 of article 162 of the Corporations Act.

- 3) Approved, by unanimity of the votes, having registered 549,240,693 votes in favor, 0 votes against and 1,899,900 abstentions, the ratification of the approval of the merger of shares of the Companhia de Locação das Américas by the Company, as approved at the EGM 11/12/2020 and considering the terms of the Amendment to the Protocol, whose effectiveness remains conditioned to the satisfaction (or waiver, as the case may be) of the precedent conditions set forth in the Protocol and Justification;
- 4) Approved, by unanimity of the votes, having registered 549,240,693 votes in favor, 0 votes against and 1,899,900 abstentions, the amendment of article 3 of the Company's Bylaws, to reflect the inclusion, as complementary and related activities to the main corporate purpose of the Company, the intermediation and agency of services and business in general, except real estate, the leasing of enginery and equipment and the management of third-party assets, under the following terms:

"Article 3. The Company's purpose is:

- (a) car rental;
- (b) the temporary hire of driver labor in addition to car rental;
- (c) intermediation and agency activities for services and business in general, except real estate;

- (d) leasing of enginery and equipment;
- (e) the management of third-party assets; and
- (f) the management of equity interests, in Brazil and abroad."
- 5) Approved, by unanimity of the votes, having registered 549,240,693 votes in favor, 0 votes against and 1,899,900 abstentions, the amendment of §2 of article 18 of the Company's Bylaws, that addresses the hypotheses in which individual signatures are authorized by any attorney appointed pursuant to Article 19 of the Company's Bylaws, in the following terms:
 - "§2: Without prejudice to the provisions of the *caput* and, §1 of article 18 above, the individual signature by any attorney appointed under the terms of article 19 below is authorized, exempting the holding of the meeting of the Executive Board provided for in §1 above, in the following cases:
 - (a) signature of Vehicle Registration Certificates (CRV), within the scope of the purchase and sale of the Company's cars, as well as the purchase and sale agreements related thereto;
 - (b) signing of car rental agreements and general conditions of car rental agreements, including the subscription car product modality, as well as documents related to the term of receipt of vehicles;
 - (c) representation before judicial offices, in any instance, as well as before customs offices, Federal Revenue, Municipalities, INSS, FGTS and their collecting banks and others of the same nature, Regional Labor Offices, all Police Stations, as well as representation before the Fire Department and any supervisory bodies and issuers of operating licenses, permits and their derivatives, consumer protection and defense bodies, DETRAN's, DETRO and other traffic departments, including JARI's, Traffic Police Stations, Highway Police and even mixed capital companies, Federal Revenue Service, State Treasury Departments, Municipal Treasury Departments, Commercial and Registry Boards, Public Prosecutor's Office, Environment Departments, regular advertising agencies and even the ECAD, in addition to all other public and judicial government agencies, being authorized the replacement for this whole item; and
 - (d) representation before energy dealership, water supply and sewage treatment, telephony, internet and derivatives concessionaries."
- **6)** Approved, by majority of votes casted, having registered 547,448,241 votes in favor, 1,792,452 votes against and 1,899,900 abstentions, the amendment of §5 of article 26 of the Company's Bylaws to suppress the section "ad referendum of the general meeting", in the following terms:
 - "§5. The Company may pay or credit interest as compensation on equity calculated on net equity accounts, subject to the rate, method of calculation and limits established in tax legislation. The amount paid to shareholders as interest on equity may be attributed to the amount of the minimum mandatory dividend."
- 7) Approved, by unanimity of the votes, having registered 549,240,693 votes in favor, 0 votes against and 1,899,900 abstentions, the amendment of the *caput* and the sole paragraph of article 27 of the Company's Bylaws, to include the declaration of interest on equity in the event that the Company draws up interim balance sheets or shorter periods, as well as include the deadlines for the payment of declared interim dividends or interest on equity, in the following terms:
 - "Article 27. By resolution of the Board of Directors, the Company may prepare interim balance sheets or balance sheets for shorter periods, as well as, after hearing the Fiscal Council, if

installed, or alternatively the Audit Committee, declare dividends or interest on equity as provided for by law.

Sole paragraph: Interim dividends or interest on equity may be considered as an anticipation of the mandatory dividend, and must be paid within 60 (sixty) days from the date on which they are declared or until the end of the fiscal year in which they are declared, pursuant to §3 of article 205, of Federal Law No. 6,404/76, except in the case of interest on equity, which may be paid in the subsequent fiscal year, as approved by the Board of Directors."

8) Approved, by unanimity of the votes, having registered 549,240,693 votes in favor, 0 votes against and 1,899,900 abstentions, the proposed consolidation of the Company's Bylaws, to reflect the changes provided for in the items above. The text of the Company's consolidated Bylaws, now approved according to the management's proposal, already contemplating the items indicated above, was authenticated by the Presiding Board, numbered and filed at the Company's headquarters, and will be filed with the Commercial and Registry Board of the State of Minas Gerais in a separate section of these minutes, as well as available on the websites of CVM, B3 and the Company.

Closing: There being nothing further to discuss, the Chairman thanked the presence of all attendants and ordered the closing of the Shareholder Meetings after suspending the same so that these minutes could be drawn up, which, after being read, discussed and found to be in good order, were approved and signed by the Presiding Board. In accordance with article 21-V, §§1 and 2 of ICVM 481, shareholders whose remote voting ballots were considered valid by the Company and shareholders who registered their presence in the electronic remote participation system were considered present at the meeting and signatories of the minutes. The final summary voting maps and the List of Present Shareholders are shown in Annexes II and III to these minutes, respectively. The recording of the Meetings and the votes expressed through remote voting ballots were filed with the Company. Belo Horizonte, April 26, 2022.
