MINUTES OF THE ANNUAL AND EXTRAORDINARY SHAREHOLDERS' MEETING

HELD ON APRIL 26, 2021

- 1 **Date, Time and Place:** held on April 26, 2021 at 10:00 a.m., **exclusively digitally**, at the headquarters of Notre Dame Intermédica Participações S.A. ("**Company**"), in the city of São Paulo, State of São Paulo, at Avenida Paulista, No. 867, 8th floor, cj. 82, room A, Bela Vista, Zip Code 01311-100.
- 2 **Call Notice:** The Call Notice was published pursuant to Article 124 of Federal Law No. 6,404, of December 15, 1976, as amended ("**Brazilian Corporation Law**"), in the newspaper *Valor Econômico*, in the editions of March 24, 25 and 26, 2021, on pages E6, E7 and E20, respectively; and in the state register *Diário Oficial do Estado de São Paulo*, in the editions of March 24, 25 and 26, 2021, on pages 188, 191 and 363, respectively.
- 3 **Publications:** The management report, the financial statements of the Company and the independent auditor's report for the fiscal year ended on December 31, 2020, were published in the state register *Diário Oficial do Estado de São Paulo* (pages 05 to 22) and in the newspaper *Valor Econômico* (pages E41 to E50), both on March 17, 2021. Furthermore, all documents related to the matters to be decided, in accordance with Rule No. 481 issued by the Brazilian Securities Commission ("**CVM**") on December 17, 2009, as amended ("**CVM Rule 481**"), were made available to the shareholders at the Company's registered office and/or on the Company's website (<https://ri.gndi.com.br>), on the website of the CVM (www.cvm.gov.br) and on the website of B3 S.A. – Brasil, Bolsa, Balcão ("**B3**") (www.b3.com.br).
- 4 **Attendance:** Shareholders of the Company representing approximately 61.69% of the capital stock were present at the Annual Shareholders Meeting and 67.77% of the capital stock were present at the Extraordinary Shareholders Meeting, as per (a) the signatures in the Shareholders Attendance Book; and (b) the summarized voting results made available by the Company on April 24, 2021, based on the valid distance voting ballots received through the Central Depository of B3, through Itaú Corretora de Valores S.A., as the stock transfer agent of the Company, and through the Company directly, in accordance with CVM Rule 481 ("**Summarized Voting Map**"). Mr. Fábio Bobis, the legal representative of Ernst & Young Auditores Independentes S.S., the company responsible for auditing the financial statements of the Company for the fiscal year ended December 31, 2020 and Mr. João Ricardo Pereira da Costa, Chairman of the Fiscal Council, were also present.
- 5 **Presiding Board:** After the quorum for holding the Meeting was verified, the presiding board was composed by Mr. Michel David Freund - Chairman; and Mr. Glauco Desiderio - Secretary.
- 6 **Agenda:** To discuss and vote on:
 - 6.1 **At the Annual Shareholders Meeting:** (i) analysis of the manager's accounts, the financial statements of the Company, the opinion of the independent auditors and the opinion of the Audit Committee for the fiscal year ended December 31, 2020; (ii) approval of the proposal

for the allocation of net income for the fiscal year ended on December 31, 2020, including distribution of dividends; (iii) approval of the global amount of the compensation of the Company's management for the fiscal year of 2021; (iv) definition of the number of members of the Board of Directors; (v) election of the Board of Directors; and (vi) election of the members of the Fiscal Council.

6.2 At the Extraordinary Shareholders Meeting: amendment of article 5 of the Company's Bylaws, in order to ratify the capital increase carried out on September 11, 2020 due to the exercise of the Company's Stock Option Plan.

7 Resolutions: After verifying the quorum for convening the meeting and reading of the Summarized Voting Map, which was made available for consultation of the shareholders present, in accordance with Article 21-W, paragraph 4, of CVM Rule 481, the shareholders unanimously approved that these minutes be drawn up in summary form, as established in Article 130, paragraph 1, of the Brazilian Corporations Law, and that they will be published without the signatures of the shareholders, in accordance with Article 130, paragraph 2, of the Brazilian Corporations Law.

7.1 At the Annual Shareholders Meeting: After examining and discussing the matters, the shareholders resolved to:

- (i) approve, by a majority of the shareholders votes attending the meeting, with the record of 339,402,977 favorable votes, 118,400 contrary votes and 36,652,673 abstentions, the manager's accounts, the financial statements of the Company, the opinion of the independent auditors and the opinion of the Audit Committee for the fiscal year ended December 31, 2020;
- (ii) approve, by a majority of the shareholders votes attending the meeting, with the record of 371,946,641 favorable votes, 1,877,185 contrary votes and 2,350,224 abstentions, the allocation of the ascertained net profit in the amount of seven hundred thirty-six million, one hundred eighty-eight thousand, two hundred and eighty-five Brazilian reais and fifty four cents (BRL736,188,285.54) for fiscal year ended December 31, 2020, as below:
 - (a) five percent (5%) of the net profit, equivalent to thirty-six million, eight hundred and nine thousand, four hundred and fourteen Brazilian reais and twenty-eight cents (BRL36,809,414.28), for the legal reserve;
 - (b) twenty-five percent (25%) of the net profit (adjusted after allocation to the legal reserve), equivalent to one hundred and seventy-four million, eight hundred and forty-four thousand, seven hundred and seventeen Brazilian reais and eighty-two cents (BRL174,844,717.82), for payment to the Company's shareholders registered as such at May 13, 2021, it being certain that, as of May 14, 2021, the Company's shares will be traded ex-dividends. The dividends are going to be paid, at the discretion of the Board of Directors, until July 31, 2021; and
 - (c) the remainder of the net profit, in the amount of five hundred and twenty-four million, five hundred and thirty-four thousand, one hundred and fifty-three Brazilian reais and forty-five cents (BRL524,534,153.45), to the investment reserve.
- (iii) approve, by a majority of the shareholders votes attending the meeting, with the record of 202,515,057 favorable, 135,779,304 contrary votes and 37,879,689

abstentions, the annual global compensation of the Company's Management's members, for the fiscal year of 2021, in the annual global amount of up to seven million and seven thousand Brazilian reais (BRL7,007,000.00), of which BRL 7,000,000.00 (seven million Brazilian reais) referring to the Board of Directors and BRL 7,000.00 (seven thousand Brazilian reais) referring to the Executive Board;

- (iv) approve, by a majority of the present shareholders votes, with the record of 373,809,581 favorable votes, 14,245 contrary votes and 2,350,224 abstentions, the definition of the Board of Directors' composition by seven (7) effective members, of which three (3) are independent directors.
- (v) approve, by a majority of the present shareholders votes, with the record of 351,157,485 favorable votes, 18,745,263 contrary votes and 6,271,302 abstentions, the election of the following members of the Board of Directors, with unified mandate of 2 (two) years term, reelection allowed, pursuant to article 15 of the Company's Bylaws, according to the ticket presented in the Management Proposal for this Meeting:

The members of the Board of Directors hereby elected (a) will be invested in their respective positions by signing the instrument of investiture, according to **Attachment I** of these minutes; and (b) they will take office in their positions upon presentation: (i) of the respective instrument of investiture, drawn up in the appropriate book, containing the declarations in compliance with the law and regulations in force; (ii) the clearance statements, for the purposes of article 147 of the Brazilian Corporations Law and article 2 of CVM Rule 367; and (iii) the declarations of the securities eventually held by them issued by the Company and its subsidiaries or the same group, under the terms of article 157 of the Brazilian Corporations Law.

Messrs. José Luiz Teixeira Rossi, Plínio Villares Musetti and Mrs. Ana Paula de Assis Bogus forwarded their statements to the Board of Directors attesting their respective compliance with the independence criteria established in the B3 Novo Mercado listing regulation, as presented in the Management Proposal; and

- (vi) approve, by a majority of the present shareholders votes, recorded votes against and abstentions, the election of the following members of the audit committee, for term until the Annual General Meeting which will approve the financial statements for the fiscal year ending on 31 December 2021:

The members of the Fiscal Council hereby elected will take office after signing the respective instruments of investiture, drawn-up in accordance with the law, pursuant **Attachment II** of these minutes, and state, in compliance with Article 37, item II, of Law No. 8.934/94, Article 147 of the Brazilian Corporations Law and CVM Rule 367/02, not being involved in any of the crimes provided for by law or in other legal restrictions that prevent them from exercising management positions in a corporation.

- 7.2 At the Extraordinary Shareholders' Meeting:** After examination and discussion, the shareholders approved, by the majority of the present shareholders votes, with the record of 410,895,317 favorable votes, zero contrary votes and 2.350.224 abstentions, the amendment to the caption of Article 5 of the Bylaws to record the capital increases of the Company, carried out on September 11, 2020 upon Board of Directors' resolution, within the limit of authorized capital, due to the exercise of the Company's Call Option Plan. Thus, the caption of Article 5 of the Bylaws shall become effective with the following terms, as well as the consolidation of the Company's Bylaws, which forms an integral part of these minutes as **Exhibit III**.

***"Article 5:** The Company's share capital is BRL5,646,453,161.33 (five billion, six hundred and forty-six million, four hundred and fifty-three thousand, one hundred and sixty-one Brazilian reais and thirty-three cents) fully subscribed and paid-in, divided in 609,787,507 (six hundred and nine million, seven hundred and eighty-seven thousand, five hundred and seven) common, registered, book-entry and no par value shares."*

- 8 Closure:** There being no further matters to be discussed, the meeting was closed for the transcription of these minutes in summary form, in accordance with Article 130, Paragraph 1 and 2 of the Brazilian Corporate Law. After the meeting's reopening, the minutes were read, approved, and signed by the attending shareholders.
