MINUTES OF THE ANNUAL SHAREHOLDERS MEETING HELD ON APRIL 20, 2023

- **1. Date, Time and Place:** on April 20, 2023, at 1:00 p.m., in a partially digital format, as Call Notice of March 17, 2023, held at the headquarters of Lojas Renner S.A. ("Company" or "Lojas Renner") located at 401 Joaquim Porto Villanova Av., in the city of Porto Alegre, RS, Brazil, in accordance to the Brazilian Securities and Exchange Commission Instruction (CVM) no 81 of March 29, 2022, as amended ("81 CVM Resolution").
- **2. Notices/Publication:** (1) Call Notice published in the newspapers "Jornal do Comércio" (Porto Alegre) printed version and online, on the following days of March 17, 20 and 21, 2023; (2) the Management's report, financial statements and the reports from the independent auditor and the Fiscal Council, all related to the fiscal year ending on December 31, 2022, were published in the "Jornal do Comércio" (Porto Alegre) printed version and online, on February 17, 2023; and (3) the Management's Proposal/Shareholders Meeting Manual was submitted to the Comissão de Valores Mobiliários CVM (Brazilian Securities and Exchange Commission) and to the B3 Brasil, Bolsa, Balcão (Brazilian Stock Exchange) via the Empresas.NET system on March 16, 2023.
- **3. Attendance:** in accordance with CVM Resolution 81, this meeting was realized in a partially digital format, through the platform Zoom, as Call Notice of March 17, 2023. Thus, shareholders, representing 64,7% of the capital stock, participating in person, according to the logins made at the eletronic platform and the summarized voting map made available by the company on April 19, 2023, prepared in accordance with the valid remote voting ballot received by B3's Central Depository, by Itaú *Corretora de Valores*, as company's securities registrar and directly by the company. Also in attendance: (i) the Board of Director's members: José Galló, Chairman, Osvaldo Burgos Schirmer, Vice Chairman, Carlos Fernando Couto de Oliveira Souto, Christiane Almeida Edington, Thomas Bier Herrmann, Juliana Rozenbaum Munemori and Fábio Pinheiro, also as Chairman of the Audit and Risk Management Committee; (ii) the Board of Executive Officer's members: Daniel dos Santos, CFO and IRO; Fabiana Silva Taccola, Operations Officer; and Regina Frederico Durante, People and Sustainability Officer; (iii) members of the Fiscal Council: Joarez José Piccinini, Chairman, and Roberto Frota Decourt, and (iv) Mr. Guilherme Ghidini Neto representative of Ernst & Young *Auditores Independentes S.S.*, the Company's independent auditors.
- **4. Agenda:** (1) examine, discuss and vote on the Management's report and accounts and the financial statements all related the fiscal year ending on December 31, 2022; (2) examine, discuss and vote on the proposal for the allocation of net income related to such fiscal year and the distribution of dividends; (3) establish the number of members of the Board of Directors; (4) elect the members of the Board of Directors; (5) establish the aggregate compensation of the members of Management; (6) establish the number of members of the Fiscal Council; (7) elect the members of the Fiscal Council; and (8) establish the compensation amount of the members of the Fiscal Council.
- **5.** Chair: Mr. José Galló Chairman; Ms. Diva Deli Simas Freire Secretary.

- **5.1 Reading of Documents, Receipt of Votes and Drafting of the Minutes:** (1) the reading of the documents related to the Agenda of this meeting was unanimously waived, since all of them were previously made available by the Company and are of the knowledge of the shareholders; (2) the statements of voting, protest and dissent, if any, shall be numbered, received and authenticated by the Chair and shall be filed with the Company's headquarters, according to the provision in Paragraph 1st of Article 130 of the Law 6.404/76 and will be made available in accordance with the applicable law; (3) these minutes shall be issued in summarized format and will be published without signatures of all the attendees in accordance with Paragraphs 1st and 2nd of Article 130 of the Law 6.404/76.
- **6. Resolutions:** after reviewing and discussing the matters on the Agenda, the Shareholders resolved to:
- (1) approve, by majority voting, except for those legally impeded from doing so, according to the voting result herein attached as Annex 1, the Management's report and accounts and the financial statements related the fiscal year ending on December 31, 2022, as audited by *Ernst & Young Auditores Independentes S.S.*;
- (2) approve, by unanimous vote, except for abstentions, according to the voting result herein attached as Annex 1, pursuant to the Management's proposals, the allocation of the net income for fiscal year 2022 in the amount of R\$ 1,291,704,302.16 and the distribution of dividends as follows: (i) R\$ 269,417,215.14 to the Tax Incentive Reserve; (ii) R\$ 51,114,354.35 are allocated to the Legal Reserve; (iii) R\$ 322,847,698.14 to the Reserve for Investments and Expansion; and (iv) R\$ 648,325,034.53 to Dividends, which were fully distributed throughout the year in reference as Interest on Equity, corresponding to 50.2% of the net income for the fiscal year;

Pursuant to Article 34 of the Company's Corporate Bylaws, Interest on Equity in the total amount of R\$ 648,325,034.53 declared and paid throughout 2022, were attributed to the amount of dividends proposed by Management, with no additional amount to be paid as dividends concerning the year 2022;

- (3) <u>establish</u>, by unanimous vote, except for abstentions, according to the voting result herein attached as Annex 1, in 8 (eight) as for the number of seats in the Board of Directors;
- (4) elect, according to the voting result herein attached as Annex 1, the following as members of the Board of Directors: (i) José Galló, Brazilian, married, business administrator, bearer of ID number 6.011.890.834 SSP/RS, registered in the tax register (CPF/MF) under number 032.767.670-15; (ii) Osvaldo Burgos Schirmer, Brazilian, married, business administrator, bearer of ID number 7002135882, SJS-RS, registered in the tax register (CPF/MF) under number 108.187.230-68; (iii) Carlos Fernando Couto de Oliveira Souto, Brazilian, married, lawyer, bearer of ID number 7022007335 SSP/RS, registered in the tax register (CPF/MF) under number 469.694.890-00; (iv) Fábio de Barros Pinheiro, Brazilian, married, engineer, bearer of ID number 428.391 SSP/DF, registered in the tax register (CPF/MF) under number 275.497.201-34; (v) Thomas Bier Herrmann, Brazilian, married, business administrator, bearer of ID number 5004347224 SSP/RS, registered in the tax register (CPF/MF) under number 148.854.500-63; (vi) Juliana Rozenbaum Munemori, Brazilian, married, economist, bearer of ID Card R.G. Except for Mr. José Gallo, all the members hereby elected declare themselves as independent, with which declaration the Board of Directors corroborates, as to the independency criteria provided by the *Novo Mercado* ruling as well as by Company's Board of Directors Appointees Internal Policy. All the members of the Board of Directors hereby elected shall have a term of office until the Annual General Meeting of 2024 and shall declare, pursuant to Paragraph 1 of the Article 147 of the Law 6,404/76, that they were not found guilty of any crimes which respective law could prevent them from exercising corporate duties and shall be vested in their respective seats by signing their respective terms of office before the Register of the Minutes of Meetings of the Board of Directors in the form and for the period pursuant to Article 149, Paragraph 1 of the Law 6.404/76.

- (5) <u>approve</u>, by majority voting according to the voting result herein attached as Annex 1, the aggregate annual compensation of the Company's officers and members of the Board of Directors for fiscal year 2023 totaling up to R\$ 53.0 million, including fixed and variable compensation and expenses relative to the stock option plan and restricted shares;
- (6) <u>establish</u>, by unanimous vote, except for abstentions, according to the voting result herein attached as Annex 1, in 3 (three) as the number of effective seats in the Fiscal Council as well as 03 (three) for alternate/substitute members;

- (8) <u>approve</u>, by majority voting according to the voting result herein attached as Annex 1, the overall compensation of the Fiscal Council for the year 2023 in the amount of R\$ 850.9 thousand, which is resulted from the amount paid in 2022 plus the equivalent to the monetary adjustment by the INPC index.
- **7. Closing:** there being no further item on the Agenda to be discussed, the Chairman adjourned the meeting for the necessary time to conclude the drafting of these minutes. Upon resuming the session, the minutes were read and approved by the attendees, signed by the attendants, in accordance with CVM Resolution 81.
