**MINUTES OF THE ANNUAL GENERAL MEETING
HELD ON APRIL 29, 2026**

1. Date, Time and Place: on April 29, 2026, at 1pm., in a exclusively digital format, as Call Notice disclosed on March 27, 2026 of Lojas Renner S.A. (“Company” or “Lojas Renner”), with headquarters at the city of Avenida Joaquim Porto Villanova, 401, Jardim do Salso, in the city of Porto Alegre, state of Rio Grande do Sul, pursuant to paragraph 2º-A, Article 124 of Law nº 6,404/76 (“Corporate Law”) and the Brazilian Securities and Exchange Commission Resolution nº 81 of March 29, 2022, as amended (“CVM Resolution 81”).

2. Notices/Publications: (1) Call Notice published in the newspapers “*Jornal do Comércio*” (Porto Alegre) – printed version and online, on March 30 and 31 and on April 1, 2026; (2) the Management’s Report, Financial Statements and the Reports from the Independent Auditor and the Fiscal Council, all related to the fiscal year ending on December 31, 2025, published in the “*Jornal do Comércio*” (Porto Alegre) – printed version and online, on March 10, 2026; and (3) the Management’s Proposal/Manual for Participation of Shareholders in the General Meeting submitted to the Brazilian Securities and Exchange Commission (“CVM”) and to the *B3 – Brasil, Bolsa, Balcão* (Brazilian Stock Exchange) via the Empresas.NET system on March 27, 2026.

3. Attendance: This meeting was held in an exclusively digital format, with shareholders representing 66,65% of the capital stock of the Company, according to the participants at the eletronic platform and remote voting ballots dully sent. Also in attendance: (i) the Board of Director’s members: Carlos Fernando Souto, Chairman, Jean Pierre Zarouk, Vice-Chairman, Andréa Cristina de Lima Rolim, André Vitorio Cesar Castellini, Marcilio D’Amico Pousada, Adriano Cives Seabra, and Juliana Rozenbaum Munemori, also as Chairman (Coordinator) of the Audit and Risk Management Committee; (ii) the Executive Board’s members: Fabio Faccio, Chief Executive Officer, Daniel dos Santos, Vice-President of Finance, Administrative and Investor Relations, and Regina Durante, Vice-President of People, Sustainability and Institutional Relations; (iii) the members of the Fiscal Council: Roberto Frota Decourt and Paula Regina Goto, and (iv) Cristiano J. Seguecio, representative of *KPMG Auditores Independentes Ltda.*, the Company’s independent auditor.

4. Agenda: (1) examine, discuss and vote on the management’s accounts and the financial statements for the fiscal year ending on December 31, 2025; (2) examine, discuss and vote on the proposal for the allocation of net income for the fiscal year and the distribution of dividends; (3) establish the number of members of the Board of Directors; (4) elect the members of the Board of Directors; (5) establish the number of members of the Fiscal Council; (6) elect the members of the Fiscal Council; (7) establish the aggregate compensation of the members of Management; and (8) establish the compensation amount of the members of the Fiscal Council.

5. Chair: Mr. Carlos Fernando Souto – Chairman; and Ms. Eloisa Sassen – Secretary.

5.1 Reading of Documents, Receipt of Votes and Drafting of the Minutes: (1) the reading of the Agenda, the documents related to the Agenda of this Annual General Meeting and the Summarized Consolidated Voting Map was unanimously waived, since all of them were previously made available by the Company and are of the knowledge of the shareholders; (2) these minutes shall be

issued in summarized format and will be published without signatures of all the attendees in accordance with Paragraphs 1st and 2nd of Article 130 of the Corporate Law.

6. Resolutions: after reviewing and discussing the matters on the Agenda, the Shareholders resolved to:

(1) approve, by majority voting, except for those legally impeded from doing so, according to the voting result herein attached as Annex 1, the Management's report and accounts and the financial statements related the fiscal year ending on December 31, 2025, as audited by *KPMG Auditores Independentes Ltda.*;

(2) approve, by majority voting, according to the voting result herein attached as Annex 1, pursuant to the Management's proposals, the allocation of the net income for fiscal year 2025 in the amount of R\$ 1,457,566,755.60 (one billion four hundred fifty-seven million five hundred sixty-six thousand seven hundred fifty-five reais and sixty cents) and the distribution of dividends as follows:

(i) R\$ 72,878,337.78 (seventy-two million eight hundred seventy-eight thousand three hundred thirty-seven reais and seventy-eight cents) to the Legal Reserve, according to article 193 of the Corporate Law;

(ii) R\$ 834,310,275.33 (eight hundred thirty-four million three hundred ten thousand two hundred seventy-five reais and thirty-three cents), corresponding to 57,2% of the net profit for the fiscal year, to the payment of dividends. Pursuant to Article 36 of the Company's Bylaws, such amount has already been fully paid to the shareholders in the form of Interest on Equity, by resolution of the Board of Directors, with no additional amount to be paid as dividends; and

(iii) R\$ 550,378,142.49 (five hundred fifty million three hundred seventy-eight thousand one hundred forty-two reais and forty-nine cents) to the Reserve for Investment and Expansion, according to Article 35 (c) of the Company's Bylaws.

(3) establish, by majority voting, according to the voting result herein attached as Annex 1, at 8 (eight) the number of members of the Board of Directors;

(4) elect, according to the voting result herein attached as Annex 1, for a one-year term, the following members of the Board of Directors, all in the quality of independent members, under the terms of the *Novo Mercado* ruling, the Corporate Law and CVM Resolution No. 80, of March 29, 2022, as amended ("CVM Resolution 80"): (i) **Carlos Fernando Couto de Oliveira Souto**, Brazilian, married, lawyer, bearer of ID nr. 7022007335 (SSP/RS), registered in the tax register (CPF/MF) under nr. 469.694.890-00; (ii) **Jean Pierre Zarouk**, Brazilian, widower, business administrator, bearer of ID nr. 13.799.502-7 SSP-SP, enrolled in the tax register (CPF/MF) under nr. 100.881.148-30 (iii) **Juliana Rozenbaum Munemori**, Brazilian, married, economist, bearer of ID nr. 55.884.673-7 SSP/SP, enrolled in the tax register (CPF/MF) under nr. 081.606.157-28; (iv) **Andréa Cristina de Lima Rolim**, Brazilian, in a stable union, economist, bearer of ID nr. 20.532.366 (SSP/SP), enrolled in the CPF/MF under nr. 102.426.328-23; (v) **André Vitorio Cesar Castellini**, Brazilian, married, business administrator, bearer of ID nr 2.981.230-6 (SSP/SP), enrolled in the CPF/MF under nr. 117.088. 638-85; (vi) **Marcilio D'Amico Pousada**, Brazilian, married, business administrator, bearer of ID nr. 15.139.490 (SSP/SP), enrolled in the CPF/MF under nr. 066.548.318-02, (vii) **Adriano Cives Seabra**, Brazilian, in a stable union, engineer, bearer of ID number 08.899.444-7 (IFP/RJ), enrolled in the CPF/MF under nr. 016.480.547-81, all of them with commercial address at Avenida Joaquim Porto Villanova, 401, Jardim do Salso, in the City of Porto Alegre, State of Rio Grande do Sul; and (viii) **Gustavo José Costa Roxo da Fonseca**, Brazilian, married, engineer, bearer of ID number 15.643.174-9 (SSP-SP), enrolled in the CPF/MF under nr. 149.225.568-85.

The directors hereby elected declared themselves to be independent, pursuant to a favorable opinion of the Board of Directors regarding their compliance with the independence criteria set forth in the Novo Mercado Regulation, as well as in CVM Resolution 80 and in the Company's Management Nomination Policy. The directors shall assume office upon execution of the respective terms of office and declarations of no impediment, to be recorded in the Minutes Book of Meetings of the Board of Directors, in accordance with Brazilian Corporate Law and Annex K to CVM Resolution No. 80/22, and shall remain in office until the investiture of the directors elected at the Annual General Meeting to be held in 2027.

(5) establish, by majority voting, according to the voting result herein attached as Annex 1, at 3 (three) the number of effective members of the Fiscal Council and their respective alternate members;

The members of the Fiscal Council shall assume office upon execution of the respective terms of office and declarations of no impediment, and shall remain in office until the investiture of the members of the Fiscal Council elected at the Annual General Meeting to be held in 2027;

(7) approve, by majority voting, according to the voting result herein attached as Annex 1, the aggregate annual compensation of the Company's members of Management for the 2026 fiscal year totaling up to R\$ 56.8 million, including fixed and variable compensation and shares;

(8) approve, by majority voting, according to the voting result herein attached as Annex 1, the compensation of the Fiscal Council for the 2026 fiscal year in the amount of R\$ 900 thousand (nine hundred thousand reais).

7. Notice to Shareholders (Change of Newspaper): Pursuant to Article 289, paragraph 3, of the Corporate Law, the Company hereby notifies its shareholders that, following the publication of these minutes, the subsequent legal publications required under the Corporate Law and applicable regulations shall be made by the Company in the newspaper *Valor Econômico* (Brazil), a newspaper of wide circulation published in the city where the Company's head office is located, replacing *Jornal do Comércio*.

8. Closing: There being no further item on the Agenda to be discussed, the Chairman suspended the meeting for the necessary time to conclude the drafting of these minutes. Upon resuming the session, the minutes were read and approved by the attendees. The minutes will be signed by the

Chairman and Secretary, that hereby certified the presence of the shareholders according to the Attendees List and that the General Meeting complied with all legal and regulatory requirements to be held in the exclusively digital format.
