



MATERIAL FACT

DESKTOP S.A. ("<u>Company</u>"), pursuant to paragraph 4 of article 157 of Law 6,404/76 ("<u>Brazilian Corporate Law</u>") and CVM Resolution No. 44/2021 ("<u>CVM Resolution 44</u>"), hereby informs its shareholders and the market in general that, on this date, has carried out the acquisition of 70% (seventy per cent) of quotas representing the capital stock of Cilnet Comunicação e Informática Ltda. ("<u>Fasternet</u>") by Desktop Internet Ltda. ("<u>Transaction</u>").

Fasternet provides broadband Internet services with fiber optic technology in the interior of the State of São Paulo in the cities of Tatuí, Cerquilho, Boituva, Amparo, Rio Claro, Itu and more than 30 other cities in the region. With, approximately, 116 (one hundred and sixteen) thousand subscribers, Fasternet is on track to close the year 2022 with a Net Revenue of approximately R\$ 116,000,000.00 (one hundred and sixteen million Brazilian Reais) and an EBITDA of approximately R\$ 58,500,000.00 (fifty-eight million, five hundred thousand Brazilian Reais). Additionally, operating and administrative synergies of approximately R\$ 2,500,000.00 (two million and five hundred thousand Brazilian Reais) were mapped in addition to the aforementioned EBITDA.



The total price of the Transaction for the acquisition of 70% of the capital stock of Fasternet was R\$ 209,136,168.51 (two hundred and nine million, one hundred and thirty-six thousand, one hundred and sixty-eight reais and fifty-one cents), and the amount of R\$ 75,000,000.00 (seventy five million reais) was paid in cash, the amount of R\$ 25,000,000.00 (twenty five million reais) will be paid in January 2024, the amount of R\$ 88,136,168.51 (eighty-eight million, one hundred and thirty-six thousand, one hundred and sixty-eight reais and fifty-one cents) will be paid in installments, as of the first anniversary of the Transaction, in 5 (five) annual installments, and the amount of R\$ 21,000,000.00 (twenty-one million reais) will be paid on the fifth anniversary of the transaction.

The acquisition of Fasternet is consistent to Desktop's strategy, which focuses on players (i) that operate in regions adjacent to the Company's current operation, (ii) that are leaders in their respective markets, (iii) with consistent gain of market share, and (iv) with potential to leverage the Company's organic growth by opening new markets.
