**MINUTES OF THE ANNUAL GENERAL MEETING
HELD ON APRIL 24, 2025**

DATE, TIME AND PLACE:

On April 24, 2025, at 10:00 am, held exclusively digitally, through an electronic platform, pursuant to CVM Resolution 81/22.

CALL NOTICE AND OTHER DOCUMENTS PUBLISHED:

The Call Notice, dated March 14, 2025, was published in the newspaper Valor Econômico, on March 17, 18 and 19, 2025, on pages C7, C7 and B5, respectively.

The Management Report and Financial Statements of the Company for the fiscal year ended December 31, 2024, accompanied by the opinions issued by the Independent Auditors and the Audit Board, were published in the newspaper Valor Econômico, on February 27, 2025, on pages B03 to B05 and F37 to F47.

The Management Proposal and the 2025 Proxy Statement, as well as all other documents mentioned above, were made available to shareholders on the Company's Investor Relations website and on the websites of the Securities and Exchange Commission of Brazil ("CVM") and of B3 S.A. – Brasil, Bolsa, Balcão ("B3") more than one (1) month before the present date, in accordance with Federal Law 6,404/76 ("Brazilian Corporations Law") and the applicable CVM regulations.

ATTENDANCE:

Were in attendance shareholders holding common shares corresponding to 82.18% of the voting capital of Klabin S.A. ("Company" or "Klabin"), as per the shareholder attendance list present in these minutes, including both shareholders participating via digital platform and those who submitted absentee ballots, in accordance with CVM Resolution 81/22. Also present were Pedro Zan, representing the Audit Board; Renato Barbosa Postal, representing PricewaterhouseCoopers Auditores Independentes Ltda.; Cristiano Teixeira, Chief Executive Officer; and Herbert Wang Ho, Chief Controlling Officer of the Company.

AGENDA:

- (i) Review the management accounts, examine, discuss and vote on the Company's Financial Statements, accompanied by the Management Report and the Opinions issued by the Independent Auditors and the Audit Board, for the fiscal year ended December 31, 2024;
- (ii) Deliberate on the allocation of the net income for the year ended December 31, 2024;
- (iii) Establish the number of members of the Board of Directors for the next term;
- (iv) Elect the members of the Board of Directors;
- (v) Elect the members of the Audit Board;
- (vi) Deliberate on the overall annual compensation of the members of management for the fiscal year 2025; and
- (vii) Deliberate on the overall annual compensation of the members of the Audit Board for the fiscal year 2025.

DELIBERATIONS:

The shareholders unanimously decided to: (a) waive the reading of the documents referred to in article 133 of the Brazilian Corporations Law; and (b) approve the drafting of these minutes in summary form and their publication without the signatures of shareholders, pursuant to article 130, paragraphs 1 and 2, of the Brazilian Corporations Law. The shareholders were then informed that the consolidated absentee voting map was available for consultation, and no shareholder requested its reading. Subsequently, the following resolutions were taken:

- I. Approve, by majority vote, with abstentions of the legally prevented recorded, per the voting map included in **Annex I** to these minutes, the management accounts and the Financial Statements, accompanied by the Management Report and the opinions of the Independent Auditors and the Audit Board, pertaining to the fiscal year ended on December 31, 2024.

- II. Approve, by majority vote, with abstentions recorded, per the voting map included in **Annex I** to these minutes, the allocation of the net income for the fiscal year ended on December 31, 2024, according to the Management Proposal, as described below:
