1. Blau Farmacêutica SA (“Blau” or “Company”) received, by e-mail, on October 22<sup>nd</sup>, 2021, Official Letter No. 1434/2021-SLS from B3 SA - Brasil, Bolsa, Balcão, below transcribed:

2. In view of the aforementioned Official Letter, the Company clarifies that it is not aware of the existence of any relevant acts or material facts that should have been disclosed in the period between October 8<sup>th</sup>, 2021 and October 22<sup>nd</sup>, 2021 and were not. During this period there was considerable volatility in the stock market managed by B3, in view of the variation in the Bovespa Index in the period, which achieved 112,833 points at the end of the market session of October 8<sup>th</sup>, 2021, reached 114,648 points at the market closing of October 15<sup>th</sup>, 2021, dropping to the minimum level of 102,853 points, during the trading session of October 22<sup>nd</sup>, 2021, closing at 106,296 points.

3. The Company reinforces that it will inform its shareholders and the market in general of any events of its knowledge that may influence the price of its shares or investor's decision to buy, sell, maintain or exercise any rights inherent to the condition of holders of these securities, in accordance with applicable legislation and regulations.

4. Blau remains at yours disposal to provide any additional clarification that this Issuer's Listing and Supervision Superintendence may deem necessary with respect to the subject in question.
