The Board of Directors of the Company, pursuant to its Bylaws, unanimously resolved to (i) authorize the Company, Gerdau Aços Longos S.A. and Gerdau Açominas S.A. to contract a global credit line called "Senior Unsecured Global Working Capital Credit Agreement" ("Credit Agreement"), administered by the Bank of New York Mellon, with the following main characteristics described in the Credit Agreement: (a) amount of up to USD eight hundred seventy-five million (US\$ 875,000,000.00); (b) term of five (5) years from the date of signing of the Credit Agreement, and (c) up to seven (7) creditor banks, all top tier banks, to be contracted on a timely basis according to the individual credit approval procedures as per the terms and conditions established by the Company; and (ii) authorize the Company to provide, jointly and severally with Gerdau Acos Longos S.A. and Gerdau Acominas S.A., personal guarantees for all the obligations undertaken by Sipar Aceros S.A., Gerdau Acos Longos S.A., Gerdau Acominas S.A., Gerdau Trade Inc., GTL Trade Finance Inc., Gerdau Ameristeel Corporation, Gerdau Hungria Holdings LLC, Gerdau Corsa S.A.P.I de C.V., Gerdau GTL México S.A. de C.V., Empresa Siderúrgica Del Perú S.A.A., Gerdau Ameristeel US Inc., Gerdau Holdings Inc., Gerdau Macsteel Inc. and GUSAP III within the scope of the Credit Agreement.
- 3. The Board also resolved to authorize the Company, when signing all the documents necessary to execute the Credit Agreement and providing the personal guarantee mentioned in item 2(ii) above, including contracts and other related acts, to be represented in accordance with Article 12 of its Bylaws.
