## NOTICE TO THE MARKET

**GERDAU S.A.** (B3: GGBR / NYSE: GGB) ("Company" or "Gerdau") hereby informs its shareholders and the market that its Board of Directors, at a meeting held on this date, approved the establishment of a strategic partnership between Gerdau Next S.A. and Randon Serviços e Participações Ltda., with the same equity interest in the capital stock. The intention, initially, is to provide truck and semi-trailer rental services, in order to deliver solutions that meet the needs of cargo carriers or shippers ("Partnership"). Also on this date, Gerdau Next S.A. and Randon Serviços e Participações Ltda. signed the binding instruments that formalize the parties' intention to carry out the Partnership.

Investment in the Partnership will be R\$ 250 million, with each partner contributing in proportion to its interest in the capital stock. In addition to the initial investment, the Partnership may seek other sources of funding.

The Partnership underlines the mission of Gerdau Next, the new business division of Gerdau, to diversify the business portfolio of Brazil's largest steelmaker in strategic segments and drive its operational strategy with a comprehensive ecosystem of mobility solutions.

Note that the formalization of the Partnership is subject to conditions precedent typical to operations of this nature, which include approval from antitrust authorities.

The Company will keep its shareholders and the market duly informed on the conclusion of the operation.

## ABOUT GERDAU

With a history spanning 121 years, Gerdau is Brazil's largest steel producer, one of the leading producers of long steel in the Amercas and of special steel in the world. In Brazil, it also produces flat steel and iron ore for its own use. It also has a new business division – Gerdau Next – focused on operations in steel-related segments. Guided by its purpose of empowering people who build the future, the company is present in nine countries and has over 36,000 direct and indirect employees in its operations. Gerdau is the largest recycling company in Latin America and uses scrap as an important input, 73% of the steel it produces comes from scrap. Every year, Gerdau transforms 11 million tonnes of scrap into a variety of steel products. The company is also the world's largest charcoal producer, with over 250,000 hectares of planted forests in the state of Minas Gerais. As a result of its sustainable production matrix, Gerdau currently has one of the industry's lowest average greenhouse gas emissions ( $CO_2e$ ), of 0.90t/ $CO_2e$  per tonne of steel, which is about half the global industry average of 1.89 t/ $CO_2e$  per tonne of steel. Gerdau's shares are listed on the São Paulo (B3), New York (NYSE) and Madrid (Latibex) stock exchanges.
