

### **RESULT**

- » RN 10% above that of 1Q21;
- » Recurring 15% EBITDA margin;
- » Appreciation of BRL against the dollar putting pressure on costs;

Nakata was among the first positions of the most remembered brands in the general ranking of the national survey. 2,864 repairmen took part in the survey, carried out by CINAU.







Net Revenue | R\$ Million









# EBITDA | NET RESULT\_



### Resultado Líquido











Average Daily Volume (R\$ thousand), Quotation and No. of Shareholders









### WORKING CAPITAL AND FREE CASH FLOW\_





