NOTICE TO SHAREHOLDERS – Dividends and IoC distribution

Tegma Gestão Logística S.A. (“**Tegma**” or the “**Company**” – B3: TGMA3) hereby informs its shareholders and the market in general that, at a meeting of the Company’s Board of Directors held on August 3, 2026, the proposal for the payment of distributions (interim dividends and interest on equity) regarding the six-month period ended June 30, 2026, was approved, as follows:

R\$75,169,060.08, or R\$1.14 per share, comprising: (i) R\$56,047,106.20, as interim dividends, corresponding to R\$0.85 per share; and (ii) R\$19,121,953.88, as interest on equity, corresponding to R\$0.29 per share.

The interest on equity shall be credited toward the mandatory dividends for the fiscal year ending in 2026, pursuant to Article 9, Paragraph 7, of Law No. 9,249/95. Such amounts shall be subject to withholding income tax at a rate of 17.5%, except in the case of shareholders who provide satisfactory evidence of their exemption or immunity. Dividends will be paid to shareholders on a net basis, after deduction of applicable withholding income tax, except for those who provide proof of exemption from such tax under applicable tax laws.

All holders of the Company’s common shares as of August 6, 2026 (the “Record Date”) shall be entitled to receive the aforementioned distributions. The Company’s shares shall trade “ex-dividends and ex-interest on equity” as of and including August 7, 2026.

Payments shall be made on August 18, 2026, in accordance with the following instructions:

- i. shareholders using the share custody services shall have their distributions credited in accordance with the procedures adopted by B3 S.A. – Brasil, Bolsa, Balcão;
- ii. payment to all other shareholders shall be made by crediting the bank account details provided by the respective shareholder to Itaú Corretora de Valores S.A., in its capacity as the financial institution acting as custodian and registrar of the Company’s shares; and
- iii. shareholders who have not provided their bank details or who do not maintain a checking account with a financial institution must contact the share registrar, Itaú Corretora de Valores S.A., for instructions on updating their registration details, by calling **3003-9285** (state capitals and metropolitan regions) or **0800-720-9285** (other locations).
