Which personal data do we process?

The personal data that Neoenergia may process are:

How do we obtain your personal data?

You provide us with your personal data through a web form and third party systems, for registration in the Mailing Group.

We require that you update your personal data as it changes and always provide us real information, as we need to have your current information.

Why do we process your data?

What is the legitimacy for processing your data?

How long do we keep your data?
