Ref.: B3 Official Letter No. 118/2022-SLS – Request for clarification on atypical oscillation

ATACADÃO S.A. (B3: CRFB3) ("Company"), hereby presents to its shareholders and the market in general, in compliance with the Official Letter No. 118/2022-SLS issued by B3 S.A. – Brasil, Bolsa, Balcão, received on January 27, 2022 ("Official Letter"), the following information.

The Official Letter makes reference to the atypical oscillation in the Company's shares, as follows:

"Dear Sir,

In light of recent atypical oscillations verified in the securities issued by this company, the number of trades and volume negotiated, as shown below, we hereby request this company to inform, by January 28, 2022, if there is any fact to this company's knowledge that can justify such oscillation.

Except for the above-mentioned information, the Company is not aware, on the date hereof, of any other fact linked to the Company that may have resulted in such atypical oscillation.
