Atacadão S.A. (B3: CRFB3) ("Company"), informs its shareholders that the Company's Board of Directors, on September 12, 2022, approved the registration of the Company's corporate capital increase, within the limit of authorized capital, pursuant to Article 166, III, Paragraph 1 of Law No. 6.404/76, due to the exercise of stock call option.

Below, information on the referred Company's capital increase, pursuant to Exhibit E to CVM Resolution No. 80/22:

I – Date of shareholders' general meeting when the stock option plan was approved;

The Company's Stock Option Plan was approved at the Extraordinary Shareholders' Meeting held on March 21, 2017, ratified at the Extraordinary Shareholders' Meeting held on May 19, 2017, and amended at the Extraordinary Shareholders' Meeting held on June 26, 2017.

II – Capital increase amount and new capital stock;

Capital increase amount totaled R\$ 6,576,745.50. The Company's new capital stock, after capital increase is R\$ 9,917,302,008.46.

III – Number of shares issued of each type and class;

562,115 new non-par, book-entry, registered, common shares were issued.

IV – Issue price of new shares;

New shares were issued at the issue price of R\$ 11.70 per share.
