In addition, according to the correspondence received, the content of which is reproduced in full as part of this communication (Appendix I), Wishbone informs that:

- The shareholding now acquired is not intended to change the composition of the Company's control or administrative structure.
- It does not hold any convertible debentures issued by the Company or any other securities convertible in shares or that grant rights to subscribe or acquire shares issued by the Company.
- Neither were any contracts or agreements that regulate the exercise of voting rights or purchases and sales of securities disclosed by the Company.
