**MINUTE OF THE ANNUAL GENERAL MEETING  
HELD ON APRIL 28, 2026**

- 1 Date, Time and Place:** On April 28, 2026, at 2:00 p.m., held exclusively in digital format, through the Ten Meetings platform, being considered, for legal purposes, as held at the headquarters of Caixa Seguridade Participações S.A. ("**Caixa Seguridade**" or "**Company**"), located at the Setor Hoteleiro Norte, Quadra 1, Bloco E, 17º andar, Asa Sul, Zip Code 70701-050, city of Brasília, Federal District.
- 2 Call Notice and Publications:** The Call Notice was published in accordance with article 124 of Law No. 6,404, of December 15, 1976, as amended ("**Brazilian Corporation Law.**"), in the newspaper *Correio Braziliense*, in the editions of April 02, 06 and 07, 2026, pages 16, 14 and 17, respectively. The documents referred to in article 133 of the Brazilian Corporation Law, namely, the Management Report, the Financial Statements of Caixa Seguridade, the Report of the Independent Auditor, the Opinion of the Supervisory Board and the Annual Summary Report of the Audit Committee, relating to the fiscal year ended December 31, 2025, were published, in summary form, in printed version in the newspaper *Correio Braziliense*, on March 13, 2026, in issue no. 23,001, pages 19 to 24 and, in full, on the *website* of the aforementioned newspaper ([www.correio braziliense.com.br/publicidade-legal](http://www.correio braziliense.com.br/publicidade-legal)).
- 3 Documents Made Available:** The documents indicated above, as well as the other documents referred to in articles 10, 11 and 13 of Resolution No. 81, of March 29, 2022, as amended, of the Brazilian Securities and Exchange Commission ("**CVM**" and "**RCVM 81**", respectively), related to the matters to be resolved were made available to shareholders at the Company's headquarters and on the websites of Investor Relations of Caixa Seguridade, CVM and B3 S.A. – Brasil, Bolsa, Balcão, on March 27, 2026.
- 4 Attendance:** Caixa Seguridade's shareholders representing 86.72% (eighty-six point seven two percent) of the Company's voting capital stock were present, as verified by (i) the records of the electronic remote participation system made available by the Company, pursuant to Article 47, item III, of RCVM 81, and (ii) the Distance Voting Ballots validly received, pursuant to Article 47, item II, of RCVM 81, as established in article 127, sole paragraph, of the Brazilian Corporation Law. Also present were Messrs. Salvador Congentino Neto and Edgar Vieira Soares, representatives of the management of Caixa Seguridade, as well as the representatives of the independent auditor, Messrs. Ismael Nicomélio dos Santos and Luiz Olavo Costa Siqueira, from the Audit Committee, Mr. Jose Antonio Mendes Fernandes, from the Supervisory Board, Mr. Luiz Felipe Figueiredo de Andrade, and from the People, Eligibility, Succession and Compensation Committee, Mr. Edgar Vieira Soares, who were available for clarification.
- 5 Board:** Salvador Congentino Neto – Chairman, and Rafaela do Nascimento Moura Cordeiro – Secretary.

- 6 Agenda:** To resolve on: (i) the Management's accounts and the Financial Statements for the fiscal year ended December 31, 2025; (ii) the allocation of net income for the fiscal year ended December 31, 2025; (iii) the overall compensation of the Company's Managers, Supervisory Board members and members of the Company's Statutory Committees for the 2026/2027 fiscal year; and (iv) ratify the election of Mr. Luiz Francisco Monteiro De Barros Neto to the position of member of the Board of Directors.
- 7 Preliminary Procedures:** Before starting the work, Caixa Seguridade's legal advisor provided clarifications on the operation of the electronic remote participation system made available by the Company and the form of manifestation and vote of the shareholders participating in the Annual General Meeting ("**AGM**" or "**Meeting**").", as well as informed that: (i) the work of the Meeting would be recorded, and the recording will be archived at the Company's headquarters, pursuant to article 30, paragraph 1, of RCVM 81; and (ii) the electronic system of remote participation in the AGM allowed shareholders to listen to the statements of all other shareholders and to address the members of the Board and the other participants of the AGM, thus admitting communication between shareholders.
- 8 Resolutions:** Once the quorum for installation was verified, it was approved, by unanimity of the shareholders present: (i) the exemption from reading the documents related to the matters to be resolved, since such documents and information were previously made available and are known to the shareholders, as well as the voting maps disclosed to the market on this date, pursuant to article 46-C of RCVM 81, which were also made available to shareholders; (ii) the drafting of this minute in the form of a summary of the facts that occurred, as provided for in article 130, paragraph 1, of the Brazilian Corporation Law; and (iii) the publication with omission of the signatures of the shareholders, pursuant to article 130, paragraph 2, of the Brazilian Corporation Law. It was inquired whether any of the shareholders present had submitted a manifestation of vote by sending a Distance Voting Ballot and wished to change their vote at this AGM, so that the guidelines received through the ballot would be disregarded, as provided for in article 28, paragraph 2, item II, of RCVM 81. Subsequently, the matters on the agenda were placed for discussion and voting, as follows:
- (i) Pursuant to Article 132 of the Brazilian Corporation Law, were **approved**, by majority of the shareholders present, with record of opposing votes and abstentions, without reservations, the Management accounts and the Financial Statements for the fiscal year ended December 31, 2025, accompanied by the Explanatory Notes and the Independent Auditor's Report, and other applicable documents
  - (ii) It was **approved**, by majority of the shareholders present, with record of opposing votes and abstentions, without reservations, the allocation of net income for the fiscal year ended December 31, 2025, in the amount of BRL 4,291,560,084.13 (four billion, two hundred and ninety-one million, five hundred and sixty thousand, eighty-four reais and thirteen cents), pursuant to the Management Proposal, the Brazilian Corporation Law and the Company's Bylaws ("**Bylaws**"), as follows: **(a)** allocation of the amount of BRL 184,416,874.65 (one hundred and eighty-four million, four hundred and sixteen thousand, eight hundred and seventy-four reais and sixty-five cents), corresponding to approximately 4.30% of net income, to the legal reserve, in accordance with article 193 of the Brazilian Corporation Law and the Management

Proposal; **(b)** allocation of the amount of BRL 2,940,000,000.00 (two billion, nine hundred and forty million reais), representing BRL 0.980000000000 (ninety-eight cents) per share, fully to the dividend account, divided as follows: **(1)** 1,890,000,000.00 (one billion, eight hundred and ninety thousand reais) referring to interim dividends, fully paid in advance; and **(2)** BRL 1,050,000,000.00 (one billion and fifty million reais) referring to minimum mandatory dividends fully paid in advance; and **(c)** allocation of the amount of BRL 1,167,143,209.48 (one billion, one hundred and sixty-seven million, one hundred and forty-three thousand, two hundred and nine reais and forty-eight cents) to the statutory reserve, pursuant to item "f" of article 56 of the Bylaws.

(iii) It was **approved**, by majority of the shareholders present, with record of opposing votes and abstentions, without reservations, according to the Management's Proposal and based on the guidelines and parameters of the Parent Company, following the guidance of the Secretariat for Coordination and Governance of State-Owned Companies ("**SEST**"), set forth in Circular Letter SEI No. 15/2026/MGI and No. 663/2026/MGI, the establishment of the Global Compensation of Caixa Seguridade's Officers ("**RGD**") - Managers, Supervisory Board members and members of the Company's Statutory Committees, in the total amount of up to BRL 11,588,951.38 (eleven million, five hundred and eighty-eight thousand, nine hundred and fifty-one reais and thirty-eight cents) for the period from April 1, 2026 to March 31, 2027, in the form of the summary table in Exhibit III to this minute; and

(iv) It was **approved**, by majority of the shareholders present, with record of opposing votes and abstentions, without reservations, the ratification of the election of Mr. **Luiz Francisco Monteiro De Barros Neto**, Brazilian, married, economist, bearer of identity card No. 1.203.038, SSP/DF, registered with the CPF/MF under No. 703.347.227-72, with office at the company's headquarters, in the city of Brasília, Federal District, North Hotel Sector, Block 1, Block E, 17th floor, North Wing, CEP 70701-050, for the position of member of the Board of Directors.

It was stated that: **(1)** the profile of the candidate hereby ratified for the position of member of the Board of Directors, pursuant to item (iv) above, was evaluated with the favorable opinion of the People, Eligibility, Succession and Compensation Committee, for the nominee's compliance with legal, regulatory and statutory requirements; and **(2)** the candidate hereby ratified for the position of member of the Board of Directors will serve a term of office until the Annual General Meeting that approves the accounts for the fiscal year ending on December 31, 2026.

**9 Closing:** In compliance with Article 22, paragraph 5, and Article 33, paragraph 4, of CVM Resolution No. 80, of March 29, 2022, as amended, the total number of approvals computed in the voting of the items on the agenda is in the Final Voting Map (Exhibit II of this Minute). There being nothing more to discuss, the work for the drafting of this minute was suspended, which, once finalized, was read, approved and signed by the members of the Board, and the shareholders who participated in the Meeting through the electronic system made available by the Company, or via Distance Voting Ballot, had their presence recorded by the members of the Board and will be considered subscribers of this minute, pursuant to article 47, paragraphs 1 and 2, of RCVM 81, and the Caixa Seguridade Shareholders' Attendance

Book.
