NOTICE TO SHAREHOLDERS

UNIPAR CARBOCLORO S.A. ("Company") (B3: UNIP3, UNIP5 and UNIP6) (Fitch Ratings: AA+ (bra)) hereby informs its shareholders and the market in general that the Annual Shareholders' Meeting held today approved the distribution of dividends among the different types and classes of Company shares, under the terms of the Company's Management Proposal, based on the net income calculated for the fiscal year ended December 31, 2021.

Besides the early dividends already paid throughout 2021, as per notices to shareholders published on May 27, 2021, August 12, 2021, November 11, 2021, and December 16, 2021, the shareholders attending the meeting approved an additional dividend distribution of two hundred and fifty million reais (R\$250,000,000.00), to be paid as of **May 04, 2022**, divided among the different types and classes of Company shares as follows:

- a) the amount of eighty-two million, seventy-four thousand, eight hundred and seventy-two reais and twenty centavos (R\$82,074,872.20) proposed to common shares, corresponding to a dividend of R\$2.48651680790 per common share;
- b) the amount of five million, five hundred and fifty-three thousand, one hundred and forty-four reais and twenty centavos (R\$5,553,144.20) proposed to class "A" preferred shares, corresponding to a dividend of R\$2.73516848869 per class "A" preferred share; and
- c) the amount of one hundred and sixty-two million, three hundred and seventy-one thousand, nine hundred and eighty-three reais and sixty centavos (R\$162,371,983.60) proposed to class "B" preferred shares, corresponding to a dividend of R\$2.73516848869 per class "B" preferred share.

General Information

Holders of Company shares on **April 20, 2022** will be entitled to receive the additional dividends stated above. These dividends will be paid as of **May 04, 2022**, and the Company shares will be traded ex-dividends on B3 S.A. – Brasil, Bolsa, Balcão as of **April 22, 2022**.

The credits will be made available to shareholders based on their bank domicile provided to the Company's bookkeeping agent. As for shareholders whose shares are deposited with B3 S.A. – Brasil, Bolsa, Balcão, dividends will be paid and transferred through their custody agents.



As for shareholders whose registration data do not include the individual taxpayer's ID (CPF/ME), or the corporate taxpayer's ID (CNPJ/MF), or bank details (bank, branch, checking account), the amounts will only be credited as of the third business day as of the date of update of the registration data in the electronic files of Itaú Unibanco S.A. – Gerência de Operações e Escrituração, located at Rua Ururai, 111, Prédio B, Térreo, Tatuapé, São Paulo/SP, CEP 03084-010.
