NOTICE TO THE MARKET

UNIPAR CARBOCLORO S.A. (B3: UNIP3, UNIP5, and UNIP6) (Fitch Ratings: AA+ (bra)) (“Unipar” or “Company”) hereby informs its shareholders and the market in general that today Mr. Frank Geyer Abubakir presented his resignation from the positions of Chairman and sitting member of the Board of Directors.

Mr. Frank Geyer Abubakir concludes an important leadership cycle at Unipar, which culminates in the consolidation of Company’s the governance model, without the presence of the controlling shareholder in the Company management.

Due to his resignation and subsequent vacancy in the position of Chairman of the Board of Directors, Mr. Frank Geyer Abubakir appointed Mr. Bruno Soares Uchino, which has been a member of the Company’s Board of Directors since November 2017, for such office, under the sole paragraph of article 20 of the Bylaws.

Mr. Bruno Soares Uchino earned a bachelor’s degree in Law from the University of the Rio de Janeiro State and has more than 20 years of experience in mergers and acquisitions, debt restructuring, and corporate law. Because of his appointment for the position of Chairman of the Board of Directors, Mr. Bruno Soares Uchino presented today his resignation from the positions of coordinator and member of the Audit Committee.

Furthermore, given the vacancy in the seat of sitting member of the Company’s Board of Directors, Mr. Sergio Machado Terra was elected for the aforementioned position, with a term of office until the next general meeting, under article 150 of Law 6,404/1976 and paragraph 3 of article 19 of the Bylaws.

Mr. Sergio Machado Terra is a founding partner of Terra Tavares Ferrari Elias Rosa Sociedade de Advogados, responsible for the legal conduct of complex corporate, arbitration, and judicial issues. He also has experience as arbitrator, acting in courts constituted in the main Brazilian arbitration chambers. Mr. Sergio Terra earned a bachelor’s degree in Law from University of Rio de Janeiro (1993) and was a professor in the graduate program of Getúlio Vargas Foundation.



The Company also informs that, given that Mr. Frank Geyer Abubakir was elected by a multiple vote process at the Company's general meeting held on April 20, 2022, the other Board members elected in the same voting process, as well as the aforementioned substitute board member, will remain in office until the next general meeting, under paragraph 3 of article 141 of the aforementioned law, when a new election for the Board of Directors will be held.

The resignation of Mr. Frank Geyer Abubakir and the appointment of Mr. Bruno Soares Uchino to the position of Chairman of the Company's Board of Directors do not entail changes in its shareholding control, nor in the strategic direction and conduct of Unipar's business. Finally, the Company thanks Mr. Frank Geyer Abubakir for his dedication and major contribution to the Company during the period in which he served on the Board of Directors.
