## NOTICE TO SHAREHOLDERS

## ADJUSTMENT OF THE DIVIDENDS PER SHARE

**UNIPAR CARBOCLORO S.A.** (B3: UNIP3, UNIP5 and UNIP6) (Fitch Ratings: AA (bra)) ("Company") hereby informs its shareholders, in rectification to the Notice to Shareholders disclosed on April 03, 2020 that, due the acquisition by the Company of its own shares, in accordance with the Share Buyback Program approved by the Company's Board of Directors on November 9, 2018, the dividends per share approved by the Board of Directors' Meeting held on April 03, 2020, were adjusted from R\$0.393685714 to R\$<u>0.3939900763</u> per common share, from R\$0.714593340 to R\$<u>0.7145933404</u> per class "A" and from R\$0.433054285 to R\$<u>0.4333890839</u> per class "B" preferred share, remaining unchanged the total amount of R\$41,207,367.22.

Therefore, the dividends to be distributed between the different types and classes of shares issued by the Company, pursuant to article 33 of the Bylaws, as follows:

- (a) the amount of thirteen million, five hundred and thirty thousand, two hundred and seventy-seven reais and eighteen centavos (R\$13,530,277.18) will be allocated to the payment of dividends to common shareholders, corresponding to R\$0.3939900763 per common share;
- (b) the amount of one million, eight hundred and seventy-eight thousand, fourty hundred and six reais and fourty-nine centavos (R\$1,878,406.49) will be allocated to the payment of dividends to class "A" preferred shareholders, corresponding to R\$0.7145933404 per class "A" preferred share; and
- (c) the amount of twenty-five million, seven hundred and ninety-eight thousand, six hundred and eighty-three reais and fifty-five centavos (R\$25,798,683.55) will be allocated to the payment of dividends to class "B" preferred shareholders, corresponding to R\$0.4333890839 per class "B" preferred share.

The Company reiterates the following information:

## **General Information**

The holders of Company shares on April 9, 2020 will be entitled to receive the dividends declared herein. Such dividends will be paid as of April 22, 2020 and the Company shares will be traded ex-dividends on B3 S.A. – Brasil, Bolsa, Balcão as of April 13, 2020.

The credits will be made available to shareholders based on their bank domicile provided to the Company's bookkeeping agent. For shareholders whose shares are deposited with B3 S.A. – Brasil, Bolsa, Balcão, the dividends will be paid and transferred through their custody agents.

For shareholders whose registration does not include the individual taxpayer's ID (CPF/ME) or the corporate taxpayer's ID (CNPJ/ME), or bank/branch/checking account information, the amounts will only be credited as of the third business date after the date the registration was updated in the electronic files of Itaú Unibanco S.A. – Operations and Bookkeeping Area, Rua Ururaí, 111, Prédio B, Térreo, Tatuapé, São Paulo/SP, CEP 03084-010.
