São Paulo, February 07, 2023: Infracommerce CXaaS S.A., "Infracommerce" or the "Company" (B3:IFCM3), pursuant to CVM instruction no. 44 of August 23, 2021, as amended, informs its shareholders and the market in general, the 2023 preliminary financial projections, as detailed below.

Adjusted EBITDA	Between R\$150 and 170 million
Capex	Between R\$120 and 140 million

Considering these results, the Company formalizes its objective of advancing its profitability metrics.

These are preliminary and non-audited estimates and are subject to changes due to the announced transactions closing on January 09, 2023, and general macroeconomic conditions.
