Resignation of Member of the Board of Directors

São Paulo, March 31, 2022: Infracommerce CXaaS S.A., "Infracommerce" or "Company" (B3:IFCM3), in accordance with the provisions of the Brazilian Securities and Exchange Commission (*Comissão de Valores Mobiliários* – "CVM") Rule No. 44, of August 23, 2021, and article 26 of the *Regulamento do Novo Mercado*, hereby informs its shareholders and the market in general that it received, on March 30, 2022, a letter of resignation from **Mr. Pedro Sirotsky Melzer** to his position of effective member of the Company's Board of Directors, to which he had been elected on February 23, 2021, at the Company's Extraordinary Shareholders' Meeting ("Shareholders' Meeting"), whose term would extend until the Company's Annual Shareholders' Meeting which shall approve the management accounts related to the fiscal year ending on December 31, 2022.

In view of the resignation presented by Mr. Pedro Sirotsky Melzer, the director elected by the Shareholders' Meeting as a deputy, **Mr. Luiz Antonio Miranda Pavão de Farias**, will effectively assume the duties currently performed and within the competence of the respective member of the Company's Board of Directors.
