MATERIAL FACT

Movida Participações S.A. approves cancellation of public company registration of its subsidiary Movida Locação de Veículos S.A.

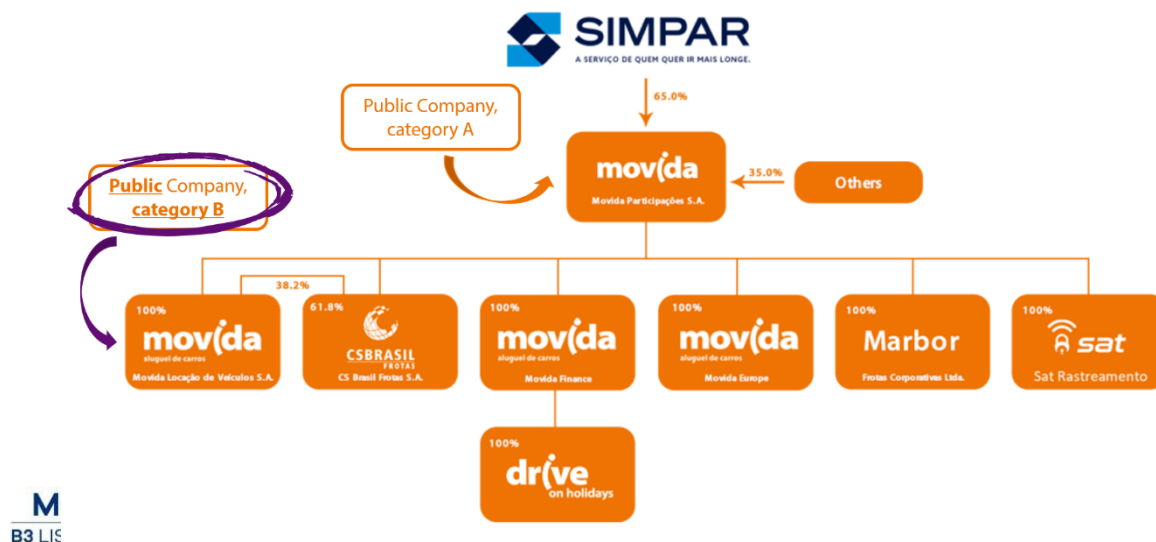
Movida Participações S.A. ("Movida Participações") and **Movida Locação de Veículos S.A.** ("Movida Locação" and, together with Movida Participações, the "Companies"), in accordance with the provisions of §4 of Art. 157 of Law No. 6404/76, as amended ("Brazilian Corporation Law"), of Art. 2, sole paragraph, item VI, of CVM Resolution No. 44/21, hereby inform their shareholders and the market in general that, at an Extraordinary General Meeting held on this date, Movida Participações, holder of 100% of the share capital of Movida Locação, approved the cancellation of the registration of Movida Locação as a publicly-held company in Category "B" before the CVM, with the exemption from conducting a public tender offer for shares, pursuant to Article 54 of CVM Resolution No. 80, of March 29, 2022, as amended ("Cancellation of Registration").

The Cancellation of Registration will provide administrative and economic benefits to the shareholders of Movida Participações, resulting in **operational simplification** and **reduction of ancillary costs** related to the operations and activities carried out by Movida Participações, however, it will have **no direct impact on the shareholders of Movida Participações S.A., which will remain a publicly traded company in the "A" category registered with the CVM and continue to have its shares listed on B3 under the ticker MOVI3.**

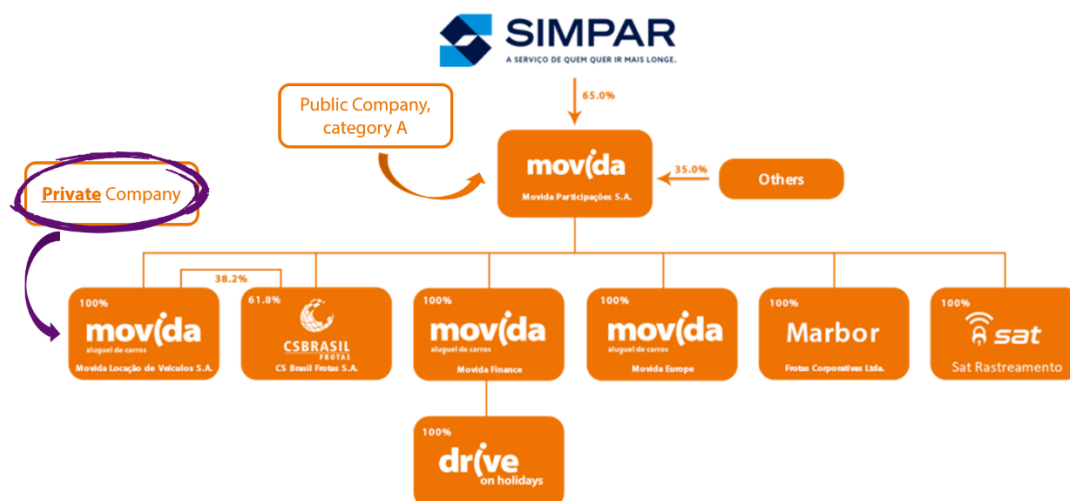
The procedural nature of this procedure is highlighted with the Cancellation of Registration follows the Material Fact of November 11, 2024, regarding the Partial Spin-Off of Movida Locação de Veículos S.A., when over 99% of the assets and liabilities of Movida Locação S.A.'s CNPJ were spun off into Movida Participações S.A.'s CNPJ.
