**Belo Horizonte, May 09<sup>th</sup>, 2023** — **MRV Engenharia e Participações S.A. (B3: MRVE3)** ("Company"), in accordance with CVM Resolution No. 81/22, discloses its voting final detailed statement regarding the voting instruction pronounced through remote and presential voting to each of the matters submitted for deliberation at the General Extraordinary Meeting held on May 09th 2023:

## **DELIBERATIONS:**

- 1. To deliberate on the changes to Article 5 of the Companys Bylaws to reflect the capital increase, within the authorized capital limit, approved by the Board of Directors meeting held on January 9, 2023 and ratification of the Companys current capital;
- 2. To deliberate on the creation of (i) the New Business and Innovation Executive Board, composed by 01 (one) Executive Director, and (ii) the Real Estate Development Executive Board I and II, composed by 02 (two) Executive Directors; so that the Company now has 10 (ten) Executive Officers, as per the proposal approved by the Board of Directors at a meeting on March 24, 2023, with consequent amendment to the caput and paragraphs 7, 8 and 9 of article 27 the Companys Bylaws;
- 3. To deliberate on the inclusion, in the Companys Bylaws, of the provisions of items III and IV of article 22 of the "Regulamento do Novo Mercado", referring to the Audit Committee, with the consequent inclusion of paragraphs 3 and 4 of article 31 of the aforementioned Bylaws;
- 4. To deliberate on the consolidation of the Companys Bylaws, due to the deliberations of the items above;
- 5. To deliberate on the creation of the Companys Stock Option Plan IV;
- 6. To deliberate on publishing the minutes of the General Meeting pursuant to art. 130, §2, of the Corporate Law 6,404 /76, omitting the names of the shareholders.
