NOTICE OF 2ND ROUND OF REVERSE AUCTION FOR PAYMENT OF EXTRA-COMPETITIVE CREDITS BY OFFERING A MINIMUM DISCOUNT (Reverse Auction) issued in the records of Judicial Reorganization No. 0090940-03.2023.8.19.0001, pending before the 7th Business Court of the District of the State of Rio de Janeiro of OI S.A. IN JUDICIAL RECOVERY, (CNPJ 76.535.764/0001-43), with headquarters and establishment at Rua do Lavradio, nº 71, Centro, Rio de Janeiro-RJ, CEP 20230-070, PORTUGAL TELECOM INTERNACIONAL FINANCE B.V. AND M RECUPERAÇÃO JUDICIAL (34108060), with headquarters at Delfandlaan 1 (Queens Tower), Office 916, 1062 EA, Amsterdam, Netherlands; OI BRASIL HOLDINGS COOPERATIEF U.A. IN JUDICIAL RECOVERY (52578518), with s Headquartered at Delfandlaan 1 (Queens Tower), Office 916, 1062 EA, Amsterdam, Netherlands. The Honorable Judge of the 7th Business Court of the District of the Capital of the State of Rio de Janeiro (Judicial Reorganization Court), Dr. SIMONE GAST ESI CHEVRAND, in accordance with the law, HEREBY NOTIFIES that, under the terms stated in the Judicial Reorganization case files, the OI Group will hold a 2nd Round of Reverse Auction for the payment of extra-bankruptcy credits, under the terms described below and in accordance with the conditions established in this Notice, with creditors having up to ten (10) calendar days from the publication of this Notice to submit their proposals and express their interest in the auction, under the following terms: 1. Purpose of the Reverse Auction: The purpose of the Reverse Auction will be to pay outstanding credits registered with the Recuperandas until January 31, 2026, exclusively owned by Non-Bankruptcy Creditors who wish to participate in the auction. For clarification purposes, Non-Bankruptcy Creditors are those who hold credits constituted after the filing of the Judicial Reorganization on March 1, 2023. 2. Minimum Discount: Interested creditors must submit a minimum discount proposal with settlement of the remaining balance, observing the value range corresponding to their respective credit, under the following terms: a) for credits up to R\$ 1,000,000.00 (one million reais): minimum discount of 40% (forty percent) on the nominal value of the credit; b) for credits exceeding R\$ 1,000,000.01 (one million reais and one cent): minimum discount of 70% (seventy percent) on the nominal value of the credit. 3. Reverse Auction Basis: The value of the Extra-Bankruptcy Credit to be considered for bidding purposes in the Reverse Auction shall correspond, in any event, to the full amount of the notes/invoices due by January 31, 2026, and not yet paid. The amounts recognized by the Company will be included in the list of extra-bankruptcy credits for the second round of the Reverse Auction, which will be available on the Company's website (www.oi.com.br) and on the Judicial Management website (www.psvar.com.br). 4. Waiver: Creditors with claims exceeding R\$ 1,000,000.01 (one million reais and one cent) who wish to participate in the reverse auction may waive the excess amount, expressly, irrevocably, and irreversibly, in order to qualify for the respective lower minimum discount range and thus participate in the auction according to the criteria available in the respective framework. 5. Requirements for Participation in the Reverse Auction: All Extra-Bankruptcy Creditors may participate in the Reverse Auction if they: i) have credit duly recognized by the Company, such that, in the event of a discrepancy between the Credit recognized by the Company and that recognized by the creditor, the former shall prevail for the purposes of participation in the Reverse Auction; ii) Offer a discount not less than the minimum discount on the full amount of the extra-bankruptcy credit (until January 31, 2026), so that, if they are winners in the Reverse Auction, they may receive such credit with the discount offered in the context of the Reverse Auction, giving full discharge to the remaining balance; iii) Submit identification documents together with the Form, which, in the case of Legal Entities, shall include: articles of association and amendments, sub-power of attorney (when necessary), and power of attorney with specific powers if represented by a third party; and for individuals: personal documents (ID and CPF or CNH), and power of attorney with specific powers if represented by a third party, also indicating contact details (telephone, email, and physical address) and bank details for payment (bank, branch, checking account, PIX, CNPJ/CPF, name of the beneficiary). 6. Form: On the Form, the discount to be offered by the creditor must be expressed as a percentage with a maximum of two decimal places, and any bids submitted with more than two decimal places will be rounded (up if the third decimal place is equal to or greater than 5; or down if the third decimal place is equal to or less than 4, as applicable). Only a single bid (e.g., a single discount percentage) per creditor will be accepted. /economic group, even if it holds credits originating from various debt instruments, and the creditor must indicate in detail the composition of the credit offered in the Form. 7. Business Group: Creditors belonging to the same Economic or Business Group must consolidate their credits so that the amount submitted to the auction corresponds to the totality of the credits held by that group. 8. Funds Allocated to the Reverse Auction: A total amount of R\$ 140,000,000.00 (one hundred and forty million reais) will be made available for the auction.

The aforementioned amount will be distributed among the credit ranges, in proportion to their total liabilities calculated per range, so that for the payment of Creditors considered winners in the range of up to R\$ 1 million, the amount of R\$ 12,022 will be made available.

Maximum Payment: In order to ensure the most equitable distribution of funds among the largest possible number of creditors, it is established that the maximum amount to be received by each creditor/economic group considered the winner will be limited to R\$ 40,000,000.00 (forty million reais). 10. Expression of Interest in Participating in the Reverse Auction: Non-bankruptcy creditors who are interested in participating in the Reverse Auction and meet all the requirements set forth in item 5 above must submit the duly completed Form directly to the Judicial Management, via email

The Notice and the Form will be available on the Company's website (www.oi.com.br) and the Judicial Management website (www.psvr.com.br). Proposals must be formulated in a clear, specific, and binding manner, following the model provided by the Judicial Management, indicating the total amount of the credit submitted to the procedure (the entire credit held until January 31, 2026), the corresponding range, the discount percentage offered (following the minimum percentage), a statement of full settlement of the remaining balance, and other elements necessary for analyzing its regularity and adherence to the established rules. If any documents are missing or insufficient in the Form submitted by the respective Creditor, Judicial Management will notify the Creditor of the outstanding issues and grant the Creditor a period of two (2) days to rectify them. If the specified period ends without the Creditor having resolved the outstanding issues, their participation in the Reverse Auction will be rejected. 11. Reverse Auction Result: The creditor(s) who submit(s) the highest Discount Offered on the nominal value of their credit, in accordance with the rules set forth herein, shall be considered the winner(s) of the Reverse Auction. The Judicial Management will announce the Winning Bid(s) and must disclose in the Judicial Reorganization records, within fifteen (15) days after the deadline given to creditors to regularize their documentation, a list containing the results of the Reverse Auction, presenting the final cascade of payments based on the terms of each of the proposals submitted and the total amount of Credits that will be settled up to the limit of the Amount made available by the Oi Group. 12. Apportionment Rules: If more than one Extra-Bankruptcy Creditor is declared a Winning Creditor for having submitted Winning Proposals with an identical discount percentage and the balance available for payment is not sufficient to ensure full payment of all such Winning Proposals (considering only the discounts offered), payment will be made by proportional apportionment among such Winning Proposals, respecting the minimum percentage and always limited to the balance of the respective Credits and the limit of funds made available.

In the event of a tie between bids and apportionment among bidders with the same discount percentage, the settlement of the original credit amount (without the discount) will be proportional to the amount actually received by the creditor as a result of the apportionment, taking into account the value of the discount offered. 13. Payment(s) of the Winning Bid(s): The Recoverable Companies shall make the payment(s) of the Winning Bid(s), in accordance with the apportionment rules, within ten (10) calendar days from the announcement of the reverse auction results. 14. The Judicial Administration emphasizes that participating creditors are fully subject to the conditions set forth herein, with a view to ensuring the efficiency of the reverse auction, equality among interested parties, and the best outcome for the companies undergoing reorganization. And so that it may come to the attention of interested parties and produce the intended effects, this Notice is hereby issued, which will be posted and published in accordance with the law.
