#### NET REVENUE FROM THE SALE OF ASSETS

1. Sale of all shares of ONTs held by Oi, as well as the associated account into which the proceeds of the sale will be deposited.
2. Credit rights and associated accounts owned by Oi related to receivables determined in favor of Oi in the ICC Arbitration No. 26470/PFF, except for the amounts already committed to third parties under the agreement reached in the Consensual Solution Procedure.
3. Credit rights pertaining to 50% (fifty percent) of the receivable cash flows, existing, contingent, current or future, arising from service provision contracts entered into from time to time between the Debtors or their Affiliates and their respective corporate customers, as well as any and all associated accounts into which such flows are deposited, at any time, in favor of Oi.
4. Shares of Oi Soluções S.A. held by Oi or its Affiliates, as well as all assets comprising its portfolio.
