O rating foi rebaixado de ‘B3’ para ‘Caa3’ na escala global e possui perspectiva negativa.

(“Light” or “Company”) (B3: LIGT3; ADR I: LGSXY), in compliance with CVM Resolution 44/2021, hereby informs its shareholders and the market in general that the Company and its subsidiaries Light Serviços de Eletricidade S.A. and Light Energia S.A. had their credit risk ratings changed by Moody’s Investors Service (“Moody’s”).

The rating was downgraded from ‘B3’ to ‘Caa3’ on the global scale with negative outlook.

The downgrade reflects the reasoning included in the report released by Moody’s, which is available on the link below.
