MINUTES OF THE ANNUAL AND EXTRAORDINARY SHAREHOLDERS' MEETING

DATE, TIME, PLACE: 04/29/2025, at 3:00 p.m., at the Company's headquarters, at Avenida Prefeito Waldemar Grubba, 3.300, CEP 89256-900, in Jaraguá do Sul - Santa Catarina.

ATTENDANCE: (a) Shareholders representing more than 91.4% of the Capital Stock; (b) Mr. Alberto Yoshikazu Kuba, Chief Executive Officer of the Company; (c) Mr. Felipe Brutti da Silva, representative of KPMG Auditores Independentes; and, (d) Mr. Vanderlei Dominguez da Rosa, Member of the Fiscal Council.

AGENDA: The reading of the Call Notice is waived, in view of its prior and regular publication. The reading of the consolidated Remote Voting Bulletin was also waived, considering its prior availability via *the internet*, in the Investor Relations area of the Company's website, in compliance with the provisions of CVM Instruction No. 481/2009.

DRAFTING AND PUBLICATION OF THE MINUTES: The drafting of these minutes in summary form was approved, as well as its publication with the omission of the signatures of the shareholders, pursuant to paragraphs 1 and 2 of article 130 of Law No. 6,404/76.

a) **AT THE ANNUAL GENERAL MEETING:** After voting on the items on the specific agenda, the shareholders decided, according to the voting protocol and voting map:

1. To approve, by majority vote (3,738,287,762), with abstentions (93,440,866) and votes against (833,218) registered, and excluding those legally impeded, the Management Report, Financial Statements, Independent Auditors' Report, Fiscal Council Opinion and other acts and documents related to the fiscal year ended December 31, 2024.
2. To approve, by majority vote (3,739,880,273), with abstentions (92,660,255) and votes against (21,318), the allocation of net income for the year 2024, made available to the Shareholders' Meeting, in the amount of R\$ 6,042,592,653.57, plus (a) R\$ 1,613,890.38 related to the Reversal of Dividends from Previous Years; (b) R\$ 13,725,567.90 related to the realization of the Revaluation Reserve - Assigned Cost, less R\$ 851,348.96 related to the complement of the Stock Option Plan; totaling R\$ 6,057,932,111.85, as proposed by the Board of Directors, with the following allocation: (a) R\$ 302,129,632.68 for Legal Reserve; (b) R\$ 3,190,925,671.75, for Dividends and Interest on Equity, already distributed; and (c) R\$ 2,564,876,807.42 to Finance the Capital Budget/Investment Reserve in 2025. The Investment Budget for the year 2025 was also approved, in the amount of R\$ 3,835,956,824.00, with the following sources of funds: R\$ 2,564,876,807.42 with own resources (Capital Budget Reserve) and R\$ 1,271,080,016.58 with third-party resources (Financing). With the approval of this allocation, all resolutions of the Board of Directors carried out based on article 39 of the Bylaws, on the distribution of Dividends



and Interest on Equity, related to the fiscal year ended on 12/31/2024, are ratified and ratified.

2.1. The Company also notes that the Budget amount does not include the amounts related to the acquisition operations to be eventually signed throughout the year.

3. To approve, by majority vote (3,784,700,748), with abstentions (719,864) and votes against (47,141,234), the establishment of the annual global compensation of the Company's Management for the year 2025, in the amount of up to R\$ 143,125,000.00, of which up to R\$ 27,448,000.00 for the Board of Directors, and up to R\$ 115,677,000.00 for the Board of Executive Officers, distributed as follows: (a) Compensation by WEG S/A in the amount of up to R\$ 24,756,000.00, up to R\$ 14,275,000.00 for the Board of Directors, and up to R\$ 10,481,000.00 for the Board of Executive Officers; and (b) Compensation by the subsidiary WEG Equipamentos Elétricos S/A, in the amount of up to R\$ 118,369,000.00, of which up to R\$ 13,173,000.00 for the Board of Directors, and up to R\$ 105,196,000.00 for the Board of Executive Officers.
4. To approve the election of the following members of the Fiscal Council, as follows:

Appointed by the Controllers, approved by majority vote (2,743,303,164), abstentions (20,583,824) and votes against (627,070) recorded, without reservations:

- Effective member: Ms. **Patricia Valente Stierli**, Brazilian, divorced, business administrator, registered with the CPF under No. 010.551.368-78 and Identity Card No. 4589089 SSP/SP, with address at Rua Itacema, 246 – apto. 32, Itaim Bibi, CEP 04530-050, São Paulo-SP; and as its Alternate: Mr. **Giuliano Barbato Wolf**, Brazilian, divorced, administrator, registered with the CPF under No. 417.982.609-72 and Identity Card No. 1/R 839.655 SSP/SC, with address at Av. Trompowsky, 291, Torre I, sala 06, Centro, CEP 88015-300, Florianópolis-SC.

Nominated by the minority shareholders, approved in a separate vote, by majority vote (1,057,539,410), with the opposing votes recorded (10,508,378), with no abstentions and no reservations:

- Effective member: Ms. **Lucia Maria Martins Casasanta**, Brazilian, married, economist and accountant, registered with the CPF under No. 491.887.206-91 and Identity Card No. M-1073947 SSP/MG, with address at Rua Gorceix 28 apto 402, CEP 22.411-050, Rio de Janeiro - RJ; and as its Alternate: Ms. **Silvia Maura Rodrigues Pereira**, Brazilian, single, economist, registered with the CPF under No. 817.642.437-49 and Identity Card No. 318457 MMA, with address at Rua Barão da Torre, 445, Apto 501, Ipanema, CEP 22411-003, Rio de Janeiro-RJ.

5.1. The Fiscal Council Members shall take office within 30 days from this date, upon signing the respective Instrument of Investiture in a proper book, which shall also contain the declaration that they meet the requirements provided for by law and that they are not prevented from exercising the position, pursuant to article 162 of Law No. 6,404/76; whose document will be filed at the Company's headquarters. The Fiscal Council members shall hold their positions until the first Annual General Meeting to be held after this date.



5. To approve, by majority vote (3,829,791,932), with abstentions (1,820,739) and votes against (949,175), without reservations, the individual monthly remuneration for the effective members of the Fiscal Council, in the amount of R\$ 15,435.00.
6. To approve, by majority vote (3,832,545,124), with abstentions (14,005) and votes against (2,717), without reservations, that the publications of the Company's legal acts be made in the following newspapers: "Correio do Povo", from Jaraguá do Sul-SC and "Valor Econômico", from São Paulo-SP.

b) **AT AN EXTRAORDINARY GENERAL MEETING**: Once the items on the agenda were voted, the shareholders decided, according to the voting protocol and voting map:

1. To approve, by majority vote (3,746,321,695), with abstentions (11,234) and votes against (90,316,194), in accordance with the voting protocol and voting map, and without reservations, the revision of the share-based compensation plan, called the Long-Term Incentive Plan (ILP Plan), in favor of the Company's Directors and Managers.
2. To approve, by majority vote (3,835,730,660), with abstentions (5,185) and votes against (913,278) registered, according to the voting protocol and voting map, and without reservations, the increase in the capital stock from R\$ 7,504,516,508.00 to R\$ 12,504,516,508.00, through the incorporation of part of the balance of the Profit Reserve/Profit Retention for Investments account in the amount of R\$ 5,000,000,000.00, without an increase in the number of shares. As a result of this approval, the *caput* of Article 5 of the Bylaws will have the following wording: "**Article 5** - *The Company's Capital Stock is R\$ 12,504,516,508.00 (twelve billion, five hundred and four million, five hundred and sixteen thousand, five hundred and eight reais), fully subscribed and paid in, represented by 4,197,317,998 (four billion, one hundred and ninety-seven million, three hundred and seventeen thousand, nine hundred and ninety-eight) registered book-entry common shares, with no par value, all with voting rights.*". The Bylaws will be consolidated to reflect the approved amendment.
3. To approve, by majority vote (3,836,236,226), with abstentions (6,888) and votes against (406,009) registered, according to the voting protocol and voting map, and without reservations, the creation of the Statutory Audit Committee. As a result of this approval, a new chapter will be included in the Bylaws:
"CHAPTER IX - THE STATUTORY AUDIT COMMITTEE
Article 37 - *The Company shall have a Statutory Audit Committee, an advisory body directly linked to the Board of Directors, composed of up to three (3) independent members, one of whom shall be Coordinator, appointed and removed by the Board of Directors, and (i) the members of the Committee shall be independent members, (ii) at least one (1) of the members shall be independent members of the Company's Board of Directors; that does not participate in the Executive Board, as defined in the Novo Mercado Regulation, of B3 and (iii) at least 1 (one) of the members must have recognized experience in corporate accounting matters.*
Article 38 - *It is incumbent upon the Statutory Audit Committee:*
 - a) *give an opinion on the hiring and dismissal of independent audit services;*
 - b) *evaluate quarterly information, interim statements and financial statements;*
 - c) *monitor the activities of the Company's internal audit and internal controls area;*
 - d) *evaluate and monitor the Company's risk exposures;*
 - e) *evaluate, monitor, and recommend to management the correction or improvement of the Company's internal policies, including the related party transactions policy;*
 - f) *receive and process information reporting non-compliance with legal and regulatory provisions applicable to the Company, as well as internal regulations and codes, including the provision of specific procedures for the protection of the provider and the confidentiality of the information;*
 - g) *to inform the Board of Directors quarterly of its activities, which will be recorded in the minutes of the Board of Directors' meeting in which the report is made;*
 - h) *submit annually to the Board of Directors, before the end of the annual year, a*



proposal for a summary report covering the meetings held and the main issues discussed, and recommendations made by the Statutory Audit Committee to the Board of Directors, to be disclosed by the Company.

Paragraph 1 - The rules relating to the composition, duties, operation, compensation and term of office of the members of the Statutory Audit Committee, among other aspects, are governed by its own Internal Regulations, approved by the Board of Directors, in compliance with the provisions of the applicable regulations.". The Bylaws will be consolidated, including the updating of the numbering of the subsequent and referenced articles, to reflect the approved amendment.

4. To approve, by majority vote (3,818,391,646), with abstentions (14,467) and votes against (18,243,010), in accordance with the voting protocol and voting map, and without reservations, the installation of the Fiscal Council, with a change from permanent to non-permanent, pursuant to the caput of article 161 of Law 6,404/1976. As a result of this approval, the *caput* of Article 35 of the Bylaws shall have the following wording: "**Article 35** - The Company shall have a non-permanent Fiscal Council , composed of up to five (5) sitting members and an equal number of alternates, and shall only be installed by resolution of the Shareholders' Meeting which, on the occasion, will also elect its members and set their remuneration." The Bylaws will be consolidated to reflect the approved amendment. This amendment has no effect on the election of the Fiscal Council for the 2025/2026 fiscal year held at the Annual General Meeting on this date.
5. To approve, by majority vote (3,836,637,265), with abstentions (8,852) and votes against (3,006) registered, according to the voting protocol and voting map, and without reservations, the amendment to article 11 of the Bylaws, to accommodate the regulatory adjustments promoted by the Brazilian Securities and Exchange Commission, resulting from CVM Resolution 204/2024, which amended CVM Resolution 81/2022. As a result of this approval, the *caput* and paragraph 1 of Article 11 of the Bylaws will now have the following wording: "**Article 11** - To participate and resolve in the Shareholders' Meetings, the Shareholder shall present an official identification document with photo, valid throughout the national territory. For the purpose of deliberation, changes in shareholding positions occurring on the date of the Shareholders' Meeting will be disregarded. **Paragraph 1** - The Company shall adopt, in the inspection of the documentary regularity of the shareholder's representation, the principle of good faith, and the statements it provides shall be presumed to be true. With the exception of the failure to present the power of attorney, if applicable, and the proof of custody of shares, when these are not included in the Company's records as owned by the custodian institution, no formal irregularity, such as the presentation of documents by copy, or the lack of authentication of the copies, will be grounds for impediment to the vote of the shareholder whose regularity of the documentation is doubted.". The Bylaws will be consolidated to reflect the approved amendment.

Voting: The Company also informs that it received, between 03/26/2025 and 04/25/2025, 1,347 remote voting ballots for the AGM, which were duly computed together with the votes in the other voting channels, as consolidated in the General Voting Map that accompanies these minutes, also informing that it will publish the Analytical Voting Bulletin within the legal deadline.

There being nothing more to discuss, Mr. President offered the floor to anyone who wished to make use of it and, in the absence of manifestations, closed the proceedings and asked that these minutes be drawn up, which, read and found to be in compliance, were signed by those present.
