1. Aprovar, por maioria de votos (3.769.774.687), registradas as abstenções (130.613.194) e votos contrários (967.607), e excluídos os legalmente impedidos, o Relatório da Administração, Demonstrações Financeiras, Relatório dos Auditores Independentes, Parecer do Conselho Fiscal e demais atos e documentos relativos ao exercício social encerrado em 31 de dezembro de 2025.
2. Aprovar, por maioria de votos (3.770.715.784), registradas as abstenções (130.599.804) e votos contrários (39.900), a destinação do lucro líquido do exercício 2025, colocado à disposição da Assembleia Geral, no montante de R\$ 6.376.219.321,12, mais (a) R\$ 4.076.361,12 relativo à Reversão de Dividendos de Exercícios Anteriores; (b) R\$ 11.202.744,43 relativo à realização da Reserva de Reavaliação - Custo Atribuído; totalizando R\$ 6.391.498.426,67, conforme proposto pelo Conselho de Administração, com a seguinte destinação: (a) R\$ 318.810.966,05 para Reserva Legal; (b) R\$ 3.815.750.740,20, para Dividendos e Juros sobre o Capital Próprio, já distribuídos; e (c) R\$ 2.256.936.720,42 para Financiar Reserva para Orçamento de Capital/Investimento em 2026. Aprovado também, o Orçamento de Investimentos para o ano de 2026, no montante de R\$ 4.404.771.971,26, com as seguintes fontes de recursos: R\$ 2.256.936.720,42 com

recursos próprios (Reserva para orçamento de capital) e R\$ 2.147.835.250,84 com recursos de terceiros (Financiamentos). Com a aprovação desta destinação, restam ratificadas e homologadas todas as deliberações do Conselho de Administração realizadas com base no art. 39 do Estatuto Social, sobre distribuição de Dividendos e Juros sobre o Capital Próprio, relativas ao exercício social encerrado em 31/12/2025.

2.1. A Companhia também registra, que o valor de Orçamento não compreende os valores relativos às operações de aquisições a serem eventualmente firmadas ao longo do exercício.

3.2. Aprovar, por maioria de votos (1.116.946.438), registradas as abstenções (2.777.426.047), e votos contrários (6.983.003), a caracterização da Sra. Tânia Conte Cosentino, como membro independente do Conselho de Administração.

3.3 Aprovar, por maioria de votos (3.402.378.945), registradas as abstenções (2.476.047) e votos contrários (496.500.496), com base no Art. 17 do Estatuto Social, e tendo em vista não ter sido adotado o voto múltiplo na forma do art. 141 da Lei nº 6.404/76, a eleição dos seguintes membros do Conselho de Administração da Companhia, para um mandato de 2 anos (até a Assembleia Geral Ordinária que aprovar as demonstrações financeiras do exercício de 2027), podendo ser reeleitos:

Os Conselheiros tomarão posse em até 30 dias a contar desta data, mediante a assinatura do respectivo Termo de Posse em livro próprio, no qual também constará a declaração de que, sob as penas da Lei, não estão impedidos para o exercício da administração da Sociedade, seja por lei especial ou em virtude de condenação criminal, em quaisquer dos crimes previstos nos §§ 1º e 2º do art. 147 da Lei das Sociedades por Ações; bem como a declaração de disponibilidade de tempo necessária ao cargo; de reputação ilibada; de inexistência de conflito de interesse com a Sociedade; e demais declarações que se façam necessárias. O documento ficará arquivado na sede da Companhia.

3.6. Para fins do disposto no § 2º do art. 149 da Lei nº 6.404/76, os Conselheiros eleitos indicam os endereços informados em suas respectivas qualificações, acima descritas.

4. Aprovar, por maioria de votos (3.818.282.745), registradas as abstenções (2.074.794) e votos contrários (80.997.949), a fixação da remuneração global anual dos Administradores da Companhia, para o exercício de 2026, no montante de até R\$ 154.843.000,00, sendo até R\$ 29.436.000,00 para o Conselho de Administração, e até R\$ 125.407.000,00 para a Diretoria Estatutária, assim distribuída: (a) Remuneração pela WEG S/A no montante de até R\$ 26.776.000,00, sendo até R\$ 15.344.000,00 para o Conselho de Administração, e até R\$ 11.432.000,00 para a Diretoria Estatutária; e (b) Remuneração pela controlada WEG Equipamentos Elétricos S/A, no montante de até R\$ 128.067.000,00, sendo até R\$ 14.092.000,00 para o Conselho de Administração, e até R\$ 113.975.000,00 para a Diretoria Estatutária.
5. De acordo com o mapa sintético consolidado de votação a distância, ainda que tenha sido atingido o quórum legal para a instalação do Conselho Fiscal, com votos favoráveis (116.534.030), abstenções (3.343.560.090) e votos contrários (432.872.128), não houve a apresentação de candidatos para sua composição, restando, portanto, prejudicada e sem efeitos a sua instalação, consoante a previsão do parágrafo 2º do artigo 36 da Resolução CVM 81/2022.
6. Aprovar, por maioria de votos (3.893.235.958), registradas as abstenções (8.060.260), e votos contrários (59.270) e sem ressalvas, que as publicações dos atos legais da Companhia sejam feitas nos seguintes jornais: "Correio do Povo", de Jaraguá do Sul/SC e "Valor Econômico", de São Paulo/SP.

**Votação:** A Companhia ainda informa que recebeu, entre 19/03/2026 e 19/04/2026, 1.496 boletins de voto à distância para a AGO, os quais foram devidamente computados juntamente com os votos nos demais canais de votação, conforme consolidado no Mapa Geral de Votação que acompanha a presente ata, informando ainda que publicará o Boletim Analítico de Votação no prazo legal.
