a) **EM ASSEMBLEIA GERAL ORDINÁRIA:** Votados os assuntos da pauta específica, decidiram os senhores acionistas, conforme protocolo de votos e mapa de votação:

1. Aprovar, por maioria de votos (3.634.784.905), registradas as abstenções (99.191.669) e votos contrários (1.606.371), e excluídos os legalmente impedidos, o Relatório da Administração, Demonstrações Financeiras, Relatório dos Auditores Independentes, Parecer do Conselho Fiscal e demais atos e documentos relativos ao exercício social encerrado em 31 de dezembro de 2022.
2. Aprovar, por maioria de votos (3.732.780.649), registradas as abstenções (2.802.296) e sem votos contrários, a destinação do lucro líquido do exercício 2022, colocado à disposição da Assembleia Geral, no montante de R\$ 4.208.083.625,56, mais (a) R\$ 1.012.797,48 relativo à Reversão de Dividendos de Exercícios Anteriores; (b) R\$ 18.855.103,01 relativo à realização da Reserva de Reavaliação - Custo Atribuído; e, deduzidos (c) R\$ 851.348,96 relativo ao complemento referente ao Plano de Opções de Ações; totalizando R\$ 4.227.100.177,09, conforme proposto pelo Conselho de Administração, com a seguinte destinação: (a) R\$ 210.404.181,28 para Reserva Legal; (b) R\$ 2.252.351.392,55, para Dividendos e Juros sobre o Capital Próprio, já distribuídos; e (c) R\$ 1.764.344.603,26 para Financiar Reserva para Orçamento de Capital/Investimento em 2023. Aprovado também, o Orçamento de Investimentos para o

ano de 2023, no montante de R\$ 1.608.581.501,00, com as seguintes fontes de recursos: R\$ 732.492.946,10 com redução de Capital de Giro previsto no orçamento de 2023 e R\$ 876.088.554,90 com recursos próprios (Reserva para orçamento de capital). Com a aprovação desta destinação, restam ratificadas e homologadas todas as deliberações do Conselho de Administração realizadas com base no art. 37 do Estatuto Social, sobre distribuição de Dividendos e Juros sobre o Capital Próprio, relativas ao exercício social encerrado em 31/12/2022.

2.1. A Companhia também registra, que o valor de Orçamento não compreende os valores relativos às operações de aquisições a serem eventualmente firmadas ao longo do exercício.

3. Aprovar, por maioria de votos (3.698.726.480), registradas as abstenções (1.090.427) e votos contrários (35.766.038), a fixação da remuneração global anual dos Administradores da Companhia, para o exercício de 2023, no montante de até R\$ 110.000.000,00, sendo até R\$ 19.078.000,00 para o Conselho de Administração, e até R\$ 90.922.000,00 para a Diretoria Estatutária, assim distribuída: (a) Remuneração pela WEG S/A no montante de até R\$ 18.162.000,00, sendo até R\$ 9.954.000,00 para o Conselho de Administração, e até R\$ 8.208.000,00 para a Diretoria Estatutária; e (b) Remuneração pela controlada WEG Equipamentos Elétricos S/A, no montante de até R\$ 91.838.000,00, sendo até R\$ 9.124.000,00 para o Conselho de Administração, e até R\$ 82.714.000,00 para a Diretoria Estatutária.

5.1. Os Conselheiros Fiscais tomarão posse em até 30 dias a contar desta data, mediante a assinatura do respectivo Termo de Posse em livro próprio, no qual constará também a declaração de que preenchem os requisitos previstos em lei e de que não estão impedidos

para o exercício do cargo, nos termos do artigo 162 da Lei nº 6.404/76; cujo documento ficará arquivado na sede da Companhia. Os Conselheiros Fiscais exercerão seus cargos até a primeira Assembleia Geral Ordinária que se realizar após esta data.

5. Aprovar, por maioria de votos (3.729.879.210) registradas as abstenções (4.526.735) e votos contrários (1.177.000), sem ressalvas, a remuneração individual mensal para os membros efetivos do Conselho Fiscal, no valor de R\$ 14.000,00.
6. Aprovar, por maioria de votos (3.734.628.078), registradas as abstenções (954.867), sem votos contrários e sem ressalvas, que as publicações dos atos legais da Companhia sejam feitas nos seguintes jornais: "Correio do Povo", de Jaraguá do Sul-SC e "Valor Econômico", de São Paulo-SP.

b) **EM ASSEMBLEIA GERAL EXTRAORDINÁRIA:** Votados os assuntos da pauta, decidiram os senhores acionistas, conforme protocolo de votos e mapa de votação:

1. Aprovar, por maioria de votos (3.746.354.523), registradas as abstenções (38.482) e sem votos contrários, conforme protocolo de votos e mapa de votação, e sem ressalvas, a proposta do Conselho de Administração tratando de alterações no Estatuto Social (Parágrafos 2º, 6º e 7º do Artigo 17 e parágrafo 4º do artigo 36), para acomodar ajustes relacionados ao Regulamento do Novo Mercado, bem como, para ampliar as hipóteses de vedação da possibilidade de acumulação de cargos entre membros do Conselho de Administração e demais membros da Administração da Companhia. Em consequência desta aprovação, os referidos parágrafos dos artigos 17 e 36 do Estatuto Social passarão a contar com a seguinte redação:

"Artigo 17 - O Conselho de Administração é composto por, no mínimo 5 (cinco) e, no máximo, 10 (dez) membros, todos eleitos e destituíveis pela Assembleia Geral, com mandato unificado de 2 (dois) anos, sendo permitida a reeleição.

§ 1º - Dos membros do Conselho de Administração, no mínimo 2 (dois) ou 20% (vinte por cento), o que for maior, deverão ser conselheiros independentes, conforme a definição no Regulamento do Novo Mercado, devendo a caracterização dos indicados ao conselho de administração como conselheiros independentes ser deliberada na assembleia geral que os eleger. Considera-se Conselheiro Independente, para fins deste Estatuto Social, aquele que atende o disposto no Regulamento do Novo Mercado da B3, bem como o conselheiro eleito mediante faculdade prevista no § 4º do art. 141 da Lei nº 6.404/76 na hipótese de haver acionista controlador.

§ 2º - Quando, em decorrência do cálculo do percentual referido no parágrafo anterior, o resultado gerar um número fracionário, proceder-se-á ao arredondamento para o número inteiro imediatamente superior.

§ 3º - Se não for solicitado o processo de voto múltiplo, na forma da lei, a Assembleia deverá votar através de chapas registradas nos termos dos incisos deste parágrafo e seguintes, vedada a votação individual em candidatos.

I - Para concorrer à eleição para o Conselho de Administração, deverá ser formada uma ou mais chapas, e a Administração da Companhia deverá divulgar as informações sobre os candidatos que compõem a(s) chapa(s), nos termos das normas legais e regulamentares aplicáveis.

II - É facultado a qualquer acionista, ou conjunto de acionistas, propor outra chapa para o Conselho de Administração, sendo vedada, no entanto, a apresentação de mais de uma chapa pelo mesmo acionista ou Grupo de Acionistas, observadas ainda as normas legais e regulamentares aplicáveis.

III - As chapas deverão ser compostas pelo número de membros correspondentes às vagas disponíveis, devendo um membro ser apontado como provisório, o qual somente poderá tomar posse no caso de não ser requerido e eleito um membro nos termos do § 4º e § 5º do art. 141 da Lei nº 6.404/76, quando aplicável.

IV - Cada acionista somente poderá votar em uma chapa, e será declarada eleita a chapa que receber maior número de votos na Assembleia Geral.

§ 4º - Caso venha a ser solicitado o procedimento de eleição previsto nos §§ 4º e 5º do art. 141 da Lei nº 6.404/76, quando aplicável, este procedimento precederá a eleição por chapa de que tratam os incisos do parágrafo anterior, procedendo-se em seguida a

eleição por chapa referida nos mencionados incisos. Na hipótese dos minoritários elegerem seu representante para o Conselho, este assumirá uma das vagas, ficando sem efeito o nome indicado na chapa como membro provisório.

§ 5º - A Assembleia Geral que eleger os membros do Conselho de Administração indicará, entre eles, o Presidente e o Vice-Presidente do Conselho de Administração.

§ 6º - Os Conselheiros serão investidos nos seus cargos mediante assinatura de termo de posse no Livro de Atas do Conselho de Administração, o qual deverá contemplar sua sujeição à cláusula compromissória referida no artigo 41, bem como deverão atender os demais requisitos legais.

§ 7º - Os cargos do Conselho de Administração não poderão ser acumulados pelo Diretor Presidente Executivo, pelos Diretores estatutários, bem como pelos executivos da Companhia e/ou das suas Controladas.

Artigo 36 - *O Conselho Fiscal deliberará pela maioria de seus membros, e as suas reuniões somente se instalarão se presente a maioria dos seus membros.*

§ 1º - O Conselho Fiscal reunir-se-á trimestralmente, ou quando convocado por escrito, por qualquer de seus membros, com antecedência de 5 (cinco) dias da reunião.

§ 2º - As reuniões poderão ser realizadas através de teleconferência, videoconferência ou qualquer outro meio eletrônico ou tecnologicamente disponível. Os membros do Conselho Fiscal poderão expressar seu voto em tal reunião através de carta, declaração ou mensagem encaminhada à Companhia, anteriormente ou durante a realização da reunião, por fax, correio eletrônico ou qualquer outro meio eletrônico ou tecnologicamente disponível. O membro do Conselho Fiscal, agindo conforme disposto acima, será considerado presente à reunião, e seu voto será considerado válido para todos os efeitos legais e incorporado à ata da referida reunião.

§ 3º - Das reuniões do Conselho Fiscal lavrar-se-ão atas, em livro próprio, que ficará disponível aos acionistas na sede da Companhia.

§ 4º - Os membros do Conselho Fiscal serão investidos nos seus cargos mediante a assinatura de termo de posse no Livro de Atas de Reuniões do Conselho Fiscal, o qual deverá contemplar sua sujeição à cláusula compromissória referida no artigo 41, bem como deverão atender os demais requisitos legais."

2. Aprovar, por maioria de votos (3.746.354.523), registradas as abstenções (38.482) e sem votos contrários, conforme protocolo de votos e mapa de votação, e sem ressalvas, a consolidação do Estatuto Social para comportar as deliberações aprovadas pela Assembleia em relação aos tópicos anteriores.

Votação: A Companhia ainda informa que recebeu, entre 22/03/2023 e 18/04/2023, 973 boletins de voto à distância para a AGOE, os quais foram devidamente computados juntamente com os votos nos demais canais de votação, conforme consolidado no Mapa Geral de Votação que acompanha a presente ata, informando ainda que publicará o Boletim Analítico de Votação no prazo legal.

Nada mais havendo a tratar, o Senhor Presidente ofereceu a palavra a quem quisesse fazer uso e, ante a ausência de manifestações, encerrou os trabalhos e pediu que fosse lavrada esta ata que, lida e achada conforme, foi assinada pelos presentes.
