EM ASSEMBLEIA GERAL EXTRAORDINÁRIA: Abertos os trabalhos, o Senhor Presidente informou que as regras de transição sobre a tributação do Imposto de Renda das Pessoas Físicas sobre dividendos, tal como previstas na Lei 15.270/25, seguem vigentes conforme originalmente promulgadas e, portanto, acomodando a proposta da Administração para votação, nesta data, pela Assembleia Geral Extraordinária.

Dando continuidade, após votado o assunto único da pauta, decidiram os senhores acionistas:

1. Aprovar, por maioria de votos (3.690.288.923), registradas as abstenções (9.991.162) e votos contrários (8.677), conforme protocolo de votos e mapa de votação, e sem ressalvas, a constituição e pagamento de dividendos calculados sobre o saldo das Reservas de Lucros, no montante de R\$ 5.196.348.565,12, a serem pagas em três parcelas anuais, em agosto de 2026, 2027 e 2028, registradas no Patrimônio Líquido das Demonstrações Financeiras Intermediárias, divulgadas e auditadas, em 30 de setembro de 2025.

O pagamento será realizado em moeda corrente nacional, da seguinte forma:

- A primeira parcela, no valor de R\$ 1.732.116.188,37, será paga em 12/08/2026, correspondendo a R\$ 0,412831673 por ação;
- A segunda parcela, no valor de R\$ 1.732.116.188,37, será paga em 11/08/2027, correspondendo a R\$ 0,412831673 por ação;
- A terceira e última parcela, no valor de R\$ 1.732.116.188,38, será paga em 16/08/2028, correspondendo a R\$ 0,412831673 por ação.

O total dos dividendos distribuídos será de R\$ 5.196.348.565,12, equivalendo a R\$ 1,238495019 por ação. Terão direito aos dividendos os acionistas detentores de ações na



data de 19/12/2025, sendo que, a partir de 22/12/2025, as ações passarão a ser negociadas "ex-dividendos".

Votação: A Companhia ainda informa que recebeu, entre 28/11/2025 e 15/12/2025, 2.024 boletins de voto à distância para a AGE, os quais foram devidamente computados juntamente com os votos nos demais canais de votação, conforme consolidado no Mapa Geral de Votação que acompanha a presente ata, informando ainda que publicará o Boletim Analítico de Votação no prazo legal.

Nada mais havendo a tratar, o Senhor Presidente ofereceu a palavra a quem quisesse fazer uso e, ante a ausência de manifestações, encerrou os trabalhos e pediu que fosse lavrada esta ata que, lida e achada conforme, foi assinada pelos presentes.
