MATERIAL FACT AND NOTICE TO SHAREHOLDERS APPROVAL OF THE CAPITAL INCREASE

3R PETROLEUM OIL AND GAS S.A. ("<u>3R</u>" or "<u>Company</u>") (B3: RRRP3) hereby informs its investors and the general market that the Board of Directors of the Company, in a meeting held on the present date, has approved the full capital increase, within the limit of the authorized capital, through the issuance of ordinary shares, for private subscription, approved in a meeting of the Board of Directors of the company held on April 12, 2023, and the subject of a Relevant Fact and Notice to Shareholders on April 16, 2023, May 24, 2023, and June 2, 2023 ("<u>Capital Increase</u>").

1. Result of the Capital Increase. Concluded on June 6, 2023 the allocation of Additional Leftover Shares under the Capital Increase, the Company informs that 36,809,815 (thirty-six million, eight hundred and nine thousand, eight hundred and fifteen) shares were effectively subscribed and fully paid, representing 100% of the total shares subject to the Capital Increase, at the issuance price of R\$24.45 (twenty-four reais and forty-five cents) per share, totaling an investment of R\$899,999,976.75 (eight hundred and ninety-nine million, nine hundred and ninety-nine thousand, nine hundred and seventy-six reais and seventy-five centavos).

2. Ratification of the Capital Increase. Due to the full ratification of the Capital Increase by the Board of Directors on the present date, the Company's share capital has increased <u>from</u> 4,154,405,602.52 (four billion, one hundred and fifty-four million, four hundred and five thousand, six hundred and two reais and fifty-two centavos), fully subscribed and paid-up, divided into 203,087,632 (two hundred and three million, eighty-seven thousand, six hundred and thirty-two) ordinary shares, all registered, book-entry, and without par value, to R\$5,054,405,579.27 (five billion, fifty-four million, four hundred and five thousand, five hundred and seventy-nine dollars and twenty-seven cents), fully subscribed and paid-up, divided into 239,897,447 (two hundred and thirty-nine million, eight hundred and ninety-seven thousand, four hundred and forty-seven) ordinary shares, all registered, book-entry, and without par value.

3. Crediting and Trading of Shares. The trading of the shares subject to the Capital Increase on B3 S.A. - Brasil, Bolsa, Balcão will commence from June 12, 2023, inclusive. The subscribed shares should be visible in the statements of their respective subscribers from the 3rd (third) business day after the full ratification of the Capital Increase by the Board of Directors.
