2. WHY DO WE USE COOKIES?

Cookies are small text files stored in your browser's directory that allow us to understand the actions of users on our Portals and their preferences, in order to offer an increasingly personalized service, improving your browsing experience with content navigation experience with the most relevant content for each user.

Furthermore, most browsers are structured to collect and store cookies. However, you may set your browser to refuse certain types of cookies or to refuse specific cookies, where applicable. In addition, it is also possible for users to delete the cookies stored in their browser at any time.

The user is free to choose which types of cookies he accepts or not. 3R only uses the necessary cookies mentioned below. Therefore, the user may delete cookies from his browser following item 4 below.

3. WHAT TYPES OF COOKIES DO WE USE?

3R only uses its own cookies on its Portals, that is, the Portals do not use third party cookies. We provide below the cookies currently used on the Portals:

3.1 NECESSARY COOKIES

Necessary cookies are essential to enable the user to browse the Portals and use their features, such as accessing secure areas of the Portals. Without these cookies, services that the user

requested cannot be provided, and therefore the use of these cookies does not depend on the user's consent.

The personal data collected through the necessary cookies will be kept as the rules outlined in the Privacy and Data Protection Policy.

4. HOW CAN I MANAGE COOKIES?

The user can manage, disable, and delete all cookies used in their browser. However, if your browser settings are used to block all cookies (including strictly necessary cookies), the user will not be able to access all or part of the 3R Portals.
