Coordinated the Banco Nossa Caixa integration team after the acquisition by BB. He is currently Special Secretary for Social Development at the Ministry of Citizenship, where he also served as an executive secretary in 2020. He served in the Civil House as deputy chief of Analysis and Monitoring of Government Policies and Deputy Chief of Articulation and Monitoring from 2019 to 2020. Among his experiences at the board of directors, it is highlighted BNDES and Terracap, in addition to the supervisory board of BASA and Brasilprev.
- Renato Luiz Bellinetti Naegele is an agronomist, with specializations in Modern Economics and Executive Management. BB employee building his career from 1982 to 2015, and having served as Executive Manager of Business with the Public Sector, Head of Technical Consultancy for the Presidency, and Managing Director of Marketing and Communication. Abroad, he was Senior Executive Vice President of Banco Patagonia and General Manager of BB in Chile. He served as a board member on several boards of directors in Brazil and abroad. He was partner-director of Macroplan, in addition to having served in the federal government (1987 to 1996) and in the Federal Senate (2016 to 2018). He is currently a Special Advisor to the President of BB.
- Marcelo Cavalcante de Oliveira Lima has a degree in Electronic Engineering with an emphasis on Computing. Post-graduate in Object-Oriented Systems, in Strategic Administration of Information Systems and Advanced Business Management; BB career employee from 1988 to 2019, having served as financial administrative director of BB Tecnologia e Serviços, as technology manager abroad for Europe, Middle East, and Africa, based in London from 2009 to 2015. He was Executive Manager on the Board of Technology in the period from 2003 to 2009. Previously, since 1990 he worked in several positions in the technology area of Banco do Brasil.
