



INFORMATION TO THE MARKET

Banco do Brasil S.A. ("BB", the "Bank" or the "Company") hereby informs that the submission to the Board of Directors of proposed Executive Board Changes has been carried out, prioritizing the rotation of executives currently in office across different areas of the Company. The appointments were made in strict compliance with Specific Policy on Appointment and Succession and with the executive development program, conducted with the support of specialized external advisory services, taking into consideration the Bank's digital acceleration process, its strategic and business guidelines, as well as the experience, qualifications and technical capacity of its executive management, as follows:

- I. **Alan Carlos Guedes de Oliveira** - he has worked at Banco do Brasil for over 25 years in his most recent term as the position of Risks Management Officer, has been appointed as Credit Officer.
- II. **Bárbara dos Santos Lopes Freitas** - she has worked at Banco do Brasil for over 25 years, has served as the position of Head of the Customer Service and Physical and Digital Channels Unit since April 2023, has been appointed for the position of Payment Methods Officer.
- III. **Barbara Favero dos Santos Bosi** - she has worked at Banco do Brasil for over 25 years, has served as the position of Executive Manager of the Finance Office since April 2024, has been appointed as Finance Director.
- IV. **Bruno Alves do Nascimento** - he has worked at BB for over 26 years years, has served as the position of Technology, Portfolio, and AI Officer at BB Seguridade since September 2021 and has been appointed as Operations Officer.
- V. **Carlos Eduardo Guedes Pinto** - he has worked at Banco do Brasil for over 26 years in his most recent term as the position of Supplies, Infrastructure and Property Officer, has been appointed as Entrepreneurship SME's Businesses Officer.
- VI. **João Vagnes de Moura Silva** - he has worked at Banco do Brasil for over 28 years in his most recent term as the position of Finance Officer, has been appointed as Risks Management Officer.
- VII. **Larissa da Silva Novais Vieira** - she has worked at BB for over 25 years years in his most recent term as the position of Retail Business Officer (Individuals), has been appointed as Marketing and Communication Officer.
- VIII. **Marcelo Henrique Gomes da Silva** - He has worked at Banco do Brasil for over 25 years in his most recent term as the position of Entrepreneurship SME's Businesses Officer, has been appointed as Retail Business Officer (Individuals).
- IX. **Neudson Peres de Freitas** - he has worked at Banco do Brasil for 26 years in his most recent term as the position of Operations Officer, has been appointed as Strategy and Organization Officer.
- X. **Pedro Bramont** - he has worked at Banco do Brasil for over 17 years in his most recent term as the position of Payment Methods Officer, has been appointed as Digital Businesses Officer.
