O Sistema Eletrônico disponibilizado pela Companhia para participação a distância na Assembleia Geral Extraordinária dos Acionistas do BB ("Assembleia") atende aos requisitos previstos no art. 28 da Resolução CVM nº 81/2022.

MESA, PRESENÇA E QUORUM

Os trabalhos foram dirigidos em conformidade com o art. 9º, §2º, do Estatuto Social do BB, pela Presidente do Conselho de Administração, Sra. Anelize Lenzi Ruas de Almeida ("Presidente"), a qual, ao instalar a Assembleia, convidou para compor a Mesa:

- a) a Diretora Jurídica da Companhia, Dra. Lucinéia Possar, para atuar como Primeira Secretária;
- b) o acionista Dr. Leonardo Elisei de Faria, para atuar como Segundo Secretário; e
- c) a Dra. Luciana Cortez Roriz Pontes, representante da União, acionista controlador do Banco do Brasil.

Participaram remotamente, via Sistema Eletrônico, conforme disposto nos arts. 134, §1º, e 164 da Lei 6.404/1976; no art. 28, §5º, da Resolução CVM nº 81/2022; e no art. 43, parágrafo único, do Estatuto Social do BB, respectivamente:

- a) o Sr. Luiz Carlos Oseliero Filho, representante da Deloitte Touche Tohmatsu, Auditoria Independente; e
- b) o Sr. Fernando Florêncio Campos, representante do Conselho Fiscal.

O número de acionistas que participaram remotamente, por si ou por procuração, e aqueles que manifestaram seu voto a distância, foi de 987 (novecentos e oitenta e sete) acionistas, possuidores de 2.180.600.491 (dois bilhões, cento e oitenta milhões, seiscentos mil, quatrocentos e noventa e uma) ações ordinárias, que representam 76,4% do total de 2.865.417.020 (dois bilhões, oitocentos e sessenta e cinco milhões, quatrocentos e dezessete mil e vinte) ações ordinárias, deduzidas as ações mantidas em tesouraria, observadas as prescrições legais.

A Companhia registrou o recebimento, entre 05.07.2023 e 28.07.2023, de 964 (novecentos e sessenta e quatro) votos a distância, que foram devidamente computados, conforme se verifica no Mapa Final de Votação (Anexo 1) publicado na página de Relações com Investidores do BB (<https://ri.bb.com.br/>).

a) a participação por meio de sistema eletrônico ocorrerá mediante credenciamento prévio realizado em até 2 (dois) dias antes da data de realização da Assembleia, ou seja, até 02.08.2023, consoante o disposto na Resolução CVM nº 81/2022, artigo 6º, §3º;

b) o acionista, por si ou por seu procurador, deverá, dentro do prazo acima descrito, acessar o site www.bb.com.br/ri para se credenciar e enviar a seguinte documentação:

- i. **Acionista** - documento de identidade e, no caso de titulares de ações escriturais ou em custódia, comprovante expedido pela instituição financeira depositária. Serão aceitos os seguintes documentos de identidade, desde que com foto: Carteira ou Cédula de Identidade, Registro Nacional de Estrangeiro - RNE, Carteira Nacional de Habilitação - CNH, Passaporte ou Carteira de Identidade Profissional expedida pelos conselhos de profissionais liberais ou entidades congêneres;
- ii. **Procurador** - o acionista deverá autorizar legalmente um representante para votar, segundo suas intenções de voto, conforme modelo de procuração disponibilizado no Manual do Acionista do Banco do Brasil, cuja regularidade será examinada previamente;

c) o acesso à Assembleia será restrito aos acionistas e seus representantes ou procuradores que se credenciarem no prazo e modo fixados neste Edital de Convocação;

d) o envio de boletins de voto a distância por meio da B3 – Brasil, Bolsa, Balcão S.A. dispensa a necessidade de credenciamento prévio do acionista. Para participação na modalidade de voto a distância, o preenchimento e envio do boletim deverá ser realizado até o dia 28.07.2023 (inclusive): 1) aos agentes de custódia que prestem esse serviço, no caso dos acionistas titulares de ações depositadas em depositário central; ou 2) ao escriturador das ações da Companhia ou, ainda, 3) diretamente à Companhia, por correio postal ou eletrônico. Para informações adicionais, observar as regras previstas na Resolução CVM nº 81/2022 e os procedimentos descritos no boletim de voto a distância;

e) para a Assembleia ora convocada não será necessário o reconhecimento de firma nas procurações outorgadas pelos acionistas aos seus representantes ou procuradores, assim como será dispensada a autenticação dos documentos que acompanharem o boletim de voto a distância.
