**NOTICE TO THE MARKET**

Votorantim Cimentos S.A. (the "Company"), a privately held company, issuer of securities admitted to trading under the terms of article 14 of CVM Instruction No. 476/09, informs, pursuant to Resolution CVM 44/2021, the results of the tender offer for cash (the "Tender Offer") to purchase its 7.25% Senior Notes due 2041 (CUSIP 92911QAA5; P98088AA8 / ISIN US92911QAA58; USP98088AA83) (the "2041 Notes"), issued by Votorantim Cimentos International S.A. ("VCI"), a wholly owned subsidiary of the Company and outstanding in the international market ("Tender Offer") in the amount of up to US\$ 200,000,000.00 aggregate principal amount, including premium.

Under the Tender Offer's terms and conditions, VCI was assured an option to increase the aggregate principal amount and, on May 26, 2022 (early tender date), received and accepted valid offers in the aggregate principal amount, including premium, of US\$ 221,789,219.05 of the 2041 Notes (36% of the 2041 Notes principal outstanding amount have been repurchased).

Following the settlement of the 2041 Notes (early settlement), which is expected to occur on June 1, 2022, VCI will remain with principal outstanding amount of US\$ 351,394,000.00 of the 2041 Notes. This transaction is in line with the Company's liability management strategy.

Although the final settlement date for the Tender Offer is scheduled to occur on June 10, 2022, upon reaching the maximum aggregate repurchase amount, VCI will be able to decide to not accept purchase tenders of the Notes following the early tender date.

The Company reiterates its commitment to financial discipline and transparency to the market.
