CONVOCAÇÃO: Edital de convocação publicado nos dias 11, 12 e 15 de novembro de 2022 no jornal Valor Econômico (fls. C5, B8 e B6, respectivamente), com divulgação simultânea na página do mesmo jornal na internet, em conformidade com o disposto na Lei nº 6.404/76 (“Lei das S.A.”).

PRESENÇA: Presentes acionistas representando mais de 67,75% (sessenta e sete virgula setenta e cinco por cento) do capital social votante da Companhia, conforme se verifica (i) pelas presenças registradas por meio da plataforma eletrônica disponibilizada pela Companhia, nos termos da RCVM 81, e (ii) pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia e diretamente pela Companhia, nos termos da regulamentação da CVM. Presentes, ainda, integrantes da Administração da Companhia, além do Sr. André Coji, Coordenador do Conselho Fiscal da Companhia e do Sr. Daniel Cifu, representante da KPMG Corporate Finance Ltda., responsável pela elaboração do laudo de avaliação para fins do artigo 256 da Lei das S.A., que constou da proposta da administração para a Assembleia (“Laudo de Avaliação”).

ORDEM DO DIA: Deliberar sobre a aquisição pela Companhia, nos termos do §1º do artigo 256 da Lei das S.A., de forma direta, da totalidade das quotas representativas do capital social de Neuroanalítica Participações Ltda., sociedade limitada inscrita no CNPJ/ME sob o nº 16.704.445/0001-92 (“Neuroanalítica”) e da totalidade das ações de emissão de Neuropar Participações S.A., sociedade por ações inscrita no CNPJ/ME sob o nº 17.449.107/0001-14 (“Neuropar” e, em conjunto com a Neuroanalítica, as “Holdings”), com a consequente aquisição, de forma indireta, por meio da participação nas Holdings, da totalidade das ações de emissão de Neurotech Tecnologia da Informação S.A.,

sociedade por ações inscrita no CNPJ/ME sob o nº 05.359.081/0001-34 (“Neurotech”), conforme documentos definitivos da operação assinados e demais materiais submetidos à Assembleia, bem como a ratificação dos atos correspondentes praticados pela Administração até a Assembleia.

DELIBERAÇÕES: Feita a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, conforme o disposto na RCV 81, foram tomadas as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta a Lei das S.A.:

Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 3.919.256.401 votos a favor, nenhum voto contrário, e 3.787.910 abstenções, a aquisição pela Companhia, nos termos do §1º do artigo 256 da Lei das S.A., de forma direta, da totalidade das quotas representativas do capital social de Neuroanalítica e da totalidade das ações de emissão de Neuropar (em conjunto, “Holdings”), com a consequente aquisição, de forma indireta, por meio da participação nas Holdings, da totalidade das ações de emissão de Neurotech, conforme documentos definitivos da operação assinados e demais materiais submetidos à Assembleia, bem como a ratificação dos atos correspondentes praticados pela Administração até esta Assembleia. Apesar de o preço de aquisição por ação da Neurotech e de cada uma das Holdings atingir os critérios previstos no inciso II, alínea (c), do artigo 256 da Lei das S.A., conforme verifica-se no Laudo de Avaliação, não haverá direito de retirada para os acionistas dissidentes da deliberação desta Assembleia, tendo em vista a liquidez e a dispersão das ações de emissão da Companhia, nos termos do art. 137, II, alíneas (a) e (b), combinado com o §2º do artigo 256, da Lei das S.A.

ENCERRAMENTO: Nada mais havendo a tratar, a presente ata foi lavrada, e, depois de lida e aprovada, foi considerada assinada pelos acionistas cujo boletim de voto a distância foi considerado válido pela Companhia e pelos acionistas que registraram a sua presença por meio da plataforma eletrônica disponibilizada pela Companhia, nos termos da RCV 81.
