## MINUTES OF THE ANNUAL AND EXTRAORDINARY MEETING HELD ON APRIL 24th, 2025.

**DATE, TIME AND PLACE:** On April 24<sup>th</sup>, 2025, at 11:00 am (BRT), exclusively in digital format, through Microsoft Teams electronic platform, pursuant to the Brazilian Securities and Exchange Commission (CVM) Resolution No. 81 of March 29<sup>th</sup>, 2022 ("RCVM 81"), being considered as held at the Company's headquarter, at Praça Antonio Prado, No. 48, 7<sup>th</sup> floor, Centro, in the city of São Paulo, State of São Paulo Zip Code 01010-901.

**CALL NOTICE:** Call Notice published on March 25<sup>th</sup>, 26<sup>th</sup>, 27<sup>th</sup>, 2025 in the newspaper "Valor Econômico" (pages E9, E4 and E13, respectively) and simultaneous publication on the same newspaper's website, as according to the Law No. 6.404/76 (Brazilian Corporation Law.").

ATTENDENCE: Were attend, at the Annual Shareholders' Meeting, shareholders representing 65,22% (sixty-five point twenty-two percent) of the Company's voting capital stock, and the Extraordinary Shareholders Meeting, shareholders representing 70,30% (seventy point thirty per cent) of the Company's voting capital stock, as verified (i) by the attendances registered through the electronic platform available by the Company, pursuant to RCVM 81, and (ii) by the valid remote voting form received through the Central Depository of B3, from the bookkeeping agent of the shares issued by the Company, by the shareholder's custody agent and directly by the Company, pursuant to CVM regulations. Due the verified quorum, the Chairman installed the Annual Shareholder's Meeting and the Extraordinary Shareholders' Meeting. Also present were members of the Company's Management, the representative of Deloitte Touche Tohmatsu Auditores Independentes, Mr. Rafael Scatena, the Coordinator of the Audit Committee, Ms. Cristina Anne Betts and the Coordinator of the Fiscal Council, Mr. André Coji.

**BOARD:** Mr. Caio Ibrahim David - Chairman; e Mr. Gilson Finkelsztain – Secretary.

**AGENDA:** I – At the Annual Shareholders' Meeting: (1) Resolve on the management accounts and the Financial Statements for the fiscal year ended on December 31<sup>st</sup>, 2024; (2) Resolve the allocation of net income for the fiscal year ended on December 31<sup>st</sup>, 2024; (3)

define that, for the 2025/2027 term, the Board of Directors shall be composed of eleven (11) members; (4) Elect the members of the Board of Directors, as detailed in the Management Proposal; (5) Fix the limit for the annual global compensation of the management for the fiscal year of 2025, as detailed in the Management Proposal; (6) In the event of a valid request for opening of the Fiscal Council, to define that the body shall be composed of 3 regular members and an equal number of alternates, and to elect its respective effective and alternates; and (7) In the event of an election of the Fiscal Council, to fix its compensation for the fiscal year of 2025, pursuant the Management Proposal. **II – At the Extraordinary Shareholders' Meeting**: (1) To resolve by amendments to the B3 Bylaws, as detailed on the Management Proposal; (2) To restate the Company's Bylaws to reflect the respective amendments; and (3) To resolve proposals to amend the Company's Stock Granting Plan, as detailed in the Management Proposal.

**RESOLUTIONS:** Waived the reading of the consolidated voting map of votes cast through remote voting forms, which was available for consultation by the shareholders present, in accordance with the provisions of RCVM 81, the following resolutions were taken, having authorized the drawing up of these minutes in the form of a summary and their publication with the omission of the signatures of the shareholders, as permitted by the Brazilian Corporation Law.

## I – At Annual Shareholders' Meeting:

- (1) Approve, by majority of the shareholders present, with 2,983,028,509 votes in favor 3,266,549 votes against; and 411,377,998 abstentions (registered the abstention of vote of the members of the Company's Management.) without reservations, the management accounts and the Financial Statements for the fiscal year ended December 31<sup>st</sup>, 2024, accompanied by the Notes, the Opinion of Deloitte Touche Tohmatsu Auditores Independentes, the Audit Committee Report and the Fiscal Council's Opinion.
- (2) Approve, by majority by the present shareholders, with 3,335,333,666 in favor 2,420 votes against; and 62,336,970 abstentions, the following proposal for allocation of income for the fiscal year ended December 31<sup>st</sup>, 2024: (i) BRL228,829,104.80 to the legal reserve; (ii) BRL1,615,650,000.00 to the shareholders of the Company, as dividends or as interest on equity, already paid to shareholders throughout the fiscal year 2024, based on Article 57 of the Company's Bylaw; and (iii) BRL2,777,520,087.64 to the statutory reserve, pursuant to Article 56, §1, "ii" of the Company's Bylaws.
- (3) Approve, by majority by the present shareholders, with 3,334,834,513 in favor 490,602 votes against; and 62,347,941 abstentions, that the Board of Director shall be composed of eleven (11) members for the 2025/2027 term.

The members of the Board of Directors elected herein will take office upon presentation of: (i) the respective instrument of investiture, drawn up in the proper book, containing statements in compliance with the law and regulations in force; (ii) the declaration of disqualification, for the purposes of the Brazilian Corporation Law and CVM Resolution 80/22; and (iii) declaration of the securities held by them issued by the Company and its controlled companies or those of the same group, under the terms of the Brazilian Corporation Law and CVM Resolution 44/21.

- (5) Approve, by majority by the present shareholders, with 3,175,791,094 in favor 150,105,471 votes against; and 71,776,491 abstentions, setting of the annual global compensation of the Company's managers, for the current year, in the amount of up to BRL168,300,831.00, pursuant to the Management Proposal.
- (5) Register the installation of the Fiscal Council, requested by shareholders holding shares representing 60,72% (sixty point seventy-two per cent) of the voting and total capital stock of the Company, e approve by majority by the present shareholders, with 3,315,166,978 in favor 400,719 votes against; and 82,105,359 abstentions, the definition that the Fiscal Council of the Company will be composed by three (3) effective and alternate in same number and approve the election of the following persons to compose the Company's Fiscal Council, for a term of office until the Annual General Meeting that approves the financial statements for the year ending December 31st, 2025: (i) ANDRÉ COJI, Brazilian, married, business administrator,

It was recorded the presentation, by the elected members of the Fiscal Council, of the documents proving the fulfillment of the eligibility conditions provided for in Article 162 of the Brazilian Corporation Law.

(7) Approve, by majority by the present shareholders, with 3,315,915,651 in favor 6,542,115 votes against; and 75,215,290 abstentions setting the remuneration of the members of the Company's Fiscal Council for the current year, in the amount of up to BRL669,211.20, pursuant to the Management Proposal.

## II – At Extraordinary General Meeting:

- (1) By the votes indicated below, amend the Company's Bylaws, as follows:
- (1.a) Approve, by majority by the present shareholders, with 3,594,713,757 in favor 3,213,977 votes against; and 64,282,643 abstentions, the **Block A** of bylaws amendments, i.e <u>Corporate purpose A.1.</u> To include the activities of bookkeeping of trade bills through the electronic bookkeeping system (item "VI" of Article 3). The Company clarifies that the detailing of the proposed corporate purpose in "Block A" above does not modify its business segment and its predominant activities, representing only an addition of complementary or integrated activities to those already developed by the Company, compatible with its objectives and, therefore, if approved, will not entitle shareholders to withdrawal rights under articles 136, item VI, and 137, item I, of Law No. 6,404/76.
- (1.b) Approve, by majority by the present shareholders, with 3,597,927,345 in favor 1,014 votes against; and 64,282,01 abstentions, the **Bloco B** of bylaws amendments, i.e <u>Capital Stock.</u> **B.1.** To amend the value of the capital stock and the number of shares composing it to reflect (i) the increase of the capital stock in the amount of BRL 350,000,000.00 through capitalization approved by the Board of Directors on May 9, 2024, increasing the capital stock from BRL12,548,655,563.88 to BRL12,898,655,563.88; and (ii) the cancellations of shares approved by the Board of Directors on May 9<sup>th</sup>, 2024, September 19<sup>th</sup>, 2024 and March 20<sup>th</sup>, 2025, reducing the number of shares of the capital stock from 5,646,500,000 to 5,266,500,000 ordinary shares (Article 5, "caput"). **B.2.** To explicitly include that, in cases of capital increase

within the limit of authorized capital through capitalization of profits or reserves, there may or may not be the issuance of new shares by the Company (§2 of Article 8).

- (1.c) Approve, by majority by the present shareholders, with 3,597,924,263 in favor 234 votes against; and 64,285,880 abstentions, the **Block C** of bylaws amendments, i.e <u>Competence of Shareholders' Meeting.</u> C.1. To adjust the competence of the General Shareholders' Meeting regarding the approval of corporate reorganization operations to also include operations in which the Company is the acquiring entity (item "j" of Article 16).
- (1.d) Approve, by majority by the present shareholders, with 3,597,900,257 in favor 632 votes against; and 64,309,488 abstentions, the **Block D** of bylaws amendments, i.e – Competence of the Board of Directors. **D.1.** To separate the competences to (i) set the general direction of the Company's business, and (ii) approve and amend the Company's annual budget and determine the business goals and strategy for the subsequent period (amendment of item "a" and creation of item "b" of Article 29). **D.2**. To explicitly include the competence to approve the granting of guarantees to entities in which the Company participates as a founder or maintainer (item "j" of Article 29). **D.3**. To adjust the competence to approve the negotiation by the Company of its own issued shares or derivatives referenced in its issued shares to the wording of CVM Resolution No. 77/2015 (item "m" of Article 29). D.4. To clarify that it is the competence of the Board of Directors to appoint the members of any committees it may establish (item "r" of Article 29) **D.5.** To remove the qualified quorum requirement for (i) change the composition of the Products and Pricing Committee, now observing the quorum of the majority of members present at the meeting, with the casting vote of the Chairman of the Board of Directors (removal of §2 of Article 29), and (ii) to amend the Over-the-Counter Business Guidelines and the Credit Support Transactions or the Product and Service Price Guideline (removal of the sole paragraph of Article 30). **D.6.** To remove the competence for approving regulations related to (i) the Company's clearing and settlement chambers and their systems, and (ii) the activities of operations registration and centralized deposit of securities and financial assets, transferring the approval to the Board of Officers (removal of items "d" and "e" of Article 30). D.7. To remove the competence for establishing penalties that may be applied in cases of infractions to the rules approved by the Board of Directors, as such penalties are already established in the respective regulations approved by the Board of Directors (removal of item "h" of Article 30).
- (1.e) Approve, by majority by the present shareholders, with 3,597,900,769 in favor 229 votes against; and 64,309,379 abstentions, the **Block E** of bylaws amendments, i.e Competence of the Board Officers. **E.1**. To provide for the need for prior authorization from the Board of Officers for other forms of disposal of permanent assets and specify that the competence specifically refers to the granting of guarantees in favor of the Company's subsidiaries (item "e" of Article 37). **E.2**. To remove the duplication of the competence regarding the provision of guarantees by the Company, which was addressed in two separate items (item "f" of Article 37). **E.3**. To replace the previous nomenclature of 'external regulations' with the one used in other regulations issued by the Company regarding the operation of the markets its managers (items "g" and "h" of Article 37). **E.4**. To formalize the possibility of delegating some of the competencies of the Board of Officers to the officers themselves through regulations, as well as rules, standards, and operational procedures applicable to holders of Access Authorization (items "e", "g", "h", "m", "n", and "q" of Art. 37 and inclusion of §4 of Article. 37)
- (1.f) Approve, by majority by the present shareholders, with 3,597,922.163 in favor 871 votes against; and 64,287,343 abstentions, the **Block F** of bylaws amendments, i.e <u>Fiscal Council.</u>

- **F.1**. To set the number of members of the Fiscal Council at three, to streamline the structure considering that the Company currently has no controlling shareholder or preferred shares issued (Article 54).
- (1.g) Approve, by majority by the present shareholders, with 3,597,898,824 in favor 23,051 votes against; and 64,288,502 abstentions, o **Block G** of bylaws amendments, i.e <u>Innovation and Technology Committee.</u> **G.1**. To create and composition advisory committee to the Board of Directors, responsible for innovation and technology matters, establish the rules for its composition, and define its competencies (item "f" of Article 45 and inclusion of Article 53).
- (1.h) Approve, by majority by the present shareholders, with 3,597,922,583 in favor 879 votes against; and 64,286,915 abstentions, o **Block H** of bylaws amendments, i.e <u>Statutory Reserve.</u> **H.1.** To provide that the statutory reserve may be used for the payment of dividends, interest in equity, and acquisition operations by the Company of its own shares (§1 of Article 57).
- (1.i) Approve, by majority by the present shareholders, with 3,597,919,982 in favor 342 votes against; and 64,290,053 abstentions, the **Block I** of bylaws amendments, i.e <u>Indemnification</u>. **I.1**. To clarify that, regarding to the associations, the Company's indemnity commitment is applicable only to those in which the Company participates as a sustaining, honorary, or founding member ("caput" of Article 77). **I.2**. To reflect the change in the governance structure of the Market Arbitration Chamber (§1 of Article 77).
- (1.j) Approve, by majority by the present shareholders, with 3,597,912,499 in favor 524 votes against; and 64,297,354 abstentions, the **Block J** of bylaws amendments, i.e – Other changes J.1. Substitution/Vacancy in the Board of Officers. To adjust Articles 41 and 42 to clarify that in case of absence, the Vice-Presidents and Officers who compose the Board of Officers will be replaced in all their functions. J.2. Audit Committee. To adjust §2 of Article 46 to include the requirement that external members must not hold a position in the Company's Board of Officers and adjust §2 of Articles 46 and 47 to encompass other regulations applicable to the Company, in addition to the CVM. J.3. Governance and Nomination Committee. To adjust the "caput" of Article 49 to include the mention of §5 of Article 22 regarding the requirements to compose the referred committee and adjust item "g" of the sole paragraph of Article 49 to expressly include that the preparation and updating of the Company's regulations are part of the Committee's responsibilities. J.4. People and Compensation Committee. To adjust the "caput" of Article 51 to include the mention of §5 of Article 22 regarding the requirements to compose the Committee and adjust §1 of Article 51 to include that the Committee has the responsibilities established in the regulation applicable to the Company. J.5. Risk and Financial Committee. To adjust the "caput" of Article 52 to include the mention of §5 of Article 22 regarding the requirements to compose the Committee. **J.6**. Self-Regulation. To adjust Article 74 to reflect the wording used by CVM Resolution No. 135/22. J.7. Arbitration. To adjust Article 75 to formalize the submission of external members of advisory committees of the Board of Directors constituted by force of the Bylaws to the arbitration clause. J.8. Formal adjustments. To adjust other formal wordings (including for better understanding of provisions), spelling adjustments, cross references, renumbering, and gender adjustments, as detailed in Exhibit V of the Management Proposal.
- (2) Approve, by majority by the present shareholders, with 3,597,918,109 in favor 445 votes against; and 64,291,823 abstentions, the restatement of the Company's Bylaws, to reflect the amendments indicated above, as per Exhibit I to these minutes ("Exhibit I").

(3) Approve, by majority by the present shareholders, with 1,814,104,998 in favor 1,783,814,219 votes against; and 64,291,160 abstentions, the proposals to amend the Company's Stock Granting Plan, being them: (i) Inclusion of the possibility of linking the receipt of shares under the plan to compliance with any confidentiality, non-disparagement, and non-solicitation agreement, in addition to the non-compete agreement already currently provided for in the plan; and (ii) Amendment, in case of termination of the beneficiary's relationship with the Company due to removal from the position of administrator for a reason that would not constitute just cause under applicable legislation, dismissal without just cause or mutual agreement, of the period for receiving the pro-rata amount of shares granted under the Plan and not yet transferred, related to the period worked in the year of termination, of the vesting tranches. Due the approved amendments, the Company's Stock Granting comes into effect as per the Exhibit II to these minutes ("Exhibit II").

**CLOSING**: There being no further business to discuss, these minutes were drawn up, and, after being read and approved, were considered signed by the shareholders whose remote voting form was considered valid by the Company, for the Central Depository, by the bookkeeping agent and the custodian and by the shareholders who registered their presence through the electronic platform provided by the Company, in accordance with RCVM 81.
