**CONVOCAÇÃO:** Edital de convocação publicado nos dias 13, 14 e 15 de fevereiro de 2025 no jornal Valor Econômico (fls. E2, E2 e E2, respectivamente), com divulgação simultânea na página do mesmo jornal na internet, em conformidade com a Lei nº 6.404/76 (“Lei das S.A.”).

**PRESENÇA:** Presentes acionistas representando 67,24% (sessenta e sete vírgula vinte e quatro por cento) do capital social votante da Companhia, conforme se verifica (i) pelas presenças registradas por meio da plataforma eletrônica disponibilizada pela Companhia, nos termos da RCVM 81, e (ii) pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia, do custodiante do acionista e diretamente pela Companhia, nos termos da regulamentação da CVM.

Em razão do quórum verificado, o Presidente deu por instalada a Assembleia. Presentes, ainda, integrantes da Administração da Companhia, o Coordenador do Conselho Fiscal, Sr. André Coji, e o representante da Deloitte Touche Tohmatsu Auditores Independentes, empresa especializada responsável pela elaboração dos Laudos de Avaliação, conforme termo definido adiante, Sr. Rafael Scatena.

**ORDEM DO DIA:** (a) Ratificar a nomeação da empresa especializada Deloitte Touche Tohmatsu Auditores Independentes Ltda. inscrita no CNPJ sob o nº 49.928.567/0001-11, como responsável pela elaboração dos laudos de avaliação a valor contábil do patrimônio líquido da Neoway Tecnologia Integrada, Assessoria e Negócios S.A. (“Neoway”) e da Neurotech Tecnologia da Informação S.A. (“Neurotech” e, em conjunto com a Neoway, “Incorporadas”) necessários para a incorporação pela B3 (“Laudos de Avaliação”); (b) Aprovar os Laudos de Avaliação; (c) Examinar, discutir e aprovar os termos e condições do protocolo e justificação de incorporação das Incorporadas pela B3, celebrado em 12 de fevereiro de 2025, entre as administrações da B3 e das Incorporadas (“Incorporação” e “Protocolo e Justificação”, respectivamente), conforme Proposta da Administração divulgada pela Companhia; (d) Aprovar a Incorporação proposta, com a consequente extinção das Incorporadas, nos termos do Protocolo e Justificação; e (e) Autorizar a administração da B3 a

praticar e assinar todos os atos necessários para formalizar a Incorporação e a implementação das deliberações tomadas.

**DELIBERAÇÕES:** Dispensada a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, conforme o disposto na RCV 81, foram tomadas as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta a Lei das S.A.:

(a) Ratificar, por maioria dos acionistas presentes, tendo sido computados 3.493.662.052 votos a favor; 3.169.609 votos contrários; e 11.582.467 abstenções, sem reservas, a nomeação da empresa especializada Deloitte Touche Tohmatsu Auditores Independentes Ltda. inscrita no CNPJ sob o nº 49.928.567/0001-11, como responsável pela elaboração dos Laudos de Avaliação;

(b) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.493.021.955 votos a favor; 3.168.825 votos contrários; e 12.223.348 abstenções, sem reservas, os Laudos de Avaliação;

(c) Examinar, discutir e aprovar, por maioria dos acionistas presentes, tendo sido computados 3.493.978.891 votos a favor; 2.783.817 votos contrários; e 11.651.420 abstenções, sem reservas, os termos e condições do Protocolo e Justificação, conforme Proposta da Administração divulgada pela Companhia, o qual passa a fazer parte integrante desta ata como Anexo (i).

(d) Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.493.983.311 votos a favor; 2.794.456 votos contrários; e 11.636.361 abstenções, sem reservas, a Incorporação proposta, com a consequente extinção das Incorporadas, nos termos do Protocolo e Justificação; e

(e) Autorizar, por maioria dos acionistas presentes, tendo sido computados 3.496.791.157 votos a favor; 47.238 votos contrários; e 11.575.733 abstenções, sem reservas, a administração da B3 a praticar e assinar todos os atos necessários para formalizar a Incorporação e a implementação das deliberações tomadas.

Fica registrado que, conforme consta do Protocolo e Justificação aprovado nesta Assembleia, a efetivação da Incorporação somente produzirá efeitos a partir de 1º de abril de 2025.
