INTERNAL ADVISORY COMMITTEES TO THE CHIEF EXECUTIVE OFFICER AND THE JOINT BOARD

Operational Qualification Program (PQO) Certification Committee – Evaluates requests for authorization, including revocation, to use qualification seals, and proposes changes to the usage rules and other procedures of the PQO.

Internal Conduct and Ethics Committee – Responsible for ensuring compliance with and promoting the broad dissemination of the provisions of the Code of Conduct and Ethics and other company policies; proposing improvements to the Board of Directors regarding the Code; approving rules related to whistleblowing and personal investments; and evaluating and deliberating on violations of the Code, including the application of penalties.

Internal Committee for Monitoring Transactions and Preventing Money Laundering, Concealment of Assets, Rights and Values, Terrorism Financing, and Financing of the Proliferation of Weapons of Mass Destruction – Approves rules, procedures, and measures related to B3's Program for the Prevention of Money Laundering and Concealment of Assets, Rights and Values, Terrorism Financing, and the Financing of the Proliferation of Weapons of Mass Destruction, ensuring compliance with current regulations. It also assigns responsibilities to company areas affected by the implementation of the Program. The Committee evaluates the effectiveness of the company's processes and controls for preventing and combating terrorism financing, money laundering, and concealment of assets. It is responsible for approving models, criteria, and parameters used to monitor and detect transactions, whether executed or proposed, that are considered suspicious and/or atypical and may indicate ML/TF. It also evaluates the performance of such models, criteria, and parameters in accordance with applicable laws and regulations. Additionally, it reviews transactions considered suspicious and/or atypical detected by the company's monitoring processes and decides on reporting to the competent authorities.

Corporate Risk Committee – Responsible for deliberating on matters related to business continuity, corporate risks, and information security of B3.

Sustainability Committee – Responsible for the strategic guidance of B3's sustainability themes and for the approval of planning and macro initiatives related to sustainability.

Internal Pricing Committee – Aims to discuss and analyze matters related to possible changes to fee schedules for products and services and to B3's commercial discount policies.

Central Counterparty (CCP) Risk Technical Committee – Evaluates the macroeconomic scenario and its risk-related effects on the markets in which the Company operates; defines the criteria and parameters used to calculate margin values and to value the assets accepted as collateral; establishes the modes and/or values of collateral for trades executed during trading sessions and/or registered in any of the trading, registration, clearing, and settlement systems operated by the Company and its subsidiaries or affiliates, which modes and/or values also affect open interest; proposes the collateral management policy; analyzes the level of leverage in the system; suggests criteria, limits, and parameters for controlling participants' credit risk; monitors and periodically evaluates the counterparty risk represented by access permit holders and other participants; and analyzes and proposes improvements to risk systems, including the criteria and parameters for monitoring and controlling the credit risks to which B3 is exposed in its role as central counterparty. Intraday risk limits, open interest limits, and limits on the use of collateral with private issuer risk are particularly important in this regard.

Internal Information and Cybersecurity Committee – Responsible for analyzing the strategic security plan; recommending the strategic direction related to information security and cybersecurity management; supporting critical analyses of relevant security risks in operations, technology, processes, access and identity control, vulnerabilities, and awareness and commitment of personnel; evaluating policies and standards related to the topic and submitting them for assessment by the Executive Board; ensuring the execution of the budget allocated for information security in line with the strategic plan; guiding the adoption of measures to mitigate risks related to information security and cybersecurity, ensuring compliance with policies and standards; monitoring the

Company's adherence to the Information Security Policy and related standards; monitoring high and critical incidents, directing structural actions to improve the resilience of the environment; defining criteria for activating the Company's crisis plan in the event of cybersecurity incidents and contributing scenarios for crisis management planning; and monitoring the cybersecurity risks of controlled companies.
