CONVOCAÇÃO: Edital de convocação publicado nos dias 9, 10 e 11 de novembro de 2021 no Diário Oficial do Estado de São Paulo (fls. 19, 7 e 12, respectivamente) e no jornal Valor Econômico (fls. C5, A14 e A6, respectivamente).

PRESENÇA: Presentes acionistas representando mais de 58,25% (cinquenta e oito vírgula vinte e cinco por cento) do capital social votante e total da Companhia, conforme se verifica (i) pelas presenças registradas por meio da plataforma eletrônica disponibilizada pela Companhia, nos termos da ICVM 481, e (ii) pelos boletins de voto à distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia ou diretamente pela Companhia, nos termos da regulamentação da CVM. Presentes, ainda, integrantes da Administração da Companhia, como convidado, o Sr. Maurício Ferreira de Souza, Coordenador do Conselho Fiscal da Companhia, o Sr. Daniel Cifu, representante da KPMG Corporate Finance Ltda., responsável pela elaboração do laudo de avaliação para fins do inciso II do caput e do §1º do art. 256 da Lei 6.404/76, que constou da proposta da administração para a Assembleia (“Laudo de Avaliação”), bem como o Sr. João Marcelo Pacheco, sócio de Pinheiro Neto Advogados, assessor legal da Companhia na Operação (conforme definida abaixo).

ORDEM DO DIA: Deliberar sobre a aquisição pela Companhia, de forma direta ou por meio de qualquer de suas controladas, nos termos do §1º do artigo 256 da Lei 6.404/76 (“Lei das S.A.”), da totalidade do capital social da Neoway Tecnologia Integrada Assessoria e Negócios S.A., sociedade por ações, com sede na cidade de Florianópolis, Estado de Santa Catarina, na Rua Patrício Freitas, nº 131, Sala 201, Bairro Itacorubi, CEP 88034-132, inscrita no CNPJ/ME sob o nº 05.337.875/0001-05 (“Neoway”), conforme a documentação definitiva assinada e demais materiais submetidos à Assembleia (“Operação”), bem como a ratificação dos atos correspondentes praticados pela

Administração até a data da Assembleia.

DELIBERAÇÕES: Feita a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, consoante o parágrafo 4º do art. 21-W da Instrução CVM nº 481/2009, foram tomadas, com a abstenção dos legalmente impedidos, as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei nº 6.404/76:

Aprovar, por maioria dos acionistas presentes, tendo sido computados 3.488.673.237 de votos a favor, 43.600 de votos contrários; e 48.948.014 abstenções, a aquisição pela Companhia, de forma direta ou por meio de qualquer de suas controladas, nos termos do §1º do artigo 256 da Lei das S.A., da totalidade do capital social da Neoway, conforme a documentação definitiva assinada e demais materiais submetidos à Assembleia, bem como a ratificação dos atos correspondentes praticados pela Administração até a data da Assembleia. Apesar de o preço de aquisição por ação da Neoway atingir os critérios previstos no inciso II, alínea (b), do art. 256 da Lei das S.A., conforme verifica-se no Laudo de Avaliação, não haverá direito de retirada para os acionistas dissidentes da deliberação desta Assembleia, tendo em vista a liquidez e a dispersão das ações de emissão da Companhia, nos termos do art. 137, II, alíneas (a) e (b), combinado com o §2º do art. 256, da Lei das S.A.

ENCERRAMENTO: Nada mais havendo a tratar, a presente ata foi lavrada, e, depois de lida e aprovada, foi considerada assinada pelos acionistas cujo boletim de voto à distância foi considerado válido pela Companhia e pelos acionistas que registraram a sua presença por meio da plataforma eletrônica disponibilizada pela Companhia, nos termos a ICVM 481.
