COMPANY NOTICE

Pursuant to article 157 (4) of Law 6.404 of December 15, 1976, as amended ("<u>Brazilian Corporation Law</u>"), and Brazilian Securities Commission ("CVM") regulations and further to the Company Announcements issued November 13, 2020, January 15, 2021, January 20, 2021, March 02, 2021, March 08, 2021, April 08, 2021 and April 13, 2021 addressing the public acquisition offering via an equity interest increase to be made by the Company for the free float shares of Rede Energia Participações S.A. ("<u>Rede Energia</u>") ("<u>Offering</u>" or "<u>OPA</u>") ENERGISA S.A., a publicly held company, having its registered office at the address Praça Rui Barbosa, n.º 80 (parte), Centro, CEP 36770-901, Cataguases, Minas Gerais state, whose articles of organization are registered at the Minas Gerais Board of Trade under NIRE no. 31.3.000.2503-9, Corporate taxpayer number (CNPJ) 00.864.214/0001-06 ("<u>Company</u>"), hereby announces that:

At the auction held today at B3 S.A. - Brasil, Bolsa, Balcão and pursuant to the Offering Notice ("<u>Notice</u>"), the Company acquired 3,789,343 (three million seven hundred and eighty-nine thousand three hundred and forty-three) common shares of Rede Energia, accounting for approximately 0.18% (zero point one eight percent) of its share capital. Based on the price per share stipulated in the Notice, the Company acquired the shares at the Auction for the total amount of R\$ 30,731,571.73 (thirty million seven hundred thirty-one thousand five hundred seventy-one Reais and seventy-three cents).

After settling these acquisitions, the Company will directly and indirectly (including the interest held by its subsidiaries Denerge Desenvolvimento Energético S.A. and Energisa Participações Minoritárias S.A.) hold 2,105,136,870 (two billion one hundred five million one hundred thirty-six thousand eight hundred seventy) common shares issued by Rede Energia, accounting for approximately 99.75% (ninety-nine point seven five percent) of its capital.
