## NOTICE TO THE MARKET

**ENERGISA S.A.** hereby announces it has completed the public distribution offering of 1,244,154 simple, ordinary nonconvertible debentures by the Company and its aforesaid subsidiaries, with additional real guarantee in a single series with placement restrictions for public distribution, all registered and book-entered, with a unit par value of R\$ 1,000.00 (one thousand reais) at the issuance date, i.e. August 25, 2020, pursuant to CVM Directive 476/2009, amounting to R\$ 1,244,154,000.00 (one billion two hundred forty-four million one hundred fifty-four thousand reais).

The issued debentures yield semiannual interest, on the following terms: The debentures issued by the subsidiaries are secured by Energisa S.A.

The debentures have been structured to cover the optional acquisition offerings made to the debenture holders for the issuances of Energisa Mato Grosso, Energisa Mato Grosso do Sul and Energisa Paraíba with maturity scheduled for February 2021, and of Energisa maturing in June 2021.
