MATERIAL FACT

Restatement of Quarterly Information for the First Quarter of 2021

Oi S.A. – **In Judicial Reorganization** ("Oi" or "the Company"), in compliance with Article 157, Paragraph 4, of Law No. 6,404/76 and the provisions of CVM Instruction No. 358/02, hereby informs its shareholders and the market in general that, the Company is voluntarily restating its quarterly information for the first quarter of 2021.

The restatement of the individual and consolidated Quarterly Information for the three-month period ended on March 31, 2021 was due to the need to correct the depreciation expenses/costs of non-current assets that belong to the group of assets classified as assets held for sale that were not ceased during this period, and should remain so until the completion of operations, to meet the accounting standard, as shown below:
