MINUTES OF THE EXTRAORDINARY GENERAL MEETING HELD ON OCTOBER 6TH, 2025

- 1. <u>DATE, TIME AND PLACE</u>: On the 6th (sixth) day of October, 2025, at 10 a.m. held exclusively digitally, through the digital platform "Ten Meetings" ("<u>Digital Platform</u>"), thus being considered as held at the headquarters of Companhia Brasileira de Distribuição ("<u>Company</u>"), pursuant to the Resolution of the Brazilian Securities and Exchange Commission ("<u>CVM</u>") No. 81, dated March 29, 2022, as amended ("<u>CVM Resolution 81</u>").
- **CALL NOTICE AND PUBLICATIONS:** Call Notice published in the newspaper "Folha de S. Paulo", in the editions of (i) September 5th, 2025, page A25; (ii) September 6th, 2025, page A25; and (iii) September 7th, 2025, page A27, in accordance with Articles 124, §1°, item II and 289, item I, of Law No. 6,404, dated December 15, 1976, as amended ("Brazilian Corporations Law"). Additionally, the documents required by CVM Resolution 81 and CVM Resolution No. 80, dated March 29, 2022, as amended ("CVM Resolution 80"), were also disclosed to the market through the CVM system and the Company's investor relations page.
- 3. <u>MEETING BOARD</u>: Chairman: Marcelo Ribeiro Pimentel; and Secretary: Luiz Antonio de Sampaio Campos.
- 4. <u>AGENDA</u>: To resolve on: (i) full dismissal of the Company's Board of Directors; (ii) setting the number of members of the Company's Board of Directors at nine (9), for a new unified term of office, ending at the Annual General Meeting that will resolve on the financial statements for the fiscal year ending on December 31, 2026; (iii) election of the members of the Company's Board of Directors and approval of the qualification of its independent members; and (iv) election of one (1) sitting member and its respective alternate member for the Company's Fiscal Council.
- **ATTENDANCE:** Shareholders representing 79,02% of the Company's voting capital, according to the attendance recorded by means of the remote voting ballots validated by the Company, and the attendance recorded by the Digital Platform, pursuant to Article 47 of CVM Resolution 81, thus confirming that the legal quorum for installing this Extraordinary General Meeting ("Meeting") on first call has been met, pursuant to the Article 125 of the Brazilian Corporations Law.

- **RESOLUTIONS:** Initially, the shareholders approved the drafting of these minutes in summary form and their publication with the omission of the shareholders' signatures, under Article 130, paragraphs 1 and 2, of the Brazilian Corporations Law. Subsequently, the reading of the consolidated summary map of the votes cast remotely, disclosed to the market on October 04, 2025, was waived, pursuant to CVM Resolution 81. Once the minimum legal quorum had been verified, the Meeting was declared installed, and the shareholders resolved, as set forth on the voting map attached as Single **Annex** to these minutes:
 - (i) Approve, by majority of votes, the full dismissal of the Company's Board of Directors;
 - (ii) Approve, by majority of votes, setting the number of members of the Company's Board of Directors at nine (9), for a new unified term of office, ending at the Annual General Meeting that will resolve on the financial statements for the fiscal year ending on December 31, 2026;
 - (iii) Initially, the Meeting Board recorded the receipt of: (i) the request for the adoption of the cumulative voting system submitted by shareholders representing, collectively, more than 5% (five percent) of the Company's corporate capital, as per the Notice to Shareholders disclosed on October 2, 2025; and (ii) the following nominations: (a) by shareholders José Carlos Gonçalves Francisco and Rodolfo Costa Neves Francisco, the nomination of Mr. Rodolfo Costa Neves Francisco himself as a candidate for the election of members of the Board of Directors in the event of adoption of the aforementioned system, pursuant to the Notice to Shareholders disclosed on September 22, 2025; and (b) by shareholder Mr. Ricardo Maciel de Gouveia Roldão, his own nomination as a candidate for election to the Board of Directors in the event of adoption of the aforementioned system, pursuant to the Notice to Shareholders disclosed on October 05, 2025.

After this, the Meeting Board submitted the election of the members of the Company's Board of Directors to the shareholders for voting, being elected, by the cumulative voting process, the following nine (9) members:

It was stated that, pursuant to the statements provided, the independent directors hereby elected declared that they meet the independence criteria set forth in Article 6 of Annex K of CVM Resolution 80 and Article 16 of the Novo Mercado Regulation, listing segment in which the shares issued by the Company are traded, having the qualification of such directors as independent members been approved by the attending shareholders, as per the resolution above.

It was also noted that the members now elected have stated that they meet the eligibility requirements set forth in Article 147 of the Brazilian Corporations Law and Article 2 of Annex K of CVM Resolution 80.

The members of the Board of Directors hereby elected shall be invested in their positions for a unified term of office ending at the Annual General Meeting that will resolve on the financial statements for the fiscal year ending on December 31, 2026, upon the signing of

the respective terms of investiture and declarations of no-impediment, drafted on the appropriate book, pursuant to the Brazilian Corporations Law and Annex K of CVM Resolution 80, including their submission to the arbitration clause set forth in Article 38 of the Company's Bylaws, which shall be filed at the Company's headquarters.

- (iv) The Metting Board registered that the following shareholders nominated sitting members and alternate members for the election one (1) sitting member and the respective alternate member of the Company's Fiscal Council:
 - (a) The shareholder **Mr. Jarib Brisola Duarte Fogaca**, nominated himself as sitting member, and **Mr. Ailton Antônio Corrêa Leite**, as his respective alternate member, in accordance with Notice to Shareholders disclosed in October 02, 2025; and
 - (b) The shareholder(s) André Luiz Coelho Diniz nominated the following candidates: Mr. Rômulo Santos Siqueira, as sitting member, and Mr. Décio Chaves Rodrigues, as his respective alternate member, in accordance with Notice to Shareholders disclosed in October 05, 2025.

Considering that the election will be for one (1) sitting member and one (1) alternate member, and that the Metting Board recorded a greater number of nominated candidates than that are seats on the Fiscal Council, the Metting Board submitted to vote the election of the Fiscal Council, through the individual voting system.

Were elected, by majority, the following sitting member to the Fiscal Council and his respective alternate member, with unified term of office with the other members of the Company's Fiscal Council until the Annual General Meeting that will resolve on the financial statements for the fiscal year ending on December 31, 2025: Mr. Rômulo Santos Siqueira, Brazilian, married, accountant, bearer of identity card RG No. M 5.802.693, issued by SSP/MG, enrolled with the Individual Taxpayer's Registry (CPF/MF) under No. 991.647.446-04, resident and domiciled in the City of Governador Valadares, State of Minas Gerais, with professional address at Avenida Brigadeiro Luís Antônio, No. 3.142, Jardim Paulista, ZIP Code 01402-000, as sitting member, and Mr. Décio Chaves Rodrigues, Brazilian, married, accountant, bearer of identity card RG No. M 2.716.977, issued by SSP/MG, enrolled with the Individual Taxpayer's Registry (CPF/MF) under No. 489.847.286-91, as his respective alternate member.

The members of the Fiscal Council hereby elected shall be invested in their positions upon the signing of the respective terms of investiture, draft on the appropriate book, including the statement of non-impediment provided for in Articles 147, paragraph 4, and 162 of the Brazilian Corporations Law, and their submission to the arbitration clause set forth in Article 38 of the Company's Bylaws.

7. <u>CLOUSURE</u>: There being no further business to address, the proceedings were adjourned and these minutes drawn up in summary form, read, and found in conformity by the attending shareholders, who are considered signatories hereof, pursuant to CVM Resolution 81. The minutes will be electronically signed by the Chairman and the Secretary of the Meeting Board, who certify the presence of the shareholders listed in the Attendance List and that the Meeting met the legal and regulatory requirements for its digital holding, especially those provided in DREI Normative Instruction No. 81, dated June 10, 2020.
