**MATERIAL FACT**

**AMBIPAR PARTICIPAÇÕES E EMPREENDIMENTOS S.A. (B3: AMBP3)** ("Ambipar") and **ENVIRONMENTAL ESG PARTICIPAÇÕES S.A. ("ESG"** and, together with Ambipar, "Companies"), in compliance with the provisions of Resolution No. 44, dated August 23, 2021, of the Brazilian Securities and Exchange Commission (Comissão de Valores Mobiliários – "CVM") and Article 157, paragraph 4, of Law No. 6,404/76 (the "Brazilian Corporations Law"), hereby inform their shareholders and the market in general that, on September 24, 2025, the Companies, together with their affiliates ("Ambipar Group"), filed a petition for a preliminary injunction prior to the main action (*Tutela Cautelar Em Caráter Antecedente*, the "Preliminary Injunction"), and that the requests for interim relief were granted in full on the date hereof.

The Preliminary Injunction was filed as a result of a recent derivatives transaction involving Green Bonds issued by the Ambipar Group, which led to negative financial consequences due to impacts and fluctuations in the market price and trading of its securities.

The purpose of the Preliminary Injunction is to ensure the continuity of Ambipar Group's business activities and to afford protection to its assets, while Ambipar Group, together with its creditors, seeks a viable alternative for the appropriate resolution of its financial obligations.

The relief granted, on a preliminary basis, among other measures, the suspension of (i) the effects of any and all contractual provisions that would trigger acceleration of Ambipar Group and its related parties' debts and (ii) the enforceability of all obligations under the relevant contractual instruments.

Ambipar Group remains committed to maintaining constructive discussions with its creditors with a view to reaching an agreement that benefits all of its investors.

Ambipar Group continues to operate in the ordinary course and to deliver high-quality services, on safe, efficient and reliable matter, across all of its

segments. Its workforce remains fully mobilized, supporting thousands of direct and indirect jobs, generating social impact and fostering economic activity.

The Companies will keep their shareholders and the market informed of any developments regarding the matters addressed in this Material Fact.
