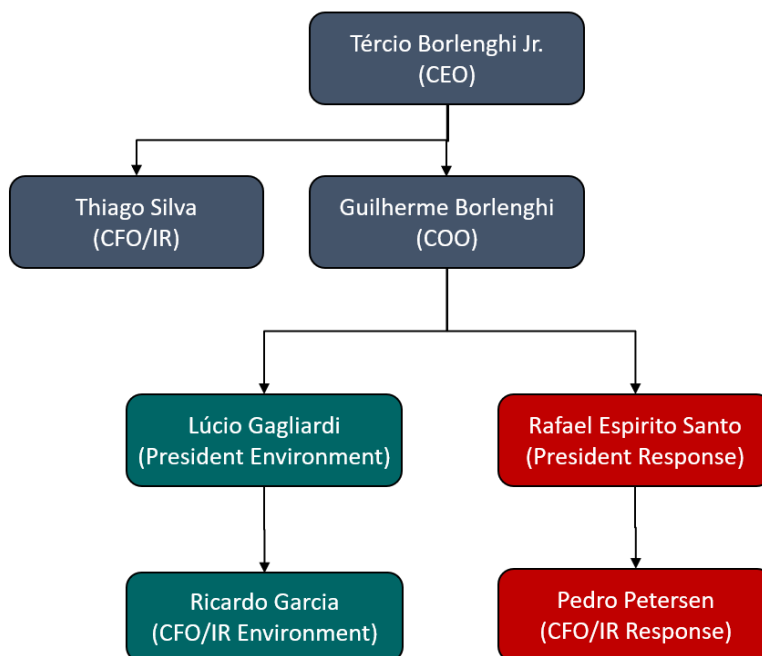
- Mr. Tércio Borlenghi Jr. is now the CEO of Ambipar;

- Mr. Pedro Petersen is now the CFO and IR of Ambipar Response;
- Mr. Lucio Gagliardi is now the President of Ambipar Environment; and
- Mr. Ricardo Garcia is now the CFO and IR of Ambipar Environment.

Mr. Guilherme Patini Borlenghi has vast experience working at Ambipar, having spent the last 13 (thirteen) years in various positions within the organization. Guilherme led strategic decisions relative to capital allocation and M&A, expanding and consolidating the position of Ambipar Response in the Brazilian market, and the entry and growth in global markets.

Mr. Rafael Espírito Santo previously worked at HPX, having participated at the listing of Response in the NYSE. Previously, he was the COO of Burger King Brazil, CFO in the real estate sectors, and worked at Vinci Partners and Banco Pactual.

Mr. Lucio Gagliardi has served as an executive at Ambipar for 6 years, having actively worked on the brand Building and positioning of Ambipar Environment in the waste management and valorization segment, with a focus on sustainable solutions and circular economy. Lucio has a chemical engineer and business administration degree from Mackenzie University, a specialization in Public Health and Environment, and a Master's degree in Environmental Health at Universidade de São Paulo (USP).

The summarized management structure is now as follows:



Along with the management reorganization, Ambipar will also implement two advisory committees for the board:

- an executive committee, focusing on integration, management, and synergies capture between companies in Ambipar Environment, along the same lines as the executive committee in Ambipar Response;
- a financial committee, which will oversee and advise the Board on capital allocation and financial matters.

Along with this reorganization, the executive Leon Tondowski is retiring. Izabel Cristina Andriotti and Yuri Keiserman are also departing from the executive management of Ambipar Environment and Ambipar Response.

Ambipar wishes the best for each of them on the next steps and is immensely grateful for their contribution, hard work, and dedication throughout the past years.
